Subject: Temporary Position Overlap for Senior Real Property Agent for the Facility Management Division in the Public Works Department (4/5 vote required)

## **RECOMMENDATION(S):**

That the Board of Supervisors: Approve the temporary overlap for the position of Senior Real Property Agent (Class 0629, Salary Range 420, Position Number 01) with the incumbent employee for a period of two (2) pay periods, pursuant to Section 7 of the Humboldt County Salary Resolution (4/5 note required).

SOURCE OF FUNDING: General Fund (1100-162)

#### DISCUSSION:

Erin Damm, Senior Real Property Agent, for the Facility Management Division of the Public Works Department has announced her intention to leave her position. This position is critical not only to the functionality of the Public Works Department, but also to the majority of other departments within the county and to owners of properties leased by the county. The Senior Real Property Agent is vital to the timely and complex negotiations for the purchase, sale, lease, improvements and maintenance, both longterm and emergency, of the facilities used by county employees.
