RESOLUTION RESCINDING RESOLUTION No. 16-28 AND ADOPTING REGULATIONS OF THE PUBLIC WORKS DEPARTMENT SPECIFYING THE HOURS THAT VEHICLES ARE ALLOWED IN MAD RIVER COUNTY PARK

WHEREAS, on March 5, 2002, the Humboldt County Board of Supervisors adopted Title 2, Division 7, Chapter 1 of the Humboldt County Code governing activities in County Parks; and

WHEREAS, Section 271-9(a) provides that the hours that various County Parks are open to the public are set by resolution adopted by the Board of Supervisors; and

WHEREAS, Section 271-22 authorizes the Director to issue such rules and regulations as he deems necessary and appropriate, subject to adoption by Resolution of the Board of Supervisors; and

WHEREAS, on March 1, 2016, the Board of Supervisors adopted Resolution No. 16-28 specifying that Mad River County Park shall be open to the public for day-use only (from sunrise to sunset), in order to improve public safety and curtail inappropriate conduct; and

WHEREAS, changes in the intensity of land use are defined by the Coastal Act as forms of development which necessitate a coastal development permit from the California Coastal Commission; and

WHEREAS, Coastal Commission staff indicated that the changes described in Resolution No. 16-28 are inconsistent with the Coastal Act's mandate to maximize public access and would be recommended for denial of a coastal development permit; and

WHEREAS, Public Works developed a modified proposal to create a gated entrance at Mad River County Park and to restrict vehicle use within the park to the hours from sunrise to one hour after sunset; and

WHEREAS, on June 8, 2017, the Coastal Commission approved a coastal development permit for the aforementioned action; and

WHEREAS, Section 917 of the County Code governs motor vehicle use on designated beach and dune areas; and

WHEREAS, the Board of Supervisors has reviewed the proposed regulations and finds that they are consistent with the intent and purpose of Chapter 1, of Division 7, of Title II of the Humboldt County Code.

NOW, THEREFORE, BE IT RESOLVED, BY THE HUMBOLDT COUNTY BOARD OF SUPERVISORS THAT:

1. Resolution No. 16-28 is hereby rescinded.



2. Mad River County Park shall be closed to vehicles from one hour after sunset until sunrise.
3. Public Works shall be responsible for authorizing and administering motor vehicle use at Mad River County Park, and shall provide special accommodations to allow commercial fishermen, persons with disabilities, and senior citizens to retain vehicular access during the nighttime gate closure periods.


