





# DHHS Budgets Fiscal Year 2018-19



#### DHHS Revenue Sources Fiscal Year 2018-19







# Legislative Actions

- AB 1971 Mental Health: Involuntary Detention: Gravely Disabled
- SB 1045 Conservatorship: Chronic Homelessness: Mental Illness
- Recruitment and Retention
  - Effect on regional stability
- Blue Ribbon Task Force
- Strategic plan

#### Helping Humboldt: an occupational empowerment program

- Work Center on Koster campus
- Will serve General Relief/MIST/SOS and local homeless populations
- County beautification, moving company functions for DHHS clients
- Drop in opportunities AND true skill building
- Following AB3085 as funding source



# Helping Humboldt

- Create a Social Enterprise
  - Building on staffing and new ROXCO Work Center
  - Social Services/Probation clients will initially make wood products for the local tourism trade and totes for the CalFresh program.
- Work Training
  - Provides training for CalWORKs, General Relief, CalFresh and Probation clients to gain work readiness and vocational skills
  - Provides strong soft skill development while working
  - Provides skills training from product experts



# Mobile Outreach and Housing

- MIST expansion
  - Arcata, Fortuna and McKinleyville
- Mobile Outreach
  - DHHS services with partners such as Food For People,
    Veterans' programs, Child Support, and Tribal entities
- Housing Placement & Retention
  - provides rental assistance for suitable housing from multiple funding sources
  - provides supportive services to enable clients to retain housing
- Housing Development
  - works with community partners, local governments,
    - developers and funders to increase supply of affordable housing and Permanent Supportive Housing

Mental Health Triage Funding

- \$978,964 over three years
- Increased Mobile Response for Adults
- Building on current successful efforts
- Expanded hours, expanded area of service
- Two more grants pending:

 increase mobile response for children/youth

-bring crisis services into the schools

## **CWS: AG Settlement and More**

- Attorney General
  - Investigation began 2015
  - Complaint filed 2017
  - Settlement February 2018
- Settlement Completed tasks include
  - Complaint procedure publicized
  - tribal consultant engaged
  - 24 hour hotline answering
  - Monitor identified
  - Automated call tree implemented
  - Electronic tracking of cross-reports and reports outside Humboldt County jurisdiction

#### CWS: AG Settlement and More

- Upcoming tasks include
  - Formation of Community Task Force
  - Complete triage plan for backlog and a time management plan for future investigations
  - Revise P&Ps
  - Mandatory trainings for all staff
  - Protocols with Tribes
  - Hiring
  - Full compliance within 365 days

## Supplemental Budget Request: ACEs

- \$400,000 from Measure S cannabis tax funds used to support early childhood mental health, parenting, and trauma prevention services
- \$200,00 directly to Humboldt First 5
- \$200,000 awarded in mini-grants to 12 partners
  - Hoopa Tribal Education Association, Eureka City Schools, Discovery Museum, City of Arcata, 0-8 MH Collaborative, Eel River Valley ACEs Action Team, McKinleyville
     Community Services District, McKinleyville FRC, Mattole
     Valley Resource Center, Redwoods Rural Health Center, The Forgotten Initiative, Changing Tides Family Services
