


Public Defender 2018-19 Budget Proposal



An efficient justice system requires that the Courts, Law Enforcement, and Public Defender operate with adequate resources to address the needs of the community.

If one branch of the local public safety unit is weak this impacts the other units immediately.

Public Defender Services



The County of Humboldt Public Defender is a law office Established and funded by the County of Humboldt

The attorneys and other staff employed by the office render legal services to individuals who are accused of a crime, public nuisance, or other potential deprivation of civil rights and who cannot afford the services of a private attorney.

Public Defender Services



There are two Public Defender Offices:

Public Defender Main Office

▶ Provides primary representation in approx. 60% of Superior Court appointments

Conflict Counsel Office

Provides primary representation in approx. 40% of Superior Court appointments

Public Defender Services

In addition to adult criminal cases, the Public Defender is appointed to represent clients for the following matters:

- Conservatorships
- Writ and Riese Hearings
- Juvenile Delinquency Cases
- Homeless Court
- Truancy Court
- Family Law Contempt
- Hoopa Court every other month

Who We Represent



Public Defenders are the primary providers of court-appointed legal services to persons facing criminal charges or other potential deprivation of civil rights who lack the funds to hire counsel.

It is estimated that over 90% of our county population cannot afford legal fees for a serious criminal matter and would qualify for Public Defender to have a public defender represent them.

Who We Represent



The Public Defender Offices represent over 80% of the appointments by the Humboldt County Superior Court for adults charged with crimes.
