**RESOLUTION FROM THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IN  
SUPPORT OF THE 16<sup>th</sup> ANNUAL SALMON RELAY RUN**

**WHEREAS**, the 16<sup>th</sup> Annual Salmon Relay Run is scheduled to begin on Friday, May 25, and end on Sunday, May 27, 2018; and

**WHEREAS**, this year the run will begin at the mouth of the Klamath River at 6:30 a.m. The Relay Run will split at Weitchpec, with one leg of the run going up HWY 96 along the Trinity River and concluding at Trinity Valley Elementary School in Willow Creek at approximately 4:00 p.m.; and

**WHEREAS**, the other leg of the run will go North, up HWY 96, rest overnight at Happy Camp the night of May 26, and then continue the following morning. Runners will resume the run on Saturday at 7:00 a.m., running as far as the Tree of Heaven campground. On Sunday, May 27 the run will begin at 8:00 a.m. continuing up HWY 96. Just prior to the juncture of HWY 96 and I-5 runners will be transported in vehicles across I-5 to Klamathon Rd where they will commence running. From Klamathon Rd they will turn left onto Ager Rd, and take the right onto Copco Rd. The Salmon Relay Run will conclude at Iron Gate Dam at approximately 1:00 p.m.; and

**WHEREAS**, there will be no road closures, as runners will run on the shoulder of the road and be escorted by a pilot car in the front and rear of the runners; and

**WHEREAS**, tribal police will provide an escort on the Yurok and Hoopa reservations and the Safety Officer from Klamath-Trinity School District will escort the runners from Weitchpec to Willow Creek.; and

**WHEREAS**, the Salmon Relay run is dedicated to raising community awareness of the environmental and cultural importance of healthy fisheries, and water issues.





Klamath-Trinity Joint Unified School District respectfully requests a Resolution from the Humboldt County Board of Supervisors in support of the 16<sup>th</sup> Annual Salmon Relay Run.
