WHEREAS, Kenneth Swithenbank grew up in the Garberville area and graduated from South fork High where he was a star athlete in several sports. Kenneth Swithenbank was hired as a Deputy Sheriff by Sheriff Dave Renner on August 28, 1988: and

WHEREAS, after completing a field training program, Kenneth Swithenbank started his law enforcement career working out of the Eureka Office. Shortly thereafter, he returned home by transferring to Southern Humboldt and working as a resident deputy out of the Garberville Station; and

WHEREAS, on May 25, 2003, Kenneth Swithenbank was promoted to the rank of Sergeant and continued his resident deputy assignment at the Garberville Station; and

WHEREAS, while assigned to the Garberville station for 25 of his 27 year career, Kenneth Swithenbank established many long lasting relationships and earned the respect and trust of the citizens he served, often being referred to as the unofficial mayor of Southern Humboldt; and

WHEREAS, On November 6, 2016, Kenneth Swithenbank was promoted to the rank of Lieutenant and assigned the position of Administrative Lieutenant working out of the Eureka Office; and

WHEREAS, throughout his career, Kenneth Swithenbank received several letters of commendation from grateful citizens thanking him for his assistance in various law enforcement matters.
