**RESOLUTION TO ACCEPT THE RIGHTS OF WAY FOR MARY COURT FOR PUBLIC ROAD PURPOSES AND PARCEL H FOR PUBLIC SIDEWALK EASEMENT PURPOSES**

**WHEREAS**, Section 66477.2 of the Government Code authorizes the Board of Supervisors by resolution to rescind its action and accept the offer of dedication on a map and open the streets, paths and alleys, and right-of-way easements to the public; and

**WHEREAS**, an offer of dedication to the County of Humboldt of Mary Court for public road purposes and Parcel H for public sidewalk easement purposes was made on Tract Map No. 0650 by Bongio Construction, Inc.; and

**WHEREAS**, on July 25, 2017, the Humboldt County Board of Supervisors did not accept the offer of dedication of Mary Court and Parcel H; and

**WHEREAS**, on August 9, 2017, Tract Map No. 0650 was filed in Book 25 of Maps, pages 66 through 68 in the office of the Humboldt County Recorder and is incorporated herein by reference; and

**WHEREAS**, County now desires to accept the dedication of Mary Court and to open the roads to the public; and

**WHEREAS**, County now desires to accept the dedication of Parcel H for public sidewalk easement purposes; and

**NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS;**

1. Humboldt County Board of Supervisors rescinds its July 25, 2017 action of not accepting the dedication and hereby accepts the dedication of Mary Court for public road purposes and Parcel H for public sidewalk easement purposes both as made by Alan Bongio Construction, Inc. on Tract Map No. 0650 which was filed on August 9, 2017 in the office of the Humboldt County Recorder.
2. The Clerk of the Board of Supervisors is directed to return a certified copy of the resolution to the Land Use Division of the Public Works Department for recordation in the office of the Humboldt County Recorder. The acceptance of the dedication shall be effective upon the recordation of the resolution in the office of the County Recorder.
