RESOLUTION NO. 18-89

RESOLUTION TO INCREASE REVOLVING FUND FOR USE OF PLANNING AND BUILDING AND RESCINDING RESOLUTION NO. 16-79

WHEREAS, SECTION 29320, ET. SEQ., OF THE Government Code of California authorizes the Board of Supervisors to establish revolving funds for the use of any officer of the County; and

WHEREAS, there has previously been established two revolving funds in the amount of \$100 each for Building Inspection (total of \$200); and

WHEREAS, there has previously been established one revolving fund in the amount of \$100 for Current Planning (total \$100); and

WHEREAS, there is a need for a revolving fund in Code Enforcement; and

WHEREAS, the Planning and Building Department has requested an increase of \$100 in the receiving fund for Building Inspection and a transfer of one Building Inspection receiving fund to Code Enforcement and an increase of \$100 in the receiving fund and an increase in the receiving fund for Current Planning bringing the total amount of the revolving funds to Two Hundred Dollars (\$200) for each of the three receiving funds (total \$600); and

WHEREAS, the increase is necessary because the Planning and Building Department frequently makes change for large bills submitted for payment of fees; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors, of the County of Humboldt hereby increases the existing revolving funds of Building Inspection in the amount of One Hundred Dollars (\$100), bringing the amount of the fund to Two Hundred Dollars (\$200) for the use of Building Inspection subject to the provisions of Section 29320 et seq., of the Government Code.

BE IT FURTHER RESOLVED that the Board of Supervisors, of the County of Humboldt transfer one of the existing revolving fund of Building Inspection (262) to Code Enforcement (269) and increase the existing revolving fund in the amount of One Hundred Dollars (\$100), bringing the amount of the fund to Two Hundred Dollars (\$200) for the use of Code Enforcement subject to the provisions of Section 29320 et seq., of the Government Code.

BE IT FURTHER RESOLVED that the Board of Supervisors, of the County of Humboldt hereby increases the existing revolving fund of Current Planning in the amount of One Hundred Dollars (\$100), bringing the amount of the fund to Two Hundred Dollars (\$200) for the use of the Current Planning Division subject to the provisions of Section 29320 et seq., of the Government Code.

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors shall transmit certified copies of the resolution to the Auditor and the Treasurer for the County of Humboldt pursuant to Government Code 29322.
