RECOMMENDATIONS:

That the Board of Supervisors:

- 1. Introduce the attached ordinance by title and waive the first reading;
- 2. Set the attached ordinance for adoption on September 4, 2018, or at least one (1) week away from the date of the Board of Supervisors meeting at which the attached ordinance was first introduced;
- 3. Direct the Clerk of the Board of Supervisors to publish the pre-adoption summary of the attached ordinance and to post a certified copy of the full text of the ordinance in the office of the Clerk of the Board of Supervisors at least five (5) days prior to the Board of Supervisors meeting at which the ordinance will be adopted [Government Code Section 25124(b)(1)]; and
- 4. Direct the Clerk of the Board of Supervisors to publish, within fifteen (15) days after adoption of the attached ordinance, a post-adoption summary of the ordinance with the names of the Supervisors voting for and against the ordinance and to post in the office of the Clerk of the Board of Supervisors a certified copy of the full text of the adopted ordinance along with the names of those Supervisors voting for and against the Ordinance [Government Code Section 25124(b)(1)].

DISCUSSION:

California Government Code Section 29701 ("Section 29701") provides that a board of supervisors shall not consider any claim for money or damages against the county unless it is presented not less than three (3) days prior to the date of the meeting of the board of supervisors at which it is considered. Similarly, California Government Code Section 29742 ("Section 29742") provides that a county auditor shall not issue a warrant for any claim that has not been on file in the office for at least three (3) days. Pursuant to Sections 29701 and 29742, a board of supervisors, upon recommendation of the county auditor, may waive the above-referenced three (3) day waiting periods by ordinance. In an effort to continue improving efficiency and eliminating unnecessary practices, the Humboldt County Auditor-Controller recommends that your Board adopt the attached ordinance waiving the three (3) day waiting periods required by Sections 29701 and 29742.

FINANCIAL IMPACT:

Adoption of the attached ordinance will have a minimal impact to the Humboldt County General Fund. However, it could cause claims to be processed sooner which may allow the county to receive certain discounts.

The recommended actions support the Board of Supervisors' Strategic Framework by managing resources to ensure sustainability of services.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose not to adopt the attached ordinance regarding waiver of the above-referenced three (3) day waiting periods. However this, alternative is not recommended because it would cause delays in processing claims for payment.

CHAPTER 3 SEPARATION OF THE OFFICES OF AUDITOR AND RECORDER OF HUMBOLDT COUNTY

Sections:

- § 243-1. Separation of Offices.

243-1. Separation of Offices.

The public interest will best be served by separating the duties of the offices of Auditor and Recorder of the County of Humboldt by providing that the duties of each of said offices shall be performed by a separate person. Therefore, at each general election there shall be a separate person elected for the office of Auditor of the County of Humboldt, and at each general election there shall also be a separate person elected for the office of Recorder of the County of Humboldt. (Ord. 94, §§ 2 & 3, 12/15/1904)

243-2. Qualifications for County Auditor.

- (a) No person shall hereafter be elected or appointed to the office of County Auditor of the County of Humboldt unless the person meets at least one of the following criteria: (Ord. 2190, § 1, 02/23/1999)
 - (1) The person possesses a valid certificate issued by the California State Board of Accountancy under Chapter 1 (commencing with Section 5000) of Division 3 of the Business and Professions Code showing the person to be, and a permit authorizing the person to practice as, a certified public accountant or as a public accountant. (Ord. 2190, § 1, 2/23/1999)
 - (2) The person possesses a baccalaureate degree from a accredited university, college, or other four-year institution, with a major in accounting or its equivalent, as described in subdivision (a) of Section 5081.1 of the Business and Professions Code, and has served within the last five years in a senior fiscal management position in a county, city, or other public agency, a private firm, or a nonprofit organization, dealing with similar fiscal responsibilities, for a continuous period of not less than three years. (Ord. 2190, § 1, 2/23/1999)
 - (3) The person possesses a certificate issued by the Institute of Internal Auditors showing the person to be a designated professional internal auditor, with a minimum of 16 college semester units, or their equivalent, in accounting, auditing, or finance. (Ord. 2190, § 1, 2/23/1999)
 - (4) The person has served as county auditor, chief deputy county auditor, or chief assistant county auditor for a continuous period of not less than three years. (Ord. 2190, § 1, 2/23/1999)
- (b) Any person serving in the capacity of County Auditor shall complete at least 40 hours of qualifying continuing education, pursuant to subdivision (c), for each two-year period, and completing at least 10 hours in each of the two-year period. At least 20 of the 40 hours of continuing education shall be obtained in governmental accounting, auditing, or related subjects. (Ord. 2190, § 1, 2/23/1999)
- (c) Qualifying continuing education may be obtained in the areas of accounting, auditing, or related subjects. In addition, qualifying continuing education may be obtained in any other subject, if it can be demonstrated that the specific educational program contributes to professional competence. (Ord. 2190, § 1, 2/23/1999)
- (d) With respect to a county auditor who is a licensee of the California Board of Accountancy, or of the

accountancy licensing authority of any other state, or who possesses a certificate issued by the Institute of Internal Auditors, continuing education obtained for purposes of renewal of the license or certificate may be applied to satisfy the requirements of this section. (Ord. 2190, § 1, 2/23/1999)

243-3. No Waiting Period for Consideration of Claims or Issuance of Warrants.

The three-day waiting periods for consideration of claims and issuance of warrants prescribed by Sections 29701 and 29742 of the California Government Code shall not apply to any claim considered and/or processed by the Humboldt County Board of Supervisors or the Humboldt County Auditor-Controller.
