FIRST AMENDMENT PROFESSIONAL SERVICES AGREEMENT BY AND BETWEEN COUNTY OF HUMBOLDT AND TRUSTAFF TRAVEL NURSES, LLC FOR FISCAL YEARS 2018-2019 THROUGH 2020-2021

This First Amendment to the Professional Services Agreement dated June 29, 2018, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Trustaff Travel Nurses, LLC, an Ohio limited liability company, hereinafter referred to as "CONTRACTOR," is entered into this _____ day of ______, 2018.

WHEREAS, COUNTY, by and through its Department of Health and Human Services – Mental Health ("DHHS – Mental Health"), desired to retain a qualified professional staffing firm to provide supplemental registered nursing personnel at DHHS – Mental Health facilities; and

WHEREAS, on June 29, 2018, COUNTY and CONTRACTOR entered into a Professional Services Agreement regarding the provision of supplemental registered nursing personnel at DHHS – Mental Health facilities; and

WHEREAS, the parties now desire to amend certain provisions of the Professional Services Agreement to modify the types of positions that may be filled thereunder and adjust the rates of compensation set forth therein.

NOW THEREFORE, the parties mutually agree as follows:

- 1. The Professional Services Agreement is hereby amended to include the following provision regarding counterpart execution:
 - 50. COUNTERPART EXECUTION:

This Agreement, and any amendments hereto, may be executed in one (1) or more counterparts, each of which shall be deemed to be an original and all of which, when taken together, shall be deemed to be one (1) and the same agreement. A signed copy of this Agreement, and any amendments hereto, transmitted by email or by other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Agreement, and any amendments hereto.

- 2. The Professional Services Agreement is hereby amended to delete Exhibit B Schedule of Rates ("Exhibit B"), and replace it in its entirety with the modified version of Exhibit B that is attached hereto and incorporated herein by reference. The modified version of Exhibit B attached hereto shall supersede any and all prior versions thereof as of July 1, 2018.
- 3. Except as modified herein, the Professional Services Agreement dated June 29, 2018 shall remain in full force and effect. In the event of a conflict between the provisions of this First Amendment and the original Professional Services Agreement, or any prior amendments thereto, the provisions of this First Amendment shall govern.
