Rabies Titer Acutal Cost Varies

Titers are venous blood draws offered by the Public Health Clinic to determine if an individual has immunity to a specific disease, such as rabies. One would choose to have a titer drawn to determine whether an immunization is needed; i.e. if there is no immunity then an immunization would be recommended. The rabies titer test is not offered by many laboratories and must be sent out of state for processing. The cost can vary, primarily due to the cost of shipping a frozen specimen on ice. Individuals interested in the Rabies Titer can call the Public Health Clinic for pricing.
