Evaluating private persons masquerading as Public Servants

California Constitution
Article I. Declaration of Rights

Section 2. All political power is inherent in the people. Government is instituted for the protection, security, and benefit of the people; and they have the right to alter or reform the same, whenever the public-good may require it.

Section 6. Excessive bail shall not be required, nor excessive fines imposed . . .

Section 8. No "person" shall be . . . deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use without just compensation.

Section 9. Every citizen may freely speak . . . and no law shall be passed to restrain or abridge the liberty of speech . . .

Section 12. . . . No standing army shall be kept up by this State in time of peace . . . (DEU, SWAT)

Section 14. Representatives shall be apportioned according to population.

Section 17. Foreigners who are, or who may hereafter become, *bona fide* residents of this State, shall enjoy the same rights in respect to the possession, enjoyment, and inheritance of property, as native born citizens.

Section 19. . . . No warrant shall issue but on probable cause, supported by oath or affirmation. .

Section 20. Treason against the State shall consist only in levying war against it, adhering to its enemies, or giving aid and comfort. No person shall be convicted of treason, unless the evidence of two witnesses to the same overt act, or confession in open court.

Section 21. This enumeration of rights shall not be construed to impair or deny others retained by the people.

Article II. Right of Suffrage

Section 5. No idiot or insane person, or person convicted of any infamous crime, shall be entitled to the privilege of an elector.

Article III Distribution of Powers

The powers of the Government of the State of California (unincorporated), shall be divided into three separate departments: the Legislative, the Executive, and Judicial; and no person charged with the exercise of powers properly belonging to one of these departments, shall exercise any functions appertaining to either of the others, except in the cases hereinafter expressly directed or permitted.
