Hi Ryan,

My husband Richard Duning and I attended the meeting Tuesday evening at Azalea Hall about the proposed Center in McKinleyville.

We are thrilled that this sorely needed facility is being planned for McKinleyville! We see so many people in our neighborhood of Calville who are teetering on the edge of complete poverty. They may just not have jobs; they may have mental, emotional or substance abuse problems (which I believe is largely an effect of poverty, anyway) and many are already living in very poor conditions. I believe that a Center such as the one discussed Tuesday evening could help these people, or at least extend a sympathetic hand to let them know that they are not completely forgotten.

We need to keep people from slipping into poverty and homelessness. They can't do much about it themselves. (Although I know many are trying, with little money-making efforts that can't bring them much security.) This Center can bring the help that is available closer to these neighborhoods that are scattered throughout McKinleyville.

I think it is completely appropriate to locate this Center in the "center" of town. I believe that it will be a positive place for people to gather, and will not increase crime.

We would like to have this Center or something like it in McKinleyville to address homelessness. We also think there might have been more extensive publicity about this project earlier in the planning process. However this doesn't diminish the value of the Center itself to our community.

I am unable to attend the hearing on Tuesday, November 8th due to it being election day. I am working the poll at Freshwater School.

I am one of 5 children who were all raised in Humboldt County and more specifically, McKinleyville for most of our life. My husband and I chose to raise our family in McKinleyville. We were very young parents, having two of our three daughters by the age of 22 and 23. We did use county services for a period of time, so this letter has nothing to do with being a "hater" as people opposing the center in it's current proposed form, have been called.

My opposition is based on several issues that I do not think have been adequately addressed.

- 1. Placement of proposed center. As I understand it, this does not fit into the MCSD plan for the town center. I understand this will be addressed at the meeting. Unfortunately as stated above, I will not be able to attend.
- 2. Safety issues/law enforcement. I recently retired as director at Timber Ridge and I am very concerned about the residents who live there. I am concerned about children who live in the surrounding area. We have had increased issues of aggressiveness towards our residents by panhandlers. At one point we had a man found sleeping on a patio area at Timber Ridge. I could not rouse him and had to call the HCSO to come and deal with this situation. We also had break-ins into employee vehicles. Our law enforcement is already stretched and even the law enforcement representative at the October meeting admitted "The Center" would most likely bring more law enforcement issues to McKinleyville. I'm sure you all have heard about the security guard who had to be transported to the hospital after being assaulted.
- 3. Financial issues. I don't believe the public meeting addressed these concerns adequately.

I believe that a committee of citizens who genuinely want to find a way for this to work for everyone, with the funding in place to take care of the inevitable problems that will come up, including local business owners, would be a very good idea. Not addressing the genuine concerns that some people in McKinleyville have regarding the potential negatives of "The Center" makes it really hard to support this plan, not to mention the placement and costs.


I respectfully request that more time is put into discussion and problem solving, which would go a long way, instead of what feels like a "rush" even though an article was placed in the Mad River Union. I would also respectfully request that these issues be noted in the mailer that comes from MCSD, which appears to be our only local government for the foreseeable future.




Figure 1: Creation of Sustainable Initiatives through Coordinating Social and Human Capital for Community Improvement. 2015 Community Bullding Initiative



Dear County Supervisors

Regarding the DHHS lease proposal for "The Center at McKinleyville" facility ("The Center"), I think community decision-making is being forced to operate in a significant informational vacuum. I am being told by some that the services are already being provided in a different nearby facility. But that doesn't comport with the The Center press release. I think more community members would come on board to the project if the public can be guaranteed that no services will be offered that would exacerbate the problems we have been recently seeing in the McKinleyville Shopping Center and other areas around town. These problems include loitering, assaults, burglaries, vagrancy, etc. Can these guarantees be written into an iron clad covenant? In other words, could The Center be permanently prohibited from offering general relief services and homelessness/foodline services? The press release seems to indicate that the services would offer general relief services, but I think the community needs a legally defensible guarantee, not empty promises. This project will never receive my support if it will add to our crime and violence problem in our community. Also I would like to know whether or not communities such as Arcata and those north and east of McKinleyville will be considered to be within the DHHS service area. This also seems to be left out of the press release. The probable parking and traffic issues resulting from serving such a broad area quite frankly has not been addressed.

I am also very concerned about the costs of the lease agreement. The reported monthly lease costs appear to be far above the norm for commercial property. I think the Board has a fiduciary responsibility to fully scrutinize these costs and justify them to Humboldt County taxpayers.

I have lived in this community continually since 1988. I have significant investments in real estate and have no desire to see community degradation due to a service center that potentially would draw unsavory people, much as we already see in Eureka and Arcata. The situation in Eureka is untenable and indicative of a completely failed system.

One of the most important things to ensure good citizenship is to empower families and individuals with the tools they need to make good decisions while supporting those decisions with the resources needed to succeed. Many times these translate to services that can assist individuals, families, and children to accomplish their goals. The idea of a service hub and decentralized services in communities can better reflect the needs of that community while reducing the barriers of time and distance. There are added benefits of flexibility and responsiveness to community concerns that cannot be achieved in a centralized and remote system.

There are legitimate concerns, but I am confident that with careful planning and consistent attention to address issues prior to developing into major problems, these concerns can be addressed. I am confident that McKinleyville as a community is ready and fully capable to make this project a success.

Please allow this important project to move forward and do all that you can to make it a success.

We are writing to demonstrate our collective support for the establishment of The Center in McKinleyville. We appreciate the support the Board of Supervisors continually demonstrates for bringing services into the community of McKinleyville. The Board has historically understood the unique dynamics our community faces and has been proactive in efforts to improve the overall health of the community.

As educators, our primary interest is in the needs of our students. The Center will provide wrap-around support services for students who attend our high school programs. Our student population has some of the highest levels of need in the state. Our students meet criteria as outlined in Adverse Childhood Experiences (ACE) protocol at levels exceeding the norm. Research has proven that the health and welfare of students must be taken care of in order for them to thrive in an educational setting and prepare for a successful transition to college and/or career environment. The Center will provide the support necessary for students to more aptly engage in their studies, extracurricular opportunities, and culture of our high school programs.

Having counseling services available within our community is a major need for McKinleyville. Currently, mental health and other service personnel travel from Eureka. Department of Human Health Services (DHHS) personnel are not a part of the school culture in that the frequency of their presence on campus is limited to individual visitations. Being located in McKinleyville provides the opportunity for them to build relationships within the culture of our schools and among our student populations.
