AMENDING SECTION 311 -7 OF THE HUMBOLDT COUNTY CODE BY REZONING PROPERTY IN THE CARLOTTA AREA [ZR-17-002 (VILTRAKIS)]

ORDINANCE NO. 2614

The Board of Supervisors of the County of Humboldt ordains as follows:

SECTION 1, ZONE AMENDMENT. Section 311-7 of the Humboldt County Code is hereby amended by rezoning lands in the Carlotta area, known as a portion of APN 206-081-001, through immediate rezone, out of Timberland Production Zone (TPZ) to Agriculture General with a combining zone specifying a five acre minimum parcel size (AG-B-5(5)).

The area described is also shown on the Humboldt County Zoning Maps [chcpz2] and on the map attached as Exhibit A.

SECTION 2. EFFECTIVE DATE. This ordinance shall become effective thirty (30) days after the date of its passage.



Legal Description
