To the Fortuna City Council,

I grew up in Washington State and since moving in 1999, I have lived on the east coast, Europe and Mexico, have traveled to over 30 countries and over 55 states. I say this because it has opened my eyes to different cultures with different ways of life. The city of Fortuna and Humboldt County are very unique. I have made this my home for over 7 years because of this uniqueness. I have worked for businesses, friends in the community, and currently own my own businesses Root 101 Nursery and Wildwood Waffles, I chose this business model because I have an understanding of how this community works and what the main industry is, whether it was legal or not. Well times have changed all across this country with the legalization and boom of the cannabis business. 31 states and Washington DC have some form of legalized cannabis whether medical or recreational with many more states having some form of legalization on the ballot this year. However, Humboldt County has something these other states don't. A culture of this industry behind them. This County, in my personal opinion, could be leading the way in developing this brand new industry, but instead has shown its greed. It's tough to write new laws that have never been created, like starting a business, and whats done has already had a huge impact on the citizens of this county. One example is that there are more listings for sale in this county than ever before because these laws and regulations are far above and beyond any other industry in the state. making it incredibly tough to create a business, plus practically eliminating the chance for a "ma and pa" business model

Re: Ventilation/Odor Control Measures at 3151 Drake Hill Rd. Fortuna, CA 95540

To whom it may concern,

O&M Industries will be installing an air ventilation system at 3151 Drake Hill Rd. Fortuna, CA to mitigate potential adverse odor emission impacts to employees and/or properties located in the vicinity.

The space will have an exhaust fan with carbon filter (called out as "EF/CF" on plans) to exhaust air out of the location. The exhaust air will vent to the exterior of the building after being filtered through the carbon filters.

In order to ensure smell does not "seep out" of the building, the system will be designed to maintain a slight negative pressure and will have a barometric intake damper (called out as "Intake" on plans) to ensure room is kept at a slight negative pressure but not over pressurized.
