The successful Bidder shall possess a valid Contractor's license in good standing, with a classification of "B" (General Building Contractor) at the time the contract is awarded.

The successful Bidder will be re-quired to comply with all equal em-ployment opportunity laws and reg-ulations both at the time of award and throughout the duration of the Project.
