AGREEMENT FOR ASSIGNMENT CONSENT

This Agreement, entered into this 5 day of February, 2019, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and DENISE MCNULTY AND ASSOCIATES, INC., DBA ALAMO NATIONAL CAR RENTAL, a Delaware Corporation, hereinafter referred to as CONCESSIONER and ENTERPRISE Rent-A-Car Company of Sacramento, LLC, a Delaware Limited Liability Company, hereinafter referred to as ENTERPRISE, is made upon the following considerations:

WHEREAS, CONCESSIONER is the Concessioner under the Revocable Lease Agreement dated June 19, 2012 ("AGREEMENT") between CONCESSIONER and COUNTY, for use of that portion of County property described as set forth in **Exhibit A**; and

WHEREAS, CONCESSIONER is selling certain CONCESSIONER assets to ENTERPRISE pursuant to an Asset Purchase Agreement dated _____, 20____, (the "TRANSACTION"), and intends to assign its right, title and interest in and to the AGREEMENT to ENTERPRISE per CONCESSIONER'S notice in **Exhibit B**.

NOW, THEREFORE, the parties hereto mutually agree as follows:

1. COUNTY and CONCESSIONER hereby confirm to ENTERPRISE that attached as **Exhibit C** is a true and correct copy of the AGREEMENT and that such AGREEMENT, and has not been amended or modified in any respect except as set forth in such **Exhibit C**.
2. COUNTY and CONCESSIONER hereby confirm to ENTERPRISE that the AGREEMENT is in full force and effect and that CONCESSIONER is in full compliance with its obligations thereunder on the date hereof.
3. COUNTY hereby consents to CONCESSIONER'S assignment to ENTERPRISE of all of its right, title and interest in the AGREEMENT, effective on the date of the closing of the TRANSACTION.
4. ENTERPRISE hereby agrees that ENTERPRISE will assume all obligations of CONCESSIONER under the AGREEMENT, and be bound by all terms and conditions thereof, from and after the date of the closing of the TRANSACTION.
5. COUNTY and CONCESSIONER hereby agree CONCESSIONER will remain responsible for all obligations under the AGREEMENT until the date of the closing of the TRANSACTION, but will be released and discharged from its obligations under the AGREEMENT which accrue from and after the date of the closing of the TRANSACTION.

6. As a condition of the COUNTY consenting to the AGREEMENT transfer to ENTERPRISE, ENTERPRISE herein agrees to pay a one-time fee of Five Hundred Dollars (\$500.00) at the time of the TRANSACTION, per Section 7 (ASSIGNMENT) of AGREEMENT (Exhibit C).
