#### NEW RULES AND REGULATIONS IMPLEMENTING THE 40% EQUITY HIRE PROGRAM

The Cannabis Social Equity Program requires all adult-use cannabis businesses to hire Equity Employees for a minimum of 40% of the total annual work hours performed at the business. The City recently adopted new rules and regulations to implement an administrative program for the 40% Equity Hire Requirement and to provide clarification on the various aspects of the program that all adult-use cannabis businesses are required to comply with. # CITY COUNCIL ADOPTS A CANNABIS SOCIAL EQUITY PROGRAM

On July 10, 2018, the Long Beach City Council adopted a Cannabis Social Equity Program as part of a larger Adult-Use Cannabis Business Ordinance. On September 26, 2018, California Governor lerry Brown signed into law the California Cannabis Equity Act (SB 1294). The bill provides to eligible local grants jurisdictions to assist equity applicants and licensees in gaining entry and to, successfully operating in, the state's regulated cannabis marketplace.
