RESOLUTION EXTENDING THE EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, Ordinance No. 2203 of the County of Humboldt empowers the Board of Supervisors to proclaim the existence or threatened existence of a local emergency when the county is affected or likely to be affected by a public calamity; and

WHEREAS, conditions of extreme peril to the safety of persons and property did arise within this county, caused by severe winter storms, commencing on or about the 20th day of January, 2019; and

WHEREAS, the Sheriff of the County of Humboldt did proclaim the existence of a local emergency within the county on the 29th day of January, 2019; and

WHEREAS, the Board of Supervisors of the County of Humboldt did ratify the local emergency proclamation on the 5th day of February, 2019; and

WHEREAS, pursuant to Government Code section 8630, the Board of Supervisors finds that the aforesaid conditions of extreme peril continue to exist and necessitate the continued proclamation of the existence of a local emergency.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED that said local emergency shall be deemed to continue to exist throughout said county as prescribed by state law, by local ordinance and resolutions of this County, and by the County of Humboldt Emergency Operations Plan, as approved by the Board of Supervisors on the 7th of April, 2015, until its termination is proclaimed by the Board of Supervisors of the County of Humboldt, State of California.
