4. How are you developing a plan for sustainability, including diversification of funding sources, in order for your proposal to carry on without reliance on future *Measure Z* funds?

The security of staff and patrons is paramount at Humboldt County Library. We are investing both time and finances in staff training regarding safety. The library will be purchasing a 30 hour online course, Homeless Library, for all staff. Homeless Library offers strategies, mindsets, and tips for serving home-challenged patrons will maintaining a safe environment. Staff will be allotted ample time for viewing, follow up, and training exercises. Additionally, the library is working with the Humboldt Area Center for Harm Reduction to develop trainings and build a mutually beneficial relationship around safety and appropriate behavior.

The library would investigate reallocating funds a security gaurd position from our operating budget if Measure Z funding were discontinued. This is not the optimal situation for the library; Measure Z

funding is vital to a safe library.

5. If this request is for the continuation, or expansion, of an existing program/service, what is the current source of funding for that program/service?

Our current security gaurd is funded through Measure Z. Our 2019 proposal is an expansion of the library's existing secuity service.

6. If you are awarded *Measure Z* funds, how will you use them to leverage additional grants, contributions, or community support?

Simply put, a safer library is a more successful library. The library is undergoing a period of rapid change; there is new leadership, new staff, and new ideas throughout the system. Professional security guards will free up time for library staff to concentrate on professional tasks. The library will leverage its increased safety and improved services to create new and longterm community support.

This proposal will require Securitas to supply the library with an additional security guard.

Measure Z Funding Project Narrative Humboldt County Library Security Guard Proposal Nick Wilczek

The Humboldt County Library's Eureka location welcomed approximately 150,000 visitors last year. Library patrons from all socioeconomic sectors of our community make use of our facility, collections, services, and programs. In addition to providing traditional library services, Humboldt County Library also serves as one of Eureka's de facto day shelter.

The library prides itself on being open to all members of our community; we are one of the last truly free and open public institutions. We don't value the patronage of any one demographic over any other. That being said, the library serves a large population of people experiencing mental health issues and suffering through drug and alcohol addictions. And this population brings a unique set of behavioral and safety concerns.

There are daily safety challenges at the library. Concerning behaviors include drug use, inappropriate and harassing comments, and threats and instances of physical violence. Female staff are often confronted with sexually harassing comments, and used sharps are an almost constant presence around the building. Threats of violence against staff, security, and other patrons are not uncommon, and EPD intervention is required multiple times a week.

Funding two security guard positions for the Eureka location of the Humboldt County Library is vital to the public safety of our community. In addition to serving as a cultural and educational hub of our city, the library is also one of Eureka's largest homeless day shelters. Approval of this funding proposal will ensure that the library is providing a safe space for people from all of Humboldt County's demographics.

Measure Z Funding Prior Year Results Humboldt County Library Security Guard Proposal Nick Wilczek

During the past year, Measure Z funding has allowed the Humboldt County Library to fund a security guard position for all open hours of the Eureka Library. This position has been vital to creating a safe experience for the library's 150,000 annual visitors. While there is still work to be done, we have seen a marked decline in negative patron behaviors.

An unanticipated consequence of our past year's experience is the realization that, while one security guard helps, we are in need of additional security personnel. As the homeless population of our county grows, so too do the amount of homeless people needing library services. In other words, the library has become the largest de facto homeless day shelter in the city of Eureka. As such, we have noticed the need for additional security staff.

While the overall safety of the facility has increased, the past year has taught us that there is still room for improvement. The library is still contacting EPD at a more than ideal rate and would benefit from handling more concerns in house. An additional security guard during all open hours will allow for proactive security and enforcement of behavioral standards at the Eureka location of the Humboldt County Library.
