<b>AUTHORITY:</b>	Section 130140 of the Health and Safety Code County Ordinance Nos. 2299, 2185 and 2222
<b>APPOINTING POWER:</b>	Board of Supervisors
<b>MEMBERS:</b>	At least five, but no more than nine
<b>QUALIFICATIONS:</b>	Residents of Humboldt County and Categorical Requirements
<b>TERM:</b>	<b>County representatives:</b> Four Years <b>Public members:</b> Three members serve 3-year terms and three members serve 4-year terms (no appointee shall serve for more than two consecutive terms). (Regardless of appointment date, terms expire on the original appointment dates)
<b>FUNCTION:</b>	Adopt an adequate and complete county strategic plan for support and improvement of early childhood development within the County, consistent with the requirements of the <i>California Children and Families First Act of 1998</i> and any state regulations or guidelines hereinafter enacted to implement the Act.
