

## CANNABIS MIRCO-GRANT & LOAN ADVISORY COMMITTEE

<b>AUTHORITY:</b>	Resolution # 19-45 dated 5/28/19
<b>APPOINTING POWER:</b>	Board of Supervisors
<b>MEMBERS:</b>	(9) Nine total. (7) Seven voting members. (1) from each District Appointed by the Supervisor from that District, (2) At-Large (1 representing the cannabis industry and 1 representing an industry that is lateral to the cannabis industry such as finance or banking) and (2) Alternates Appointed by the Board of Supervisors (non-voting unless needed)..
<b>QUALIFICATIONS:</b>	Must live within District represented for District 1-5 categories.
<b>TERM:</b>	Four (4) Years except for the first meeting of the committee where (3) three members shall be randomly selected to serve for only two (2) years so that appointments will thereafter be staggered.
<b>FUNCTION:</b>	The purpose of the Humboldt County Cannabis Mico-Grant & Loan Adivsroy Committee is to announce, review, rank, and select applications for micro-grant & loan monies, which shall be subject to Humboldt County Board of Supervisors approveal, ans as defined under Project Trellis. In making recommendations regarding funding, the committee shall take into consideration all applicable county and state cannabis funding sources and programs,
