WHEREAS, the DHHS DEH will use these funds for activities related to the SWRCB's Water Beach Safety Program; and

WHEREAS, the DHHS DEH is authorized to enter into a financial assistance agreement with the SWRCB; and

WHEREAS, the DHHS DEH desires the Director of Public Health, or the Director of Public Health's designee, to serve as the authorized representative for the DHHS DEH for purposes of the BEACH Grant Program.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby authorizes the Director of Public Health, or the Director of Public Health's designee, to enter into a financial assistance agreement with the SWRCB for the BEACH Grant Program and to execute any applications, agreements, amendments, invoices or other documents related to or required for the administration of said agreement, and to comply with all applicable federal and state statutory and regulatory requirements related to any financial assistance funds received.
