WHEREAS, the California Department of Forestry and Fire Protection has been delegated responsibility for the administration of the California Climate Investment Fire Prevention Grant Program, including, without limitation, setting up necessary procedures governing application for grant funding by local agencies, non-profit organizations and others; and

WHEREAS, the County of Humboldt ("County"), by and through the Humboldt County Department of Public Works, desires to apply for, and accept, if awarded, funding made available through the California Climate Investment Fire Prevention Grant Program in order to complete the Community Wildfire Protection Plan Phase III: Fire-adapted Landscape and Safe Homes project ("Phase III – Fire-Adapted Landscape and Safe Homes").

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

If the County's application for funding made available through the California Climate Investment Fire Prevention Grant Program is approved by the California Department of Forestry and Fire Protection, the County hereby represents and certifies that the County will have sufficient funds to operate and maintain the Phase III Fire-adapted Landscape and Safe Homes project.
