MINUTES

The meeting was called to order by Marc Rowley at 12pm.

The minutes of the September 25, 2019 board meeting were reviewed. Genie read emails of the three points that Laura wanted to see reflected in the minutes regarding the Map & Guide: 1) there were updates & design changes on all but one page of the current made by Julie, 2) Laura did submit updates & requested changes In the requested time period & those updates were acknowledged as received but omitted from the update version, 3) Laura felt that printing the Guide featuring only HCVB members & not correctly describing the destinations does a disservice to the County as a whole & misrepresents our County to the visitor & their experience. Meredith made a motion to add Laura's requested additions, seconded by Lowell (approved, unanimously). Lowell made a motion to approve the minutes with the approved additions, seconded by Pete (approved, unanimously).

The Sales Report: April Hagans briefed the Board updated the Board with the many current activities being undertaken, including upcoming Arborist group & the Family Nature Summit that were upcoming site visits for their 2020 meetings, and noting that the Family Nature Summit group postponed their visit due to the power outages. April stated that, the rich variety of Humboldt County's nature & experiences attract visitors there are gaps in the experiences. The economic impact of these groups can be measured thereafter. April reviewed recent wedding requests & the upcoming North Coast Journal wedding guide event. She reported on the multiple recent and future media FAM trips. April recapped work on the website for the Meetings, Weddings, & Membership sections to make it more useable for members & the Board. She asked Board Members who had recently visited the Members section, with affirmative responses from Justin, Meredith, & Laura.

The Executive Director's Report: Julie Benbow

The County Tourism Stakeholders Meeting Report: There was much discussion regarding the Bureau's future role as the DMO for Humboldt County, as well as the marketing of cannabis. Speaking for the County, the Bureau's role in marketing cannabis, Scott stressed that the RFP

This letter is being sent to the Humboldt County Board of Supervisors to inform the Board of the omissions and inadequacies found in the newest version of Humboldt County's "California's Redwood Coast Map & Visitor Guide" brochure relating to sections that cover the Lost Coast/Shelter Cove area.

Some of these omissions and inadequacies include: The lack of information about recreation sites/opportunities identified within Shelter Cove; the lack of notice for permit requirements for overnight backpacking on the Lost Coast Trail; The omission of the name of "one of the nation's best single-track bike trails"; No contact information provided under "The Lost Coast" section for any government office; County wide map does not depict camping/hiking locations that exist in Shelter Cove and within the King Range National Conservation Area; Shelter Cove Arts and Recreation Foundation's Art Gallery at the Inn of the Lost Coast is not included in the list of "Galleries" and Gyppo Ale Mill is not included in the list of "Craft Beers." Also there is no information on sport fishing opportunities and the unique way in which boats are launched at Shelter Cove.

The intent of this letter is to help shape future direction from the Board of Supervisors to the Humboldt County Visitors Bureau so that future versions of the "California's Redwood Coast Map & Visitor Guide" brochure may more wholly reflect the destinations, experiences and businesses that serve visitors of the Lost Coast area and Shelter Cove.

For today's traveler, a seeker of experiences, successfully highlighting and showcasing the many opportunities for adventure, relaxation and connection to nature in Shelter Cove and on the Lost Coast is critical for the Humboldt County Visitors Bureau to meet its goal in attracting more and diverse visitors. The work of our Visitors Bureau is very important to the Shelter Cove community and the community is grateful to be part of the California's Redwood Coast Map & Visitor Guide. The Shelter Cove community wants to work with the Visitors Bureau to improve outreach to our visitors. Working together we can greatly improve the Map & Visitor Guide and increase awareness for visitors and grow our local economy.

Dear Chairman Bohn:

As the founding President of the Humboldt County Visitors Bureau I recommend that the county continue its funding of this organization. For over 4 decades the "Bureau" has been responsible for marketing the county to visitors which wish to come here and enjoy our amazing outdoor activities. As you are aware the City of Eureka foolishly decided to discontinue funding the bureau this year and the bulk of the funding now comes from the County. Southern Humboldt collects the largest amount of bed tax in comparison to the north and east areas yet we have the least representation from the Visitors Bureau. For example, the recent publication of "California's Redwood Coast Map & Guide" did not represent Southern Humboldt in a number of areas and details, which were given to the "Bureau" staff as corrections on a draft document. Those corrections were not included in the publication. Not only that but there were inaccurate listings such as Bear River Casino being listed as a Craft Beer brewer and the only restaurant listed for Southern Humboldt was the Benbow Inn Restaurant. Other omissions included not having either the Northern Nights or Summer Arts listed as festivals. We have been assured that this will not happen again but this needs to be memorialized to make sure there is some documentation of this so such wrong doing and injustice does not happen again.

Please continue to fund the "Bureau" as it will ensure the representation of the Visitor Industry in our county and if southern Humboldt continues to be underrepresented, we will report back to the Board.



Dear Chairman Bohn;

As the owner of the Inn of the Lost Coast for the past twenty years in Shelter Cove I recommend that the County continue to fund the Humboldt County Visitors Bureau. The HCVB has been marketing the County for over forty years to visitors which wish to come here to enjoy all our amazing outdoor activities that are located throughout the County. Southern Humboldt collects the largest amount of bed tax in comparison to the north and east areas yet we have the least representation from the HCVB. The recent "California's Redwood Cost Map and Guide" did not represent Southern Humboldt including Shelter Cove in a number of areas and details, which were given to the "Bureau" staff as corrections on a draft document. The corrections were not included in the publication and the publication was printed and delivered with a gross number of omissions, inaccurate listings and completely overlooked Southern Humboldt activities. In my years of business experience in Shelter Cove this has been the norm and not the exception with regard to the HCVB. We have been assured that this will not happen again and ask that the County provide documentation that this kind of poor representation of the County does not continue.

Please continue to fund the HCVB with close scrutiny of business practices and methods going forward to insure equal representation for all.
