Greetings Board of Supervisors,

I am writing to submit public comment regarding today's agenda item #1;

Attestation of Humboldt County Readiness for Variance to Stage 2 of California's Roadmap to Modify the Stay-at-Home Order.

In the agenda-attached document, 'Humboldt County COVID-19 Containment Elements', May 12, 2020, page 3, heading 'Epidemiologic Stability of COVID-19', the 'as of' date for the data provided is May 11th, indicating 8 cases in the past 14 days. As of yesterday, May 12th, that count rose by three, which would indicate a total of 11 new cases within the past 14 days.

Given that we will very likely see additional cases confirmed this week, it seems premature to attest that Humboldt County is ready for a variance to stage 2. If even just two or three additional cases are confirmed today (our average daily confirmed case rate for the past three days in a row), we'll be over the threshold for the 1/10,000 in a 14-day period.

Due to our recent upturn in cases, I implore this Board of Supervisors to 'stay the course' - don't accelerate re-opening at this time.

I would like to comment on the proposal to lift restrictions.

I believe we must resist pressure to move too quickly on lifting stay at home orders, and on opening businesses, as new cases are still emerging in Humboldt County.

May I suggest a cautious approach, keeping in mind that we are an isolated area with few hospitals and limited medical staff. We cannot afford an outbreak that overwhelms our local capabilities to handle it.

Please take this virus very seriously, this is NOT like seasonal flu.

I would like to suggest that certain businesses not currently on the list be allowed to open "by appointment only." (Frame shops, salons, businesses in which one on one service can be offered.) Others can offer curbside delivery and perhaps be encouraged to use cameras to aid customer choices.

Opening by appointment only, should be offered only to those who can adhere to strict guidelines as to sanitation between customers, and the use of masks at all times. And compliance should be monitored.
