5/19/2020 This is in regards to the letter we received from the Humboldt Co Zoning Administrator dated May 6th 2020. The applicant is requesting a "Special Permit for a reduction to the required 600 foot setback from public lands". The requests are for properties located at 515 Boy Scout Camp Rd and 540 Boy Scout Camp Road in Myers Flat, CA. We request that the "Special Permits" be DENIED. This area used to be all family owned properties where you could enjoy time with family and friends. With all the grows on the road now, the "Smell" is very overpowering as the plants mature. It has created increased traffic on this private road which is in complete disrepair and nobody helps that maintain it. We have had crushed rock brought in to help with holes and mud in front of our property, but it doesn't last with trucks up and down the road all the time.
