I am a retired epidemiologist from UC Davis

Among the statistics currently given on the county Covid Dashboard website are percentages of women and men, of age classes, and of ethnic groups within the group of those who tested positive. For example, it may report that 58% of those testing positive are women and 42% are men. This statistic cannot be interpreted to mean that more women have become infected than men, as is implied. These percentages say nothing about the positivity rate among women, which is the appropriate and necessary statistic. The current flawed statistic can be manipulated easily simply by sampling or testing more men, or more women. Because the percentages relate only to the group of those testing positive, ignoring the number tested, they have no meaning, and are uninterpretable in understanding the county's Covid 19 epidemic.

These percentages deceive the public, and even medical professionals, into believing they reflect the risk or likelihood of becoming infected. Even the media misinterpreted these statistics, as illustrated by a recent inaccurate statement in the Times Standard on the county's ethnicity positivity rate.

Instead, the county needs to report the percent of women tested who are positive, of men tested who are positive, of teenagers tested who are positive, etc.
