Resume for Pete Oringer

Pete Oringer was born in Los Angeles in 1944. He graduated UCLA in 1966 with a B.S. in Invertebrate Marine Biology and attended the Humboldt State University in 1969 for a masters in Marine Biology. Before coming to Humboldt County to attend grad school, he worked for Los Angeles County Museum in invertebrate marine biology and invertebrate paleontology and in genetic research at UCLA. He also co-taught an oceanography class at UCLA extension school before coming to Humboldt County to attend grad school.

Mr. Oringer was one of the principal founders of Pacific Marine Engineering Inc. (1969) which included several subsidiaries including: Environmental Consultants; PME Commercial Diving; Pro Sports Center; and Pacific Outfitters.

Mr. Oringer was appointed to a three year term to the Solid Waite Management Review Board and was an active member and organizer of the Eureka Business Leaders Roundtable.

Mr. Oringer is active in Humboldt Bay and Port issues. He has served on the Humboldt Bay Management Plan Committee that updated the plan for the Humboldt Bay Harbor, Recreation and Conservation District. He has served as a Boardmember of the Humboldt County Convention Visitors Bureau Board for over fourteen years and he is a member of the Arcata Chamber of Commerce. Mr. Oringer is a founding principal and treasurer of both the Land Bridge Alliance Inc., and Humboldt Eastern Rail Road LLC. He is the liaison from both the Land Bridge Alliance and the Upstate Rail Connect Committee to the North Coast Rail Authority. Mr. Oringer served for ten years as head of the Bayside Community Hall (previously named the Bayside Grange).
