TERMINATION AGREEMENT

This TERMINATION AGREEMENT is dated as of August 1, 2020 (this "Agreement"), and is by and among the COUNTY OF HUMBOLDT, a political subdivision duly organized and existing under the laws of the State of California (the "County"), the HUMBOLDT COUNTY PUBLIC PROPERTY LEASING CORPORATION, a nonprofit public benefit corporation duly organized and existing under the laws of the State of California (the "Corporation"), and the TREASURER-TAX COLLECTOR OF THE COUNTY OF HUMBOLDT (the "Treasurer"), acting on behalf of the Humboldt County Treasury Pool.

WITNESSETH:

WHEREAS, the County and the Corporation have heretofore entered into a Site Lease dated as of August 1, 2016 and recorded in the Official Records of the County on August 4, 2016 as Document No. 2016-014690 (the "Site Lease"), pursuant to which the County agreed to lease certain real property described in Exhibit A to the Site Lease, including the improvements thereon to the Corporation (the "Leased Premises"); and

WHEREAS, the County and the Corporation have heretofore entered into a Lease Agreement dated as of August 1, 2016, and recorded in the Official Records of the County on August 4, 2016 as Document No. 2016-014691 (the "Lease"), pursuant to which the Corporation agreed to lease the Leased Premises back to the County, and the County agreed to make certain lease payments (the "Lease Payments") to the Corporation; and

WHEREAS, pursuant to an Assignment and Purchase Agreement dated as of August 1, 2016 and recorded in the Official Records of the County on August 4, 2016 as Document No. 2016-014692 (the "Assignment Agreement"), by and between the Corporation and the Treasurer, the Corporation assigned to the Treasurer, among other things, its rights to receive the Lease Payments from the County under the Lease and the right to exercise such rights and remedies conferred on the Corporation under the Lease to enforce payment of the Lease Payments; and

WHEREAS, the County hereby certifies that it has caused to be delivered to the Treasurer, a security deposit consisting of cash as described in Sections 4.5 and 10.1 of the Lease, which is sufficient to prepay all of the County's unpaid Lease Payments to and including December 10, 2019 (the "Prepayment Date"); and

WHEREAS, to facilitate the County's exercise of the option to prepay the Lease Payments, the County and the Corporation now desire to terminate and discharge the Site Lease, the Lease and the Assignment Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto do hereby agree as follows:

1. <u>Effective Date and Recordation</u>. On [December 10, 2019] the County deposited with the Treasurer sufficient cash to prepay all unpaid Lease Payments to and including the Prepayment Date.

2. <u>Termination of Site Lease, Lease and Assignment Agreement</u>. The County and the Treasurer hereby acknowledge and agree that as a result of the payment by the County described in Section 1 hereof, the Site Lease, the Lease and the Assignment Agreement have been terminated and discharged, and are of no further force or effect and the Corporation and Treasurer, as assignee, have no further interest in the Leased Premises and title to the Leased Premises has vested in the County.

3. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original and all of which, when taken together, shall constitute one agreement. The signature and acknowledgment pages from each counterpart may be removed and attached to a single document in order to create one original instrument.
