**Subject:** Comment on Proposed Project at Humboldt County Fairgrounds

I am very concerned that a use permit to add motorized racing events and concerts at the Humboldt County Fairgrounds in Ferndale is being considered without the benefit of an Environmental Impact Report (EIR). Both of these types of events constitute major changes in the use of the facility, with potentially significant environmental impacts.

The Noise Impact Study, prepared by Whitchurch Engineering, states: "For flat track racing, unmitigated CNEL [noise] values fall into the "clearly unacceptable range," and that even with mitigation, the noise levels would only be reduced to "normally unacceptable." Regarding monster truck events, the study states that "since noise from monster trucks is essential to the spectator experience" the only mitigation is to limit the number of events that can be held each year. The study concludes that even with mitigation, motorized vehicle events will create exterior noise that is not within normally acceptable limits, but that with a Conditional Use Permit "temporary exceedances can be disregarded."

According to the California Environmental Quality Act (Chapter 2.6:§ 21080):

**(d) If there is substantial evidence, in light of the whole record before the lead agency, that the project may have a significant effect on the environment, an environmental impact report shall be prepared.**

Based on the conclusions of the Initial Study and the Whitchurch report, there is substantial evidence that this project will have a significant impact on the environment and that an EIR is required. Any consideration of the project without a completed EIR will be inadequate, and thus, unacceptable.

We are aware of a proposal to use the County Fairgrounds as a venue for Monster Truck Events and both of us are completely opposed.

My wife and I are new residents of Ferndale, buying here primarily for the peace and quiet Ferndale offers. It is rare in California to live in a quiet small city without having to hole up somewhere completely out in the countryside. Cities up and down the state cannot make nearly the same claim to the level of natural beauty, structural authenticity and stress free daily life Ferndale offers. It is very unique to have so much of town so intact and maintained at this level. Our town is rare, much appreciated by us and our neighbors and we are proud of both it and the citizens here who volunteer excessive time and energy to keep it so.

We are vehemently opposed to this Monster Truck Rally because we come from Southern California and have direct experience with both the Winternationl Races held at the L. A. County Fairgrounds and the Hydrofoil boat races held in Mission Bay – all negative in the extreme. Not mildly loud: over the top, dog screaming, bone rattling, head splitting noise; from the days of testing and tuning engines to qualifications and finally to the last day/days of nonstop heat after heat engine scream of a type no one should be made to endure. This is not the rev of a souped-up road car or irritatingly tuned Harley; it's a full volume bleating, crackling, earsplitting racket that operates in two modes; the blat, blat of a nitro-fueled rocket barely turning over or the full throttle scream of eight seconds of life you never want to live again.

We are also opposed due to another factor planner's seem to want to avoid talking about -the types of vehicles and people who will coming here – no thanks again. We know the clientele that flocks to Monster Truck Rallies, we know them from the drunkenness, their own loud cars and the trash they leave in their wake - we know them too well and don't want to see them at all, at any level. Somehow "Victorian Village" and "Monster Truck Rally" just don't go together.

We sold that home in La Verne (the unfortunate city adjacent to the L.A. Fairgrounds) and left the area although we loved many aspects of that city. Similarly, although we enjoy Mission Bay we have for years avoided that entire (huge) waterpark and all the hotels, restaurants and bars in the area while hydrofoil season was on. It is that annoying.

Had we ever suspected Ferndale would ever fall prey to such a rotten slight-of-hand by the county as the prostitution of the Fairgrounds for such environmentally and culturally damaging event as a Monster Truck Rally it would have caused us not to purchase in Ferndale at all, anywhere in the area code. Please don't force us to leave a town we have quickly fallen in love with as result of a need for such poisonous revenue – I assure you it will cost far more than you think.

We are writing this letter in regards to the upcoming Planning Commission meeting on September 3 by the Humboldt County Fair Association asking for use permits to consider a request for motorized events and concerts at the fair ground location in Ferndale. As business owners and residents of Ferndale and living very close to the fairgrounds, we are very upset over this upcoming proposal and the burden it would place on our quiet community.

In 2017, the Fair Association held a Monster Truck Rally and a motorcycle race in Ferndale without seeking permission, notifying our community or conducting a noise study. The noise was deafening with the monster trucks and was felt and heard throughout the town of Ferndale. It measured way beyond the accepted levels. The motorcycle races were also extremely noisy and we had to compensate our guests at our BnB for both events for the inconvenience, not to mention calming our stressed animals. Our village and our business location is a place that people come to to escape the noise and confusion of the outside world. Having these events will destroy all that Ferndale has tried to achieve. We have worked hard over the years to make it a safe and peaceful village for it's residents and visitors. In a small Victorian village that is on the National Register of Historic Landmarks, our status would be jeopardized and there would be no reason for visitors to want to come, not to mention how the noise levels would affect the livestock and animals that reside in our area. An EIR is essential before any further consideration of the permit application. Our way of life, our business and property values are at stake with this proposal.

The proposal of 10 outdoor concerts a year is way too much, as that would be two concerts a month during the summer months. We ask that permit be modified to a reasonable amount. With the noisy events that the Fair Association are proposing, Ferndale would be impacted greatly. I would suggest that the two locations that Humboldt County has already authorized for motorized events, Samoa Peninsula and Redwood Acres are sufficient for our county. They are closer to the majority of people attending these events and do not overwhelm Fernbridge (traffic wise) and detract from Ferndale. I would also like to propose that the Association find events that would enhance our village and businesses for the long term, not jeopardize them with extreme noise levels.

To whom it may concern,

The annual county fair held near me was disclosed as a condition of sale which I accepted when I bought my home. In fact, I have come to appreciate the fair and the fairground over the years. However, when the 1st unsanctioned motor event happened in 2017, the incredibly loud noise made it impossible to have a conversation anywhere on my property - even inside the house.

I ask everything be done that the law affords to prevent more events like this. For example, an Environmental Impact Report required to consider a change of this magnitude has not been done. 14 noisy events over 6 months - suffering through a massively loud event every other weekend, every summer, year after year - would be an unbearable environment for me and the resale value of my home would be permanently reduced. **This would mean less money to the county from property taxes for all real estate nearby.**

Noisy events discourage the kind of tourism Ferndale has cultivated. The outrageous whine of motorcycles and roar of monster trucks is hardly fitting to what makes Ferndale unique. Amplified concerts echoing back and forth through town off the hills reduces the value of Ferndale to all of us who've ever enjoyed time here. I am unwilling to see Ferndale absorb these "externalized costs". It's not right to sacrifice Ferndale to the fairground.

Steve:

I am a resident of Ferndale and have enjoyed the Humboldt County Fair since purchasing my home in 2007.

As an engineer (retired) I have had project management responsibilities for CEQA compliance. I understand the responsibilities of MND objective reviews, presenting comprehensive factual testing data, and I understand the importance of communicating proposed impacts to those affected by a project.

I reviewed the Whitchurch Engineering study, and the Initial Study, with the proposed CUP/MND. The Whitchurch Engineering study provides adequate factual noise testing data re: effect at the fairgrounds for motor cycle and concert events. However the study did not address the in town noise levels due to reflection from the surrounding hillsides.

The HCFA has not been transparent, and previously has failed to notify residents of non-fair events which resulted in noise affecting nearby and city residents. I was encouraged that you prepared a CUP/MND, and that you are acting as an independent and objective professional responsible for HCFA compliance with requirements. However, there is a significant amount of information to be studied and provided. The burden of proof for meeting CEQA requirements should be on the HCFA.

The decision to approve the CUP should be postponed until COVID safety guidelines for reopenings are published, and until HCFA can demonstrate financial solvency with a new General Manager in place.

**Sect: 2.3.1 Motor Sports Events**

For the purposes of these comments below, I accept the Whitchurch Engineering study which provides adequate testing to regulatory standards, calculations of noise impact at the racetrack and suggestions/mitigation's for flat track racing and concerts.

- 1) However the CUP/MND approval of monster trucks; tractor pulls; go-carts and 4x4 truck events with no engineering noise study (similar to Whitchurch Engineering study) does not meet EIR requirements for impact assessment. Such a study would likely result in noise levels greater than CNEL L-max of 101 dB. Those noise levels would be a significant impact.
- Recommendation - eliminate monster trucks, tractor pulls, go-carts and 4X4 truck events if a noise assessment has not been performed or proven it does not meet Whitchurch CNEL Lmax = for attenuated motor cycles racing prior to 6PM.

**Sect: 3 Environmental Factors**

These Environmental factors were not checked for review/justification or scored as no-impact. These factors do have potential significant impact.

- 1) Sect: 3.2.17 Transportation - Existing use (2-weeks/year - Aug.-Sept.) when compared to the proposed change of adding 14 events/year (Mar.-Oct.) significantly increases the impact on Hwy-211, the City of Ferndale, and the neighborhoods of Arlington, Main, and Van Ness streets. The traffic flow for the fair builds gradually over the day. In the case of scheduled events there is a maximum flow to meet the event start time.
- Recommendation - complete a review/discussion of HCFair attendance records compared to the proposed approval amounts which are 10,000 attendees/event X 14 events = 140,000 attendees. Even if a 50% (70,000) car pool vehicle reduction were assumed, this would result in 70,000 / 14 events = 5,000 vehicles/event.
- Recommendation - In order to meet a Less than Significant score the mitigation measure (if assessments warrant) could be to limit the number of motor cycle events to 3/year and concert events to 4/year or less, March thru October depending on study outcome.

2) Sect: 3.2.19 Utility Service Systems - I am in extreme disagreement with giving a no impact score to sewer and water systems. There is no data/discussion of existing HCFair waste system discharge or water demand. The proposed approval of (10,000 attendees at 14 events = 140,000 attendees) is significant contribution to the waste water collection and may exceed treatment plant capacity, inflow and time of year (Mar.-Oct.) discharge limitations. It may also exceed limits for solid waste. The water system demand may also be exceeded.

- Recommendation - assessment of the HCFair (using average attendance) historical wastewater inflow to WWTP compared to the proposed 140,000 users. A similar assessment of historical water demand vs the proposed 140,000 user demand should be conducted so the City of Ferndale water is not adversely affected.
- Recommendation - In order to meet a Less than Significant score, the mitigation measure (if assessment warrants) could be to limit the number of motor cycle events to 3/year and concert events to 4/year or less, March thru October depending on study outcome.

3) Sect: 3,2.15 Public Services - I disagree with the no impact score for Fire and Police protection.

- Recommendation - Have a discussion with City of Ferndale Fire Protection as it is a volunteer Fire Department. Providing coverage for the fair is very different manpower commitment than for 14 additional events.
- Recommendation - Have a discussion with City of Ferndale Police Department. Staffing is minimal for normal city coverage; overtime is used for coverage for the HCFair. Employee hours and overtime pay for 14 additional events would have considerable adverse financial impact on the Ferndale City budget.
- Recommendation - In order to meet a Less than Significant score the mitigation measure (if discussion warrants) could be to limit the number of motor cycle events to 3/year and concerts to 4/year or less and require HCFA to pay associated costs for Fire and Police coverage for all events.

### **Mitigation Measurement Monitoring**

#### **Measure 3**

NOI-1 Whitchurch Engineering study indicates that the best compliance plan to mitigate noise for motorcycle racing should be no later than 6PM to meet CENEL of 70.3db.

- Recommendation - Require a Whitchurch Engineering noise study be performed at various city locations to eliminate concern for noise reflection off of the hillside.
- Recommendation - Mitigation could be requiring a maximum number of nine racers (allows for two heats) in accordance with Whitchurch table 6 restrictions for nine racers and to finish racing by 6PM.

#### **Measure 8**

##### **NOI-6**

- Recommendation - Eliminate one monster truck and other non-motor cycle events because no engineering noise study was performed. See comments above.

#### **Measure 10**

- Recommendation - Require that HCFA provide the year's schedule of events to the HC Director of Planning & Budget, and to the City of Ferndale before February for all events and concerts.
- Recommendation re "Note" - Add that HCFA is required to provide documentation for any events that did not meet the mitigations, operating restrictions, and project conditions. I recommend that if any of the mitigations or operating restrictions were exceeded for two consecutive events, this would result in a loss of the CUP.
- Recommendation - In my view, your note should not reference monster trucks based on my comments above.

### **Conclusion:**

- 1) Given the amount of information yet to be studied and provided, I would recommend not approving the CUP until a full EIR is performed. This places the burden for proof on the HCFA.
  - 2) The proposed changes to the lease agreement CEQA checklists assume that the existing conditions meet state regulations. The HCFairgrounds do not meet the Americans with Disabilities (ADA) accessibility requirements. The HCFA has received state funds to correct these deficiencies however they have not been implemented.
- Recommendation - Withhold any use permit approval contingent on HCFA implementing all required ADA improvements with final inspection and approval by regulatory authorities.

**Humboldt County Planning Commission - As you go through the public comment phase of the Humboldt County Fair Conditional Use Permit, I would like to express my support for this permit. The Humboldt County Fair provides the largest attended venue for the County, and provides an economic impact of \$8-10 Million year to the local economy(far greater than any other event). Its long history goes back to 1896, and is one of the oldest continuous fairs in California. It is a "Tradition" that generations of Humboldters have cherished, and one that needs to be protected for future generations to experience. In 2012, the State cut almost all funding to fairs in California. What did that mean to our Fair? It meant a reduction from approximate \$400 to 500 thousand a year to just less than \$40,000. The Humboldt community has stepped up with both sponsorship funds and volunteer help to narrow the gap of the this shortfall. Without their generous effort our treasured "Tradition" would have been gone forever. The Fair's responsibility of maintaining 65 acres of aging buildings has been a challenging effort. There is a need to obtain additional revenues by better utilizing the facilities during non-fair times. There has been an increase in interim events and new ideas have been encouraged. The adoption of this Conditional Use Permit in principal is essential in providing much needed financial opportunities for "Our Fair".**



My husband and I live in Ferndale, California. We are writing in regard to the Humboldt County Fair Association's proposal to expand events at the County Fairgrounds to include motorized events and concerts. We strongly object to this proposal for these reasons:

**First is Noise.** The Noise Impact Study prepared for this proposal appears inadequate, especially since probable impacts were measured at only two locations, both close to the fairgrounds. As such, they do not reflect the *actual impact noise produced by these events will have on the whole town*. In 2017, we were inside our house, located across town from the fairgrounds more than a mile away, when we heard a highly irritating loud, penetrating, endless shrieking whine. Puzzled, we went outside and tracked the noise to its source—a motorcycle race at the fairgrounds. Unless people live in Ferndale, most are unaware that sounds echo off buildings and the bluffs behind the town. Sounds are often amplified, seeming louder further away than they do at their source.

**Second is Noise Mitigation:** Whitchurch Engineering has described a number of ways that noise produced by these events can be reduced, but admits that *noise levels will probably remain "unacceptable"* even if the mitigations are adopted. It appears, however, that adopting even these mitigations is voluntary, since there is no statement about *who is responsible for enforcing them*.

**Third is the Schedule:** 14 events are proposed for the period between March and October. This may seem reasonable until one considers that 6 weeks (August 1 to September 15) must be subtracted from the schedule to accommodate the county fair. This leaves 169 days for 14 events. *If all 14 are scheduled, there will be an event every 12 days*. Not only that, there is *no mention of whether these will be one, two, or even 3-day events*. Adding to the potential disruption of the town, *March to October is also Ferndale's prime tourist season*. Providing adequate housing, parking, and dining places for tourists is already a challenge; adding several thousand more people to the mix every 12 days will be too much for this small residential town. It is also likely that tourists, who come to Ferndale for its charm and peace and quiet, will not return if the town is overwhelmed by monster trucks and motorcycles.

**Fourth is Traffic:** In a best-case scenario (for the HCFA), more than 5,000 people might attend one of these events. *We do not see any discussion of how traffic generated by such an event will be accommodated* without great disruption to Ferndale residents. Fernbridge is a very narrow bridge, and Highway 211—Ferndale's only real link to the outside world--has only two lanes. How will monster trucks cross the bridge without completely blocking traffic? How will Ferndale residents be accommodated so their lives don't come to a literal halt, possibly every 12 days for a good part of the year?





**What Do We Want?** Obviously, we would rather not have motorized racing events or large concerts at a venue located completely within our very small, rural town. If permission is granted by the County Planning Commission, however, we hope that the *number and frequency of the events are reduced, that their size is limited, that the mitigations suggested by Whitchurch are required, and that the body responsible for enforcing them is specified.*

We also want to see--before a permit of any kind is granted to the Humboldt County Fair Association--that an *Environmental Impact Report (EIR), as required by the California Environmental Quality Act (CEQA)* is prepared. Simply approving a mitigated negative declaration--when the impacts on the residents of Ferndale are potentially so dire--is inadequate. Without an EIR, there can be no real assessment of the impact of these events on our town.





Once again, we urge you to support the conditional use permit for the Humboldt County Fair Association.



Re: Proposed Motorsports and Concert events at the Humboldt County Fairgrounds

Dear Mr. Lazar:

As a resident of Ferndale with a background in land use planning and some training in CEQA, this letter is in response to a draft Initial Study and Mitigated Negative Declaration (MND) currently circulating for comments. I would like to make the following comments with a recommendation that the County consider the need for an environmental impact report to fully address impacts for the project.

The Project Description includes a total of fourteen (14) discrete events including amplified concerts and related musical activities, flat-track motorcycle races, tractor pulls, four-by-four events, monster truck events and go cart races. The fact that these items are spelled out in the project description presumes that the possible impacts of each event have been analyzed in the mitigated negative declaration, are deemed not to cause significant impacts and that this conclusion is backed up with rigorous studies.

1. Noise studies for flat-track racing and concerts are included with the MND but there are no studies that discuss impacts or proposed mitigation for the other listed events. This is especially troubling in the case of monster truck rallies since this is the event with the greatest noise impact, by far.

As stated on page 31 of the Initial Study, under the description of noise impacts from monster truck events, *"Given the limited number of motorsports events and particular venue characteristics that are needed to host events of this sort, the project is a good candidate for considering an exception to the general plan short term noise standards"*.

The implication is that there is no need to study or consider noise generated by monster trucks because of a technical exception. The general plan exception referred to is not discussed in the noise study or the Initial Study. However, included as part of the noise study for Flat-track motorcycle races, Appendix C: *Humboldt County General Plan Pertinent Code*. Unfortunately, Appendix C on the State Clearinghouse website contains no information at all. The page is blank. This would seem to be a serious omission because the rationale for not studying the impacts or adding mitigation measures is missing.

From a conversation with you I understand the exception is found in Section N-S7 on page 13-9 of the General Plan Noise Element. This section addresses exceptions to

short term noise standards. Exception 2 includes: *Temporary events in conformance with an approved Conditional Use Permit.*

The applicant's interpretation of this exception is incorrect for the following reasons.

- a) With any project that may include noise which is controlled by a use permit, it is assumed that proper mitigation measures for the activity have been addressed and reviewed through a CEQA process. Just because the General Plan provides an exception for breaching established noise levels does not eliminate it from CEQA review. The fact that a noise study for monster trucks was not even done is a major flaw in the analysis. The impacts cannot be properly evaluated by either staff, the public or the decision makers.
- b) If monster truck events are considered temporary in nature, why aren't concerts or flat-track races? Under the logic applied by the applicant, any or all activity covered by a use permit could be considered temporary as in short duration and thus qualify for an exemption. Yet the Initial Study does not categorize any of the other activities as temporary. Just the noisiest one. This is an illogical approach.
- c) The use permit being sought is not a series of temporary events. These are annual events assumed to be conducted indefinitely into the future, and that may increase in number or frequency over time with minimal environmental review.
- d) Per the applicant, loud noise from monster trucks "is an essential part of the spectator experience". In this case, an approved use permit would specifically allow a noisy event. The same can be said for motorcycle races. The intent of the exception is hardly to ignore the effects and impacts of events. Instead, it is to make allowances for necessary noise that may temporarily exceed the County's noise limits that result from an approved activity – but not for an activity that is designed by its very nature to have a significant noise impact.

**Comment:** A noise study on the effects and impacts of monster truck and the other listed events is required for analysis and review.

- 2. Under a discussion of noise impacts, the initial Study includes a number of proposed mitigation measures related to motorcycle noise. None include any type of noise barrier to reduce sound leaving the arena. I find it curious that a straw bale wall is proposed for outdoor concerts but not for motorsport events. Of the two, sound attenuation for engine noise would seem more important.

According to the Initial Study on page 30, even with the use of the proposed mitigation measures in combination, the noise will only be reduced to a level of "normally unacceptable". This statement alone indicates that the proposed mitigation measures are not effective enough to meet the standards for a mitigated negative declaration. According to the CEQA Guidelines, a negative declaration is not the correct evaluation tool if there may be significant impacts. That is the role of an environmental impact report.

- NOI-1: It is not entirely clear how stopping events at 10:00 PM reduces the degree of impact as opposed to how long an impact will affect people.
- NOI-2 is the only proposed mitigation measure to attenuate sound levels with a requirement that motorcycles be equipped with mufflers. In a dirt race track setting that is farther away from town and sensitive noise receptors, especially during evening hours, this might prove sufficient to address the issue.

In *Lewis v. 17th District Agricultural Ass'n* (1985) 165 Cal. App. 3d 823, the court found that the existence of residential areas near the county's racetrack constituted "unusual circumstances".<sup>1</sup> According to court records, the Nevada County Fairgrounds, "are contiguous with and less than a mile from several residential areas in Grass Valley and unincorporated Nevada County". The similarity is striking. In that case, the County prepared an EIR to expand existing automobile race events.

- NOI-8. An annual reporting program is not mitigation.
- NOI-3, 6 and 7 are standards but not mitigation measures.

**Comment:** An environmental impact report is needed to better evaluate additional mitigation options that could be effective. To assume that cost prohibitive measures such as a sound wall should not be considered out of hand circumvents the purpose of environmental review and a discussion of options.

3. Also, on page 30 of the Initial Study the use of hay bales to dampen sound as a mitigation measure for concerts is proposed. However, even with this mitigation measure in use, the study concludes that, "This very nearly brings the events into the *"normally acceptable"* range and into the lower end of the *"normally unacceptable"* range". The phrase 'very nearly' is not an engineering term and places the mitigated concert sounds into the range of normally unacceptable.

Again, according to the CEQA Guidelines, a negative declaration is not the correct evaluation tool if there may be significant impacts.

**Comment:** An environmental impact report is needed to better evaluate mitigation options that could be effective.

4. The noise study for flat-track motorcycle races does not consider or evaluate the effects of the grandstand and nearby hills on the direction, distance, and levels of noise that can be expected during the proposed events.

As noted on page 31 of the Initial Study, a two-day monster truck event generated complaint calls from the public. Anecdotal reports from several parts of town indicate that the reflected sound traveled unevenly across town and caused disturbance farther away from the racetrack where the noise study measurements were taken. These

complaints and observations could represent a significant impact, but without a proper noise study, the real-life experience of residents is not being accounted for.

To compare volume levels, public service announcements during the county fair for horse racing activities are low enough that they are not reflected off the hills in the same way the motorized vehicle engine noise is.

**Comment:** A set of more robust noise studies should be required in order to obtain a better picture of how loud events interact with the physical terrain.

5. Page 29 references the following section of the County Noise Element.

“The perception of nuisance will vary based upon sound level, frequency, and fluctuation. It also depends upon the character of the sound, number of noise events, familiarity and predictability, and the attitude of the listener. CNEL and Lmax are typically the basis for making nuisance determinations but other factors may be considered. For example, an annual high school parade may exceed residential noise levels but might not be deemed a nuisance.”

**Comment:** There is a lack of analysis for sound generated by motorcycle engines that are two-stroke compared to four-stroke, or to the interpretation of sound by the listener from a cacophony of multiple engines accelerating and decelerating while at a constant high rate of speed. The sound of dueling monster trucks is not discussed in terms of nuisance consideration.

There is no discussion or analysis on the characteristics of diesel engines or unmuffled monster truck engines in order to address local perceptions of those activities' engine sounds.

The sound of motorsports may be perceived very differently than that coming from concerts. A review of the literature on this will help the public and decision makers determine how likely proposed events may be a nuisance generating public complaints, as opposed to amplified sound that can be more easily accepted.

**Conclusion:** While the noise studies included with the initial study may have been done properly (I am not an expert on this), they are inadequate to demonstrate that a mitigated negative declaration can be approved by the County. A lack of information makes it impossible to fully grasp the degree of change to the environment that will result from approval of this Initial Study and Mitigated Negative Declaration. Additional study is required, and an environmental impact report is the best way to gather a comprehensive understanding of what to expect. With the use of an EIR, the County can choose to issue a statement of overriding considerations, an option not available under a mitigated negative declaration.

Humboldt County Planning Commissioners:

My name is Andrew Aiello. As a resident of Ferndale, I would like to register my support for the Humboldt County Fair Association's Conditional Use Permit, PLN-2019-15519, which authorizes the use of the Humboldt County Fairgrounds for a maximum of ten (10) concerts and four (4) motorized sport events annually that would help generate precious revenue needed to assist in the operation and maintenance of the County Fairgrounds, generate economic activity for businesses in our county, and as increase family-friendly events for our community to participate in.

Since the 2009 economic crash Fair Associations throughout the state have seen significant budgetary cuts, resulting in up to 1000% reductions in revenue. Humboldt County Fair Association was not spared, seeing their annual California Department of Food and Agriculture (CDFA) allocations drop from a high of \$400,000 annually to \$40,000 today. That incredible loss in revenue has necessitated changes to the use of the 65-acre facility to generate its own operating and maintenance budget. While the community has stepped up significantly with sponsorships and donations over the past decade, with rising costs that type of revenue generation is no longer sustainable. Allowing the Fair Association to host a calendar of larger-scale events to supplement the income generated during the annual 10-day August fair would allow for the stand-alone operation of the Association.

Aside from the financial benefits to the Fair Association, these large-scale events would greatly benefit the Humboldt County community, specifically the businesses of Ferndale. Hotels, restaurants, and small businesses would reap the benefit of additional visitors patronizing their establishments on a regular basis during the event season. This prospect of additional revenue for our local businesses is especially enticing in 2020, where the COVID-19 required cancellation of the 10-day Humboldt County Fair will result in a revenue loss of around \$8 million dollars (CDFA, 2016 data) for our county economy.

I moved here in 2016, I currently reside in Ferndale and teach and coach the College of the Redwoods. Allowing the fairgrounds to host these events would have such a positive impact on so many people, businesses, and community as a whole. Creating different opportunities for family entertainment that is at a great location and does not cause too much of an issue for anyone that lives in town. I personally live on main street in Ferndale and am in great support and favor for these events, knowing that there may be some noise, however, I am informed that these events would be over by 10pm (concerts) and the motor sport events would take place during daytime (mostly). These are great events that can create such an important fiscal and

community impact, which, without would truly hurt the community in many different ways. Also, the noise level that would travel from the grounds to the houses would drastically drop when compared from the decibel levels at the grounds to inside someone's household.

Your action here today will allow the Humboldt County Fairgrounds to remain a valuable and viable part of our greater community for generations to come. Thank you for your time and consideration.

**RE: Comments on Initial Study and Proposed Mitigated Negative Declaration for  
Proposed Motorsports and Concert Events at Humboldt County Fairgrounds**

The City of Ferndale has enjoyed a long mutually beneficial relationship with the Humboldt County Fair Association. Whenever there is a Fair event, the City benefits from patrons visiting local restaurants retail venues, and lodging options bringing economic benefits to the community. We strive in the future to do what we can to support the Fair Association in being a sustainable and successful organization.

As the Humboldt County Fairgrounds is located within the City of Ferndale, we appreciate the opportunity to comment on the Initial Study and Proposed Mitigated Negative Declaration (IS/MND) for Proposed Motorsports and Concert Events at the Fairgrounds. The City of Ferndale has reviewed the document and solicited comments from council member as well as public input at the August 19, City Council Meeting. We are not commenting on the pros and cons of the proposed motor sport and concert venues but, rather, the adequacy of the CEQA environmental review process, specifically related to noise. We have summarized the comments below:

The project description indicates that up to four (4) motorsport events are requested as part of the project. However, it is unclear what defines an event. To fully understand the anticipated impacts regarding noise levels, the length of an event should be clearly defined. Is an event a one-day occurrence or if lasting 3 days is that one event or three? Obviously, potential impacts can significantly increase if a single event lasts multiple days or more.

The noise resource setting does not include a discussion of anticipated noise levels for all proposed special permit uses. The setting primarily focuses on flat track motorcycle racing and concerts with only anecdotal evidence provided for monster trucks. Other potential proposed uses which are not discussed in detail include tractor pulls, 4x4 truck events, and Go Karts. What are the noise levels associated with each proposed use both individually (i.e., one monster truck or motorcycle) and cumulatively (six monster trucks or motorcycles)? As these are proposed uses, the setting and analysis should include information and anticipated noise levels for all proposed activities to adequately evaluate potential impacts.

The noise setting also does not clearly state where the referenced sensitive receptors are or how these locations were chosen. To better understand the analysis this information should be

provided. Ferndale High School should also be clearly stated as a sensitive receptor that is located adjacent to the proposed project area.

The environmental setting for the noise section does not address the topographic characteristics of the community setting itself. The Wildcat mountains range forms the southern edge of the City of Ferndale and quickly rises in elevation. Noise from motorsports and concerts will reverberate from this high elevation backdrop and spread across the entire community of Ferndale during the entirety of proposed events. The Noise Study and IS/MND should better describe this topographic setting and describe how noise levels further impacts the entire community not just residences immediately adjacent to the fairground location of the proposed events. The IS/MND should address the impacts of this reverberating noise and the disruptive nature of noise for an extended period on all residences within the community.

Page 29 of the IS/MND environmental checklist states that a project would be significant if “Generation of a substantial temporary or permanent increase in ambient noise levels in the vicinity of the project is in excess of standards established in the local general plan or noise ordinance, or applicable standards of other agencies?” Ensuing discussion reveals that “For flat track racing, unmitigated CNEL values fall into the “clearly unacceptable” range.” Local experience from a monster truck event held at the fairgrounds during the summer of 2017 were much louder and disruptive than the motorcycle racing. Noise levels of monster truck events should be discussed in more detail.

Page 30 of the IS/MND discusses the several potential mitigation measures reviewed in the referenced noise study concluding that “By adhering to one or more of these mitigation measures, the CNEL values associated with these events can be reduced to “normally unacceptable”. The terms “clearly unacceptable” and “normally unacceptable” suggest that significant environmental impacts associated with noise will remain despite the proposed mitigation measures. This conclusion applies to both motorsports and concert events.

One of the mitigation measures for concert events includes the construction of a temporary sound wall using strawbales (NOI-4). However, there are no references provided for construction standards or the effectiveness of such a wall. To better substantiate the mitigation, references should be provided and discussion on effectiveness of straw bales to reduce noise should be included in the CEQA MND.

The second paragraph on IS/MND page 31 states mitigation measure “NOI-5 limits Monster Truck events to one (1) event per year”. However, NOI-5 on page 32 is related to using a sound engineer during concert events. Mitigation measure NOI-6 limits the number of monster truck events to one per year. The IS/MND states “Since noise from monster trucks is essential to the spectator experience, limiting the number of events was the best feasible mitigation available to help control impact. Given the limited number of motorsports events and particular venue characteristics that are needed to host events of this sort, the project is a good candidate for considering an exception to the general plan short term noise standards.” Please provide additional explanation as to how limiting the number of events reduces noise impacts to less than significant.

Lastly, leaving the monitoring and reporting of event(s) compliance with proposed mitigation measures and operational conditions until the end of the year has the potential to expose the community to excessive noise and disruption for an entire season before amendments or further restrictions might be applied to subsequent seasonal events through an adaptive management process. This appears as an untenable situation for many members of the community who are being asked to “cope” with the “clearly unacceptable” and “normally unacceptable” disruption to their lives in the hope that further reduction of noise impacts in the future will be forthcoming.

Even with the proposed mitigation, events are likely to create noise above normally accepted levels (exceeding 60dB) which is likely to be disruptive. Several council members believed that the MND is not the appropriate level of CEQA environmental review for the proposed events spelled out in the Use Permit and MND and that an Environmental Impact Report (EIR) should be prepared. CEQA does not allow approval of projects with significant environmental impacts and the majority of council members felt significant impacts from noise will largely remain unmitigable, and that an EIR should be prepared to provide more detail on noise levels and possible mitigation measures. Additionally, alternatives to the proposed project must also be discussed as part of the EIR process especially alternatives that may result in less significant noise impacts to the community of Ferndale while still providing the Fair Association with more revenue generating events. The City believes additional review and analysis is needed for a project that is controversial within the community with citizens expressing both support and opposition.

The City of Ferndale appreciates the continued relationship between Humboldt County, and the Humboldt County Fair Association. To adequately represent the concerns of residents, we would appreciate your full consideration of the comments provided above.

Dear Mr. Lazar:

This letter is submitted on behalf of Friends of Ferndale for a Livable Community ("Friends of Ferndale"), a nonprofit organization dedicated to preserving the quality of life for Ferndale residents. We have reviewed the Initial Study and Proposed Mitigated Negative Declaration (IS/MND) for Proposed Motorsports and Concert Events at Humboldt County Fairgrounds (the "Fairgrounds"), dated July 24, 2020. Based on our review, we believe that an Environmental Impact Report (EIR) is required for this project because a fair argument exists that the project will have significant impact on the environment in several impact areas. Moreover, the analysis of several impact areas is not supported by substantial evidence and violates the public disclosure requirements of the California Environmental Quality Act (CEQA). The following comments on the IS/MND documentation support our conclusion that an EIR is required for this project and identify defects in the IS/MND's analysis and conclusions.

### **Project Description**

"Only through an accurate view of the project may affected outsiders and public decision-makers balance the proposal's benefit against its environmental cost, consider mitigation measures, assess the advantages of terminating the proposal . . . and weigh other alternatives in the balance. An accurate, stable and finite project description is the sine qua non of an



informative and legally sufficient EIR.”<sup>1</sup> The same accuracy must be provided in the project description for a mitigated negative declaration.<sup>2</sup> In this case, Section 2.3 of the IS/MND does not provide sufficient information to allow the public to fully evaluate the project’s environmental impacts.

The fourteen total events identified in the project description—four motorsports and ten concerts—are apparently inclusive of all such events to be held at the Fairgrounds in a given year. The project description notes that events would be “pre-scheduled between March and October, excepting the six-week period (August 1st through September 15th)” when events associated with the Humboldt County Fair are occurring. However, the IS/MND does not indicate whether additional concerts or similar events would be held during the County Fair. The table identifying prior concerts held at the Fairgrounds on page 7 of the IS/MND identifies several concerts that have been held during the period of time when the County Fair occurs (August-September). Most of these events occurred after CEQA was adopted in 1973. Therefore, unless similar events occurring at the Fairground during the County Fair were studied as part of a prior environmental document under CEQA, then they must also be identified in the project description and analyzed as part of this project. This analysis must be undertaken to avoid a situation where “piecemeal approval of several projects with related impacts could lead to severe environmental harm.”<sup>3</sup> They must also be considered as part of an adequate cumulative impacts analysis.

Furthermore, the length of each of the proposed motorsport and music “events” is not fully defined. While the project description identifies an event’s maximum hours of operation on any given day, it does not address the days of the week when events will be held or whether an event may occur over multiple days. If weekday events are anticipated, then the impacts would be especially borne by students of Ferndale High School given the school’s proximity to the Fairgrounds. Could events occur on weekdays when school is in session or while extra-curricular events are taking place after the school day has ended? Furthermore, it is not clear whether a single music event might encompass a multi-day festival or whether a motorsport event includes practices or qualification races. Could use of the track for casual daytime or nighttime motorcycle practices be permitted when leading up to a scheduled race? The protracted use of the Fairgrounds for these uses must be explained in the project description because they will exacerbate the potential impacts described below.

The IS/MND identifies the following types of motorsports to be permitted as part of the project: “Tractor Pulls, 4x4 Truck events, Go Carts, Monster Trucks, and Motorcycle Racing.”<sup>4</sup> Yet, only motorcycle racing is discussed in any detail. The other motorsports events must contain a description of the operational aspects in order for the project description to be complete. This information is critical to fully inform the public about the expected impacts of the project under CEQA.

Finally, missing from the description of the proposed music events is the stage configuration. The only information about the stage location is that it will be “set up in the interior of the race track on an installed temporary stage placed directly in front of the Grand Stands.”<sup>5</sup> The IS/MND goes on to say that the stage and event configuration will depend on the type of event. The description does not inform the public where the stage and speakers will be directed, and if they will be directed toward sensitive receptors. Unfortunately, as discussed below, the project’s Noise Impact Study Addendum provides no clarification on this issue.

As a result, the project description is not “accurate, stable, and finite,” as required by CEQA.

### **Aesthetics**

The aesthetic impact analysis, and particularly the discussion of light and glare, suffers from fatal flaws and therefore underestimates the impact of light and glare on the residential community surrounding the Fairgrounds. The IS/MND acknowledges that “temporary lighting is commonly incorporated into music events for the purpose of aesthetics and/or stage illumination.”<sup>6</sup> But no such acknowledgment is made for motorsports events, which, when held at night, necessarily require sufficient lighting in order to operate safely. The IS/MND does not attempt to describe the new light sources from motorsports events, including temporary lighting for staging areas and the lights affixed to the vehicles and motorcycles themselves. The IS/MND must fully account for these new, expected light sources.

Mitigation Measure AES-1 does not effectively mitigate the impact caused by temporary lighting. Mitigation Measure AES-1 states: “Temporary stage lighting used during events will be directed towards the ground and north of the stage at intensities low enough to prevent light spillage (illumination of adjacent parcels). To insure that all lighting conforms to this standard,

Humboldt County Fair Association staff shall review the temporary lighting design for each music event.” This mitigation measure suffers from three fatal flaws.

First, as discussed above, motorsports events may contribute to light spillage onto adjacent properties. Yet, Mitigation Measure AES-1 only applies to music events.

Second, the IS/MND’s description of the mitigation measure states that lighting must be at “intensities low enough to prevent the illumination of adjacent parcels.”<sup>7</sup> Does this mean no light spillage onto adjacent parcels will occur? The IS/MND fails to quantify if, and how much, illumination will be tolerated at adjacent parcels and the reduction achieved by Mitigation Measure AES-1.

Finally, Mitigation Measure AES-1 provides no enforcement mechanism to ensure that lighting is directed toward the ground at intensities low enough to prevent the illumination of adjacent parcels. It merely requires the Humboldt County Fair Association to “review the temporary lighting design for each music event.” Neither the Fair Association nor the County will actually approve the lighting plan or verify that it effectively prevents light spillage. The Fair Association need only report to the County that it has “reviewed” temporary lighting. Therefore, Mitigation Measure AES-1 is not tied to a concrete plan of action, and the mitigation is not effective in mitigating the threat of light spillage caused by the project.

### **Air Quality**

The IS/MND’s conclusion that the project will not expose sensitive receptors to substantial pollutant concentrations is fatally flawed because it is unsupported by substantial evidence. The IS/MND acknowledges that the Fairgrounds are bordered by sensitive receptors, such as Ferndale High School and several residential dwellings. Ferndale is an older community with over 37 percent of its population aged 60 and over,<sup>8</sup> meaning that many residents are especially vulnerable to air quality impacts.

Yet, the IS/MND’s only support for its finding that the project will not impact sensitive receptors is a conclusory statement that emissions “are minor, infrequent, and limited in duration” and will “dissipate into the atmosphere before they could expose people working or residing in the

area to substantial pollutants.”<sup>9</sup> This emissions analysis fails to provide any quantification of the project’s impacts. Events could be occurring as much as twelve hours per day within roughly 100 feet of a school and roughly 500 feet of adjacent residences. Therefore, it is probable that adjacent sensitive receptors will be exposed to significant levels of vehicle related air quality pollutants, especially vehicle exhaust from motorsports events.

For similar reasons, the IS/MND’s analysis of project-related odors is woefully inadequate. It fails to account for odors emitted by generators, gasoline, and motorsports in close proximity to several sensitive receptors.

Furthermore, the IS/MND identifies only two potential sources of air quality impacts: automobile exhaust from event attendees and flat track motorcycles. The IS/MND does not account for emissions caused by concert events and, more significantly, emissions from monster trucks and other types of motorsports. Therefore, the IS/MND underestimates the amount of project-related emissions.

The North Coast Unified Air Quality Management District (the “Air District”) is in non-attainment for the 24-hour standard for particulate matter of 10 microns or less (PM<sub>10</sub>). The IS/MND states that fugitive emissions as a result of vehicular traffic on unpaved roadways “are the largest source of particulate matter” within the Air District.<sup>10</sup> In its analysis of Air Quality impacts, the IS/MND acknowledges that the Air District “has not formally adopted significance thresholds” for the purpose of analyzing a project’s impact on PM<sub>10</sub>.<sup>11</sup> Instead, according to the IS/MND, it utilizes the Best Available Control Technology emission rates listed in the Air District’s Rule 110. Rule 110 only applies to stationary sources. As a result, the IS/MND implicitly acknowledges that the project’s air quality impacts are not measured against any applicable threshold of significance. It simply concludes that the project is consistent with the Air District’s PM<sub>10</sub> attainment plan because the project does not involve the operation of stationary sources. This analysis is incomplete.

Air District Rule 104.C includes a standard applicable to general combustion sources that should be applied to the project. It prohibits “any person from discharging particulate matter into the atmosphere from any combustion source in excess of 0.46 grams per standard cubic meter . . . calculated to 12 percent carbon dioxide” and certain other limitations set forth in the Rule.<sup>12</sup> Absent further analysis to quantify project-related air quality emissions, the IS/MND’s

conclusion that the project will not have a significant impact on air quality is not supported by substantial evidence. In sum, the IS/MND's air quality analysis is insufficient, and the project has the potential to result in unmitigable cumulative air quality impacts.

### **Energy**

The IS/MND's conclusory analysis of energy resources, particularly the wasteful, inefficient, or unnecessary consumption of energy resources, is deficient. It fails to acknowledge the substantial amount of fuel expected to be consumed during motorsports events and music events, let alone quantify the amount. That the Fairground currently has facilities capable of powering events is not a sufficient substitute for the critical evaluation of a project's energy consumption required by CEQA.

### **Greenhouse Gas Emissions**

The IS/MND's analysis of greenhouse gas (GHG) emissions underestimates the range of sources of potential GHG emissions created by the project. In addition to passenger vehicles travelling to events, the IS/MND also states that flat track racing motorcycles would produce GHG emissions. But there are other sources of GHG emissions generated from trucks and other vehicles participating in the project's other motorsports events. In addition, we assume that gas-powered generators will be used as part of the temporary staging for music events. As a result, the IS/MND's analysis of GHG impacts is incomplete and not supported by substantial evidence.

### **Hazards and Hazardous Substances**

The IS/MND summarily concludes that the project does not involve the emission or handling of hazardous materials and substances within one-quarter mile of an existing school, even though the Fairgrounds are located adjacent to Ferndale High School. The proposed motorsports events at the Fairgrounds, especially the monster truck events, will require the storage and handling of large quantities of gasoline. In some cases, high octane racing fuel may be used. Under provisions of California law, petroleum and oil products are considered hazardous substances.<sup>13</sup> Therefore, the project has the potential to cause a significant and unavoidable impact involving the emission or handling of hazardous substances within one-quarter mile of an existing school. This constitutes a significant and unavoidable impact that must be fully evaluated in an EIR.

### **Land Use and Planning**

As a preliminary matter, the MND asserts that “activities at the site are exempt from the city [of Ferndale]’s zoning and land use regulations.”<sup>14</sup> To support this conclusion, the MND cites to the Third District Court of Appeal’s opinion in *Lawler v. City of Redding*, but with no explanation as to how and why that case applies to the Project.<sup>15</sup> The *Lawler* case recognizes the principle that, pursuant to Government Code Sections 53090 and 53091, cities and counties enjoy an intergovernmental immunity with respect to building and zoning regulations, including their respective general plans.<sup>16</sup> In the typical case, for example, a city zoning regulation would not apply to county-owned land within the city’s limits, and vice versa. But intergovernmental immunity is not unlimited and should not constrain the analysis of a project’s environmental impacts under CEQA.

Humboldt County may only confer its immunity from City zoning regulations via a lease to a private party, such as the Humboldt County Fair Association or an event promoter, for the purpose of conducting a county fair and related activities. The California Attorney General has concluded that a county’s immunity does not extend to purely private uses.<sup>17</sup> This is especially true if the purpose of the proposed project is merely to generate revenue for the Association or a concert promoter. In this case, the specific purpose of this project is to permit motorsport and concert events outside of the six-week period in August and September when the Humboldt County Fair occurs.

As a result, the Humboldt County Fair Association bears the burden of proving that its use of the Fairgrounds for motorsport and concert events—outside of the County Fair dates—qualifies for the County’s immunity from City building and zoning regulations. The IS/MND provides no evidence to support its conclusion that the City of Ferndale’s zoning regulations do not apply to the proposed project.

Nevertheless, the IS/MND endeavors to analyze the project’s consistency with the Ferndale General Plan Land Use Element and Zoning Ordinance, as it should. These planning documents constitute plans and regulations adopted for the purpose of avoiding or mitigating an environmental effect. The project site is zoned as Public Facility (PF) in the Ferndale Zoning Ordinance, which permits “public fairgrounds and related uses.”<sup>18</sup> However, the PF zone provides no indication that such “related uses” would include “concert venues” or “automobile

racetracks.” Indeed, Section 7.05 of the Ferndale Zoning Ordinance specifically states that “no open-air . . . theater, automobile racetrack, . . . or similar assemblage of people and automobiles shall be permitted in any zone unless a use permit is first secured in each case.” Thus, even if these uses were related to the Fairgrounds, they are not permitted by right. The City recognizes that such assembly uses must be conditioned to mitigate their impacts through the issuance of a use permit. As a result, the IS/MND’s conclusion that the project is “consistent with the uses allowed in the public facility zoning designation as a public Fairgrounds related use” is incorrect. The project would cause a significant and unavoidable conflict with a land use plan intended to avoid or mitigate environmental effects.

Even assuming that the project is immune from the City’s building and zoning regulations, the IS/MND makes no attempt to determine whether the project is consistent with any applicable County land use plan policy or regulation, including its general plan and zoning ordinance adopted for the purpose of avoiding or mitigating environmental effects. Friends of Ferndale believes that the proposed project is inconsistent with the following goals and policies of the County general plan:

- Noise Element Goal N-G1. Excessive Noise. A quiet and healthful environment with limited disagreeable noise. N-G2. Incompatible Land Uses. Land uses arranged to reduce annoyance and complaints and minimize the exposure of community residents to excessive noise.
- Noise Element Policy N-P1. Minimize Noise from Stationary and Mobile Sources. Minimize stationary noise sources and noise emanating from temporary activities by applying appropriate standards for average and short-term noise levels during permit review and subsequent monitoring.
- Noise Policy N-P2. Guide to Land Use Planning. Evaluate current noise levels and mitigate projected noise levels when making community planning and zoning decisions to minimize the exposure of community residents to nuisance noise levels. Minimize vehicular and aircraft noise exposure by planning land uses compatible with transportation corridors and airports, and applying noise attenuation designs and construction standards. Avoid zoning patterns that permit people to “move to the nuisance” unless mitigated through project conditions or recorded notice.
- Noise Policy N-P4. Protection from Excessive Noise. Protect persons from existing or future excessive levels of noise which interfere with sleep, communication, relaxation, health or legally permitted use of property.



- Noise Standard N-S3. Environmental Review Process. For noise sensitive locations where noise contours do not exist, the environmental review process required by the California Environmental Quality Act shall be utilized to generate the required analysis and determine the appropriate mitigation per Plan and state standards. Future noise levels shall be predicted for a period of at least 10 years from the time of building permit application.
- Economic Development Goal ED-G4. Cooperation and Collaboration. Productive partnerships with cities, neighboring counties, and the private sector that build and enhance common assets and resolve common obstacles.
- Conservation and Open Space Goal CO-G6 Community Separation. Open space areas between urban development areas that separate and preserve unique identities of the county's cities and communities.
- Conservation and Open Space Policy CO-P6. Community Separation. Maintain separation of urbanized communities through appropriate land use designations and zoning density. Avoid merging urban development boundaries of adjacent communities.
- Conservation and Open Space Policy CO-P8. Planning for Recreational Needs within Communities. Policies addressing community recreational needs shall be prepared as part of planning efforts within each community. Implement park in-lieu fee programs in major communities.

This list of conflicting goals and policies of the County general plan is not intended to be exhaustive, but is illustrative of the careful consideration of the project's consistency with land use plans required under CEQA. A similar consistency analysis should be conducted for the City's general plan. In sum, the IS/MND's conclusion that the project is consistent with the City's and County's zoning and general plans is not supported by substantial evidence because all relevant policies and regulations have not been considered.

## **Noise**

Friends of Ferndale is especially concerned about the noise impact caused by the fourteen proposed concert and motorsport events at the Fairgrounds, given the Fairgrounds' proximity to the adjacent high school and nearby residential uses. It is clear from the IS/MND's noise impact studies that the noise generated by both motorsport and concert events will be

normally unacceptable, even with the proposed mitigation.<sup>19</sup> Due to the surrounding terrain in and around the Fairgrounds, we expect that noise will reflect off of the grandstands and nearby hills in a way that has not been fully addressed in the IS/MND. This finding alone calls for greater scrutiny and consideration of the project's noise impacts through the preparation of an EIR. Furthermore, there are serious questions about the effectiveness of the proposed mitigation measures. For example, are hay bales an effective form of sound mitigation and can they be erected at a sufficient scale to shield all sensitive receptors from loud nighttime music? If so, why is a similar physical barrier not proposed as mitigation for the motorsport events? At minimum, sound walls that achieve a high-level of noise attenuation should be considered as feasible mitigation measures. Late night event noise will have an especially significant impact on Ferndale's older population that calls for implementing all feasible mitigation.

As demonstrated by the attached "Review of Noise Impact Study for Humboldt County Fairgrounds" (the "Noise Review") prepared by Noise Monitoring Services, the IS/MND's noise studies do not fully account for the full range of noise generated by the events and, furthermore, the mitigation measures are inadequate to reduce noise levels below the thresholds of significance. The Noise Review finds that the IS/MND contains no analysis of the potential noise impacts caused by motorsport events, other than motorcycles. This is especially concerning with respect to monster trucks, given that the IS/MND's only attempt to quantify truck noise derives from a local newspaper story that found the sounds levels were between 80-95 decibels and well above the threshold of significance.<sup>20</sup> The Noise Review's expert opinion provided by the Noise Review provides substantial evidence that the proposed project will have a significant and potentially unmitigable noise impact.

### **Public Services**

The IS/MND states that "[t]here is no reason to expect that authorizing use of the Fairgrounds for additional events would result in a significant increase in demand for public services."<sup>21</sup> This conclusion is not supported by any evidence, and Friends of Ferndale believes that the project will very likely result in an increased demand for fire and police services. The mere fact that the Fairgrounds regularly hosts public gatherings during the annual County Fair does not excuse an evaluation of public resources required to host fourteen additional events with up to 10,000 attendees each. Security and police services are necessary to safely control crowds of that size. And, fire and paramedic resources must be on site in order to conduct safe motorsport events. As a result, the project has the potential to cause a significant effect on public services.

### **Transportation/Traffic**

Under the recently revised CEQA Guidelines, a project's traffic impacts are now evaluated based on "vehicle miles travelled" or VMT attributable to a project.<sup>22</sup> Lead agencies were required to begin implementing VMT methodologies as of July 1, 2020. However, as acknowledged in the IS/MND, Humboldt County has not yet adopted local guidance for evaluating VMT impacts. As a result, the IS/MND utilizes a qualitative analysis to measure project-related VMT.

Although the CEQA Guidelines authorize a qualitative analysis where an existing model or method is unavailable,<sup>23</sup> we do not believe this exception was intended to address situations where the only limitation is a lead agency's failure to adopt VMT thresholds by the July 1st deadline. Lead agencies across the state have adopted ad hoc quantitative methodologies in order to analyze traffic impacts pending final approval of their own VMT guidance. In this case, we see no reason why the project's VMT could not be fairly estimated through a quantitative model based on anticipated event attendance and estimated trips from population centers throughout the County.

Moreover, the qualitative analysis provided in the IS/MND is flawed. The analysis provides no baseline of existing conditions against which to measure the project's VMT increase. It merely provides one example of an equivalent facility within the County, the Redwood Acres facility in Eureka. The IS/MND does not compare the project against baseline conditions. Unless a qualitative analysis of VMT is conducted, the public and decision-makers will have no feasible way to estimate the increase in traffic caused by the additional fourteen events at the Fairgrounds.

### **Mandatory Findings of Significance**

The project may have impacts that are individually limited but cumulatively considerable, meaning that incremental effects of the project are considerable when viewed in connection with the effects of past projects, other current projects, and probable future projects. Fourteen additional music and motorsports events will be held at the Fairgrounds, in addition to other events held historically held at the Fairgrounds throughout the year and the annual County Fair in August and September. The IS/MND does not indicate whether those other events at the Fairgrounds have been evaluated under CEQA. An adequate analysis of cumulative impacts

would consider the added impacts of this project in conjunction with the other Fairground events. The IS/MND fails to provide this required analysis. As such, the cumulative impacts analysis is flawed and an EIR should be prepared to analyze such impacts.

### **Conclusion**

“CEQA requires the preparation of an EIR whenever substantial evidence supports a fair argument that a [project] will cause potentially significant adverse environmental impacts.”<sup>24</sup> California courts view the “fair argument” as a very low threshold for requiring the preparation of an EIR.<sup>25</sup>

Based on the foregoing, a fair argument exists that the project will have significant effects on the environment in the areas of Aesthetics, Air Quality, GHG, Hazards and Hazardous Substances, Land Use and Planning, Noise, Public Services, and Transportation/Traffic. Friends of Ferndale has provided substantial evidence that the proposed project will have potentially significant impacts. We have also identified areas where the mitigations set forth in the IS/MND are insufficient to insure that all impacts will be mitigated to less than significant levels. Finally, we have identified areas where adequate analysis has not been completed, and must be completed in order to comply with CEQA’s policies regarding full disclosure of potential impacts. In sum, the expanded use of the Fairgrounds for music and motorsport events will most likely have a significant effect on the adjacent high school and residents living several hundred feet away.<sup>26</sup>

Friends of Ferndale appreciates the opportunity to comment on the IS/MND because it views the fourteen events proposed by this project as a potential “gateway” to even more intensive uses of the Fairgrounds over time. Once a new baseline of fourteen events is established, the County may view each new additional event thereafter as a minor incremental change. From a CEQA perspective, this could mean that future additions are not subject to environmental review. Thus, it is important that this initial proposal be fully evaluated under CEQA so that the public has a complete picture of the impacts proposed by music and motorsport events at the Fairgrounds.

Given the significance of this project, Friends of Ferndale respectfully requests a continuance of the Planning Commission's consideration of the conditional use permit and IS/MND so that it has sufficient time to carefully consider these comments and those submitted by others. To be sure, a mere reduction in the number of events should not be considered as a means to expeditiously mitigate impacts. Each proposed event will cause impacts that must be fully analyzed under CEQA.

Should the County wish to pursue this challenging project further, an EIR must be prepared in accordance with the public participation and public disclosure purposes underlying CEQA. If the County approves the conditional use permit and lease amendment with the Humboldt County Fair Association without preparing an EIR or significantly reducing the project's scope, then Friends of Ferndale will have no choice but to explore potential legal options to protect the neighboring community from this project's significant environmental impacts.

Dear Mr. Ghirelli,

As requested, we have reviewed the *Noise Impact Study: Flat Track Racing at Humboldt County Fairgrounds* (August 2018) and the *Noise Study Addendum: Open Air Concerts Rev 2* (February 11, 2020), prepared by Whitchurch Engineering.

The noise impact study and its addendum concern the increased use of the venue for motorsports events and concerts, which are proposed to be held between March and October outside of the 6-week period in August and September associated with the Humboldt County Fair setup, operation, and cleanup. It is proposed that up to four motorsports events and ten concerts will be held at the venue each year excepting the six-week period August 1<sup>st</sup> through September 15<sup>th</sup>. The motorsports events will generally involve motorcycle racing. However, one of the motorsport events each year may include monster trucks and the mitigated negative declaration's project description identifies tractor pulls, 4x4 truck events, and go carts as other possible events.

The nearest sensitive receptors are residences within the City of Ferndale on Arlington Avenue, Main Street and Van Ness Avenue; a school on Main Street; and residences in unincorporated Humboldt County on Van Ness Avenue.

On reviewing the Whitchurch noise study, we conclude it contains several omissions and unrealistic assumptions that lead to misleading conclusions. Ambient noise levels have not been adequately documented. The declaration document contradicts the conclusions of the noise study, which indicates that noise levels will exceed the County's noise standards even when mitigation is incorporated. The study also contains estimates of interior noise levels that are based on unrealistic assumptions. These issues are explained in more detail below.

## Noise Standards

Although the project site is located within the City of Ferndale, according to the noise study the noise standards that apply to the project are those contained in the Humboldt General Plan.

The Humboldt County General Plan contains noise standards that apply at interior and exterior areas of sensitive uses. For residential properties, an exterior Community Noise Equivalent Level (CNEL) of up to 60 dBA is considered 'normally acceptable'. CNEL's are calculated by averaging the sound level over a period of 24 hours after applying a correction to the evening and nighttime noise levels to account for the increased sensitivity to noise during these periods. The required interior CNEL in habitable rooms is 45 dBA.

The General Plan also contains short-term performance standards for various land uses. These performance standards are provided as maximum noise levels (Lmax). For residential uses, the Lmax may not exceed 65 dBA during the daytime hours (6 am to 10 pm) or 60 dBA during the nighttime hours (10 pm to 6 am). These short-term standards do not apply to temporary events in conformance with an approved Conditional Use Permit

When a discretionary project has the potential to generate noise levels in excess of the General Plan standards, a noise study is required to assure compliance with the standards. The noise study must include measured or modeled CNEL's and Lmax levels at property lines and receptor locations.

## Ambient Sound Levels

As part of the noise study, Whitchurch obtained ambient measurements at one location during two 2-hour daytime periods. The measurements were obtained between 8 am and 10 am, and between 2 pm and 4 pm on Thursday, June 21 and Friday, June 22, 2018 at a location south of the site on Arlington Avenue. These measurements were used to estimate the ambient 24-hour CNEL at this location. The reports states that the primary sources of ambient noise were traffic on Arlington Avenue and residential noise sources, including mowers and power tools.

In our opinion, these measurements are inadequate to document existing ambient noise conditions in the project vicinity. A single measurement location cannot represent the range of noise levels that will be present in the area. This noise measurement was obtained at the residential property line closest to the road. It would be expected that properties on other roads in the area will be exposed to different ambient noise levels. Furthermore, the method used to estimate the CNEL from the short-term measurement is unlikely to lead to a reliable estimate. Whitchurch has estimated the ambient CNEL by assuming that the noise levels measured during the brief measurements would be constant throughout a 24-hour period. In reality, traffic noise is invariably much quieter during the nighttime hours. It is safe to assume that there would also be minimal noise from residential sources at night. These factors have not been accounted for in the study's CNEL estimates. The estimated ambient CNEL's have therefore almost certainly been significantly overestimated. It should also be noted that the measurements were obtained on weekdays, when traffic patterns may be different to weekend days when ambient noise may be lower.

In any environmental noise study, it is important to document the existing ambient noise levels. To properly document ambient sound levels, 24-hour sound measurements should be obtained at a selection of sensitive receptors in the area that are potentially impacted by the project. The measurement program



should include sensitive receptors in quieter areas located away from roads to ensure that worst-case (lowest) ambient noise levels are documented. The CNEL levels should be directly measured and should not be estimated from brief measurements. If the proposed events at the facility are to be held at weekends then the ambient measurements should be obtained on weekend days. Until these measurements are performed, it is not possible to comprehensively assess the project's noise impact by comparing motorsports and concert noise levels against the existing ambient noise levels.

Due to the frequency and ongoing nature of the proposed events, the project should be treated as one that will result in a permanent increase in ambient noise. In our experience, a common approach to minimizing the impact of this type of project is to limit the noise to below the existing ambient sound level. This approach ensures the project noise never increases the overall noise level by more than 3 dBA, which is considered a 'barely perceptible' increase.

## **Motorsport Event Assessment**

The Whitchurch report includes estimates of interior and exterior noise levels at the nearby sensitive receptors during motorcycle racing events. The estimated noise levels are derived from actual motorcycle racing event noise at the track. No analysis is presented for monster truck events or other possible motorsports events. In our opinion the estimated unmitigated noise levels of 93.4 dBA Lmax and 77.4 dBA CNEL at the receptors on Arlington Avenue, and 93.7 dBA Lmax and 75.7 dBA CNEL at the receptors on Highway 211 have been calculated appropriately and are valid. The report includes estimated mitigated noise levels based on reduced hours of racing, reduced number of racers and mitigated motorcycle exhaust systems. It is noted that even with all possible mitigation measures (ie. the shortest racing duration, fewest number of racers and maximum exhaust mitigation) the estimated noise levels still exceed the County's general plan standard of 60 dBA CNEL at sensitive receptors. This undermines the 'Less than significant impact with mitigation incorporated' declaration in the Initial Study and Proposed Mitigated Negative Declaration. Mitigated Lmax levels have not been fully addressed in the report (presumably to avoid having to declare a significant impact). However, based on the information contained in the report, it may be concluded that fully mitigated motorcycle racing events will produce noise levels up to 80 dBA at the nearest residences. They will therefore exceed County's exterior daytime Lmax limit of 65 dBA by as much as 15 dBA. As previously stated, a comparison of the motorsport event noise levels against the existing ambient sound levels is absent from the noise study. The absence of any analysis for monster truck events and other motorsport events means that noise due to motorsport events has not been fully assessed.

Section 4.4.2 of the Whitchurch study states that interior noise levels at nearby residences will be between 14.4 dB and 53.4 dB during peak, intermittent events. This estimate is based on applying a 40 dB correction to the estimated exterior Lmax noise levels to account for the noise reduction of the building walls. The study references Gypsum Association's *"Fire Resistance Design Manual and Sound Control: GA-600-2006"* as a source of this information. Our review of this document indicates it contains no such guidance. Furthermore, multiple sources indicate this assumption is unrealistic for wood-framed

residential structures. Commonly quoted noise reductions for residential wood-frame buildings are 20 to 25 dB of reduction. Sources that quote this exterior-to-interior reduction include the Caltrans *Technical Noise Supplement to the Traffic Noise Analysis Protocol* (2013) and the FHWA *Highway Traffic Noise: Analysis and Abatement Guidance* (2011).

These documents indicate that exterior-to-interior noise reductions above 30 dB may be achieved with masonry walls, or buildings with curtain walls. Since many of the buildings close to the site are older wood-frame structures, a suitable assumption for their exterior-to-interior noise reduction is 20 dB. The actual interior noise levels are likely to be 20 dBA higher than stated in the Whitchurch report. Based on an assumed exterior-to-interior sound reduction of 20 dB, the interior noise levels will exceed the County's interior noise limit of 45 dBA CNEL for any scenario where the exterior level exceeds 65 dBA CNEL. Most of the mitigated scenarios presented in Table 8 of the Whitchurch report will therefore result in an exceedance of the interior noise limits.

## Concert Assessment

The Whitchurch noise study addendum assesses the noise impact of concerts using reference concert sound level data as a basis. Concerts may begin between 6 pm and 7 pm, and end between 10 pm and 10:30 pm. The report indicates that unmitigated noise levels will significantly exceed the County's CNEL and Lmax noise standards for residential properties. The study proposes a combination of reduced concert durations, sound walls and concert sound monitoring to reduce noise levels at sensitive receptors. The study provides anticipated noise reductions due to the sound wall of between 18.2 and 21.6 dB. In our experience in designing acoustical barriers, reductions this high are rare. The actual reduction will be dependent on the frequency spectrum of the source, the source and barrier heights, and the distances from the source to the barrier and the barrier to the receptor. It is not clear how Whitchurch have calculated the expected barrier performance. However, we would recommend a full 3D sound modeling study to determine the actual barrier performance. This will enable noise maps to be produced showing how the sound will spread into the community and aid in the decision-making process.


The issues with the assessment of concerts are broadly the same as those discussed above for motorsports events. The study indicates that even with a fully mitigated concert event, the noise levels will still exceed the County's CNEL noise standard of 60 dBA CNEL. The study does not address compliance with the County's Lmax noise standards (and in fact provides some evidence that this standard will be significantly exceeded). The study does not address concert noise levels relative to ambient sound levels (as noted above, ambient sound levels have not been adequately documented and a comprehensive assessment is not currently possible). The concert analysis again assumes an unrealistic exterior-to-interior noise reduction of 40 dBA, and is likely underestimating interior noise levels by about 20 dBA.

## Summary

In summary, the Whitchurch noise study is deficient in multiple areas. These are:

- Ambient sound levels in the community have not been adequately documented. The ambient sound levels stated in the report are highly likely to have been overestimated due to unrealistic assumptions concerning noise made by traffic throughout the day. The report does not propose a threshold of significance, or assess motorsports noise or concert noise against existing ambient sound levels.
- The 'Less than significant impact with mitigation incorporated' declaration in the Initial Study and Proposed Mitigated Negative Declaration contradicts the analysis in the noise study, which shows that motorsports event and concert noise levels will exceed the County's General Plan CNEL noise standards. The noise study fails to properly analyze the motorsports event and concert Lmax noise levels. However, it provides enough evidence to indicate that the County's exterior Lmax noise standard will be significantly exceeded.
- The study fails to address the noise levels or the impacts produced by monster truck events or other possible motorsport events.
- The study makes unrealistic and unjustified assumptions concerning the exterior-to-interior noise reduction that will be achieved by the nearby residential structures. When this is corrected for, the data in the study indicates exceedances of the County's interior noise standards during both motorsports events and concerts.
