HONEYDEW RANCH MITIGATION MEASURES

- 1) Reduce proposed 6 acres of mixed light cultivation to the following:
 From 3.17 acres of Mixed-Light cultivation to 1.56 acres of outdoor cultivation; for a
 combined total of 4.73 acres of cultivation (RRR projects that currently hold an interim
 permit with Humboldt County and are planned to move to Honeydew Ranch).
- 2) Mixed-Light Cultivation lighting plan is the following: 24/200-watt ceramic bulbs will be used per 6,800 SF of greenhouse structure. [4800 watts per 6800 SF = .705 watts per SF]
- 3) Outdoor Cultivation will be cultivated in Agricultural Exempt metal frame greenhouse structures.
- 4) Quarterly Water Monitoring Reports for water use will be recorded.
- 5) Proposed 10,000 SF two story processing building will be reduced to a 5,000 SF single story building used for drying and curing (Local contracts drafted for off-site processing).
- 6) Road Association has been developed and will be Maintained by local Honeydew contractor Bill Etters.
- 7) Non-profit organization has been developed for the Honeydew area for local fire suppression, stream and salmon restoration, and youth development (\$20,000 has been deposited for local grants).
- 8) Native Planting plan is being developed by Local Restoration Expert Hugh Mcgee to reduce the noise and create visual aesthetics for neighboring properties.
