RECOMMENDATION(S):

That the Board of Supervisors adopts the attached Resolution amending Resolution 82-170 and rescinding Resolution 13-64 in regards to changes in office hours for Agriculture, County Administrative Office, District Attorney, Library and Public Defender.

SOURCE OF FUNDING:

Library, Information Technology, Economic Development and General Fund

DISCUSSION:

Pursuant to Government Code Section 24260, "County officers shall keep their offices open for the transaction of business during such hours and on such days as are fixed by the Board of Supervisors by ordinance or resolution."

The schedule of office hours for county departments was last revised and adopted by the Board via Resolution No. 13-64 on August 27, 2013. The following modifications are needed to reflect changes in open hours, organizational restructuring, and new offices.

Changes in office hours are being requested for Agriculture, County Administrative Office, District Attorney, and Public Defender. The changes are proposed to be effective immediately.

The Agriculture Department has adjusted hours as follows:

Monday – Friday 8 a.m. - noon/1 - 5 p.m.

The hours currently listed in the resolution are Monday through Friday 8:30 a.m. - noon/1 - 5 p.m. This change results in the office being open an additional half hour in the mornings.

The County Administrative Office has changed hours as follows:

Economic Development

Monday – Friday 9 a.m. - 5 p.m.

Information Technology

Monday – Friday 7 a.m. - 5:30 p.m.

The hours currently listed in the resolution for Economic Development are Monday-Friday 9 a.m. - noon/1 - 5 p.m. Economic Development is located in the Prosperity Center with other non-County offices. The hours posted for the Prosperity Center are 9 a.m. to 5 p.m. This change reflects that the office is open to the public during the lunch hour. The hours currently listed in the resolution for Information Technology (IT) are Monday-Friday 6 a.m. - 6 p.m. IT is reducing hours, and it will now be open one hour later in the morning and close a half hour earlier in the evening. Based on help desk logs there are limited calls during these hours and the change will make shift scheduling more efficient.

The District Attorney has increased hours as follows:

Criminal Division

Monday – Friday 8 a.m. - noon/1 - 4:00 p.m.

The hours currently listed in the resolution are Monday through Thursday 9 a.m. - noon/1 - 4 p.m. and by appointment on Friday. The Criminal Division will now be open one hour earlier and on Fridays. The District Attorney is increasing office hours to provide better access for the public and to address community needs in a timelier manner.

The Public Defender has modified hours as follows:

Conflict Counsel

Monday – Thursday 8:30 a.m. - noon/1 - 5 p.m. Friday 8:30 a.m. - noon/1 - 2 p.m.

The hours currently listed in the resolution for Conflict Counsel are Monday through Friday 8:30 a.m. – noon/1 - 5 p.m. Conflict Counsel is requesting to decrease hours; they will be closed to the public three hours earlier on Fridays. This will provide staff time to conduct trainings and catch up on obligations and should allow the office to be more productive and efficient. The office will be available by appointment from 2-5 p.m. on Fridays.

The Library is requesting multiple changes in the scheduled visits by the bookmobile effective March 1, 2015 (see attachments 2 and 3). The primary changes are three additional days of service. The Library would like to provide a new location to the bookmobile schedule by adding a first Thursday of each month run to the Loleta area. New stops at Loleta Elementary School and the Table Bluff Reservation will be part of this service. The Mattole Valley and Orleans areas will also each get one additional day of service. Currently one run to each of these areas occurs per month. In fiscal year 2009-10 the Library reduced the scheduled stops of the bookmobile in order to reduce expenses. At this time the Library has determined that additional bookmobile stops can be provided and would enhance services to underserved areas of the county.

FINANCIAL IMPACT:

The requested office hours changes for Agriculture, County Administrative Office, District Attorney, and Public Defender have no financial impact. The proposed modifications to the bookmobile schedule are anticipated to cost approximately \$6,500 annually.

The requested action supports the Board's Strategic Framework by providing community-appropriate levels of service and managing resources to ensure sustainability of services.

OTHER AGENCY INVOLVEMENT:

None.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could choose not to adopt the resolution to change office hours. This alternative is not recommended because the resolution is needed to authorize changes in open hours and bookmobile service.
