We currently have a petition circulating, with over 200 signers and counting, asking that you, the board of supervisors of Humboldt county, adopt a policy as soon as possible to regulate 5G technology as it arrives in our area. 5G technology is already being installed in our midst, as you must be aware. This new short wave technology emits at least ten times the amount of radiation that our current 3G and 4G towers do. To function fully, 5G towers will have to be installed much closer together than the older technology. Old policies to regulate older cell technology will not suffice in protecting us from this new technology. We need a new policy to regulate 5G.

We are already inundated with excessive amounts of radiation through cell phones, wifi, and other "smart" technology. Having 5G facilities lining our streets will make this next level of radiation completely inescapable. We deserve informed consent. The entire county of Marin has banned these 5G small cell facilities from all residential areas, and from mixed use areas as well. They have put in place an application process which helps to regulate when, where, and how this 5G technology is installed in their communities. **Why does Humboldt county not have such a policy yet?** I realize you are all quite busy, however this is a matter of protecting your land and people, and all lifeforms

existing here. It is an issue of health and safety. You cannot say you have done your best to protect us if you have not at least adopted such a policy to make an attempt to regulate big tech and big business from destroying our home.

5G technology is far more risk and danger than it is beneficial. It will serve only the interest of large corporations and big tech. I do believe if we were more informed on this issue, nobody would say they will take radiation exposure for the sake of having faster streaming internet. It is just not necessary for the well-being of the majority of the people or the planet. If we are a progressive and environmentally-minded community, then we will do our best to keep 5G out.

I have submitted a copy of Marin's policy, as well as a few links which can be followed to access scientific studies, as well as information about other 5G regulation efforts being made throughout the world. Please take the time to check them out and get this item on your agenda. Adopt a policy. I implore you to do your research and to do your very best to protect your people. Thank you.

Hello, my name is Holly Clancy, I am a mother of four children, and I am a student of the College of Redwoods Agriculture program, a herbalist and holistic body worker. Many residents of Humboldt county are concerned about 5G-enabled small cell wireless antennas being deployed in our community. We currently have a petition circulating, with over 300 signers and counting, asking that you, the board of supervisors of Humboldt county, adopt a policy as soon as possible to regulate 5G technology as it arrives in our area. The FCC's public human radio frequency (RF) microwave radiation ("wireless radiation") general public exposure limits were adopted over 24 years ago and fail to consider the widely documented adverse biological effects associated with exposure to wireless radiation, the same type of radiation emitted by 5G wireless antennas and devices. Members of the scientific community are not the only ones waiving a red flag when it comes to 5G. Swiss Re, the second-largest reinsurance company in the world, classified 5G as a "high impact" liability risk in its 2019 SONAR New Emerging Risks report due to health risks, and research suggests that small cell antenna installations near residences could reduce property values by up to 20% or more. It is vital that [insert name of your city/town/village] adopt a strong legislative code to protect our community from 5G antenna installations, particularly near our homes and schools, to the fullest extent possible under the law. To that end, I am attaching a sample 5G small cell ordinance to this email for your review.
