RESOLUTION NO. 21-16

RESOLUTION AUTHORIZING THE REVOLVING PETTY CASH FUND FOR USE BY THE HUMBOLDT COUNTY SHERIFF'S OFFICE ADMINISTRATION

WHEREAS, Sections 29320 et seq. of the Government Code authorizes the Board of Supervisors to establish revolving funds for use of any officer of the county; and

WHEREAS, the Humboldt County Sheriff's Office Administration has a revolving fund, in the amount of One Thousand Thirty Dollars (\$1,030.00) for use by the Sheriff and/or his delegated administration staff in the event of an urgent situation requiring cash and has requested an increase of Nine Hundred Seventy Dollars (\$970.00) bringing the total amount of their revolving fund to Two Thousand Dollars (\$2,000.00).

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:


1. That the County of Humboldt authorizes this revolving fund in the amount of Two Thousand (\$2,000.00) in accordance with the terms and conditions set forth above and subject to the provisions of Section 29320 et. seq. of the Government Code.
2. That this Resolution shall supersede any prior resolutions related to the Humboldt County Sheriff's Office Administration revolving fund.
3. That the Clerk of the Board of Supervisors shall transmit certified copies of the Resolution to the Auditor and Treasurer for the County of Humboldt pursuant to Government Code 29322.
4. This resolution is effective immediately.
