**AUTHORIZING THE CHAPTER 8 SALE OF A TAX-DEFAULTED PROPERTY TO THE CITY OF EUREKA**

**WHEREAS**, the Humboldt County Tax Collector received Resolution 2021-02 from the City of Eureka (City) objecting to the sale of one tax-defaulted property, APN: 007-112-001-000, within the boundaries of the City;

**WHEREAS**, the City submitted an 'Application to Purchase Tax Defaulted Property from County' for acquiring this tax-defaulted property within their jurisdiction and submitted the required mission statement and district map;

**WHEREAS**, the City has been found to be a qualified public agency authorized to request the purchase of tax-defaulted properties within their jurisdiction per Revenue and Taxation (R&T) code 3695 and 3695.4;

**WHEREAS**, an 'Agreement to Purchase Tax-Defaulted Property' has been written, agreed to, and signed by the City, and received back by the Tax Collector along with all required supportive documentation;

**WHEREAS**, all documentation once approved by the Board of Supervisors will be further submitted to the California State Controller's Office for final approval per R&T code 3795;


