Project Description: Maromo, LLC (11432) seeks a Special Permit for an existing 10,000-square foot (SF) outdoor cannabis cultivation operation, in three separate cultivation areas (A, B, and C). Ancillary propagation (Nursery) occurs in a 1,000-SF greenhouse onsite.

The primary water source for irrigation consists of rain-harvesting from the barn rooftop. Additionally, domestic and non-commercial agricultural water is provided by two points of diversion (POD) located on APN 107-144-020 from a spring (Certificate H100330). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500-gallon plastic tanks and two (2) 20,000gallon water bladders. The applicant proposes to install twenty (20) additional 5,000-gallon hard tanks to add 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF).

Drying and bucking occurs onsite, and all other processing occurs offsite at a licensed processing or manufacturing facility. Up to five (5) employees may be utilized during peak operations. Power is provided by PG&E, with plans to convert to a solar energy system in the future. The use of one (1) Honda generator (6500 watts each) may be utilized for supplemental power when needed.

Project Location: The project is located at 2250 Wilder Ridge Road, approximately 3 miles southeast of the unincorporated community of Honeydew, in southern Humboldt County.

Present Plan Land Use Designations: Residential Agriculture (RA 40-160) Density: forty to 160 acres per dwelling unit.

Executive Summary: Maromo, LLC (11432) seeks a Special Permit for an existing 10,000-square foot (SF) outdoor cannabis cultivation operation, in three separate cultivation areas (A, B, and C), in accordance with Humboldt County Code Section 314-55.4 of Chapter 4 of Division I of Title III, Commercial Medical Marijuana Land Use Ordinance (CMMLUO). The site is designated as Residential Agriculture (RA 40-160) in the Humboldt County 2017 General Plan Update and zoned Agricultural Exclusive (AE) and Unclassified (U).

The parcel, APN 1107-144-020, measures approximately 86 acres in size. The site is at an elevation of approximately 500 feet with a Class I watercourse, Honeydew Creek, flowing through the center of the property. Existing development on the site includes a barn (partially used for drying cannabis) and non-cannabis facilities such as a garage and two residences, both of which are occupied year-round by the property owner and family.

The site has two pre-existing cultivation areas: 1,000-SF outdoor cultivation area (Area A), located on a south-facing flat terrace on the opposite side of Honeydew Creek from the residence, and a 12,463-SF outdoor cultivation area (Area B) near the main residence. The application proposes to reduce the size of Area B to approximately 3,000 SF total and relocate cultivation to Areas A and C. Cultivation Area A will be increased from 1,000 SF to approximately 2,500 SF (increase of 1,500 SF), and Cultivation Area C will be established to a size of approximately 4,500 SF. Together, the three reconfigured cultivation areas will total 10,000 SF (an overall reduction of 3,463 SF) and configured as shown below. The purpose of the relocation is to relocate the cannabis cultivation operation(s) outside of the stream setback adjacent to Cultivation Area B.

Ancillary propagation (Nursery) occurs in an existing 1,000-SF greenhouse near Cultivation Area B. One harvest is anticipated annually in the outdoor areas for a growing season that extends from May through October.

Drying and bucking occur onsite, and all other processing occurs offsite at a licensed processing or manufacturing facility. Up to five (5) employees may be utilized during peak operations. Power is provided by PG&E, with plans to convert to a solar energy system in the future. The use of one (1) Honda generator (6500 watts each) may be utilized for supplemental power when needed.

The primary water source for irrigation consists of rain-harvesting from the barn rooftop. Domestic and non-commercial agricultural water is provided by two points of diversion (POD) located on APN 107-144-

020 from a spring (Certificate H100330). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500-gallon plastic tanks and two (2) 20,000-gallon water bladders. The applicant proposes to install twenty (20) additional 5,000-gallon hard tanks to add 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF).

Timber Conversion

A Timberland Conversion Report (**Attachment 3b**) was prepared by Mad River Properties, Inc. (Stephen Hohman, RPF No. 2652) in August 2018 for the subject parcel (107-144-020) and adjacent parcel (107-144-021), which indicated that initial conversion occurring on both parcels occurred between 2009 and 2012. The report details five separate areas of timberland conversion, totaling approximately 2.37 acres: Site A – 0.14 acres (2012); Site B – 1.08 acres (2009); Site C – 0.84 acres (2009); Site D – 0.06 acre (2009); and Site E – 0.25 acre (2009). Only conversion Site A is contained within APN 107-144-020 and is applicable to this particular cannabis application. Conversion Site A (0.14 acres) was originally converted for cannabis cultivation in 2012, with no other improvements except a fence. However, currently, there is no cannabis cultivation or other facilities occupying this conversion site. No timber harvesting or other activities have occurred within or around this site in approximately 9 years, and no hazard reduction issues are present on site. All timber conversion on Site A occurred prior to January 1, 2016, which is when the established CEQA baseline for CMMLUO was enacted. Therefore, it can be assumed that potential impacts of conversion were considered, and mitigation measures were identified in the environmental document prepared for CMMLUO.

Water Resources

The primary water source for irrigation consists of rain-harvesting off the barn rooftop. Domestic and non-commercial agricultural water is provided by two point of diversions (POD) located on APN 107-144-020 from a spring (Certificate H100330) (**Attachment 3d**). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500 gallon plastic tanks and two (2) 20,000 gallon water bladders. The applicant proposes to install twenty (20) additional 5,000 gallon hard tanks to add an additional 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF) with peak demand occurring in July at approximately 25,000 gallons per month. The Appropriate Right allows up 0.38 acre-feet to be diverted and no more than 0.39 acre-feet to be stored in total. A Final Lake and Streambed Alteration Agreement (SAA 1600-2017-0877-R1) with the California Department of Fish and Wildlife (CDFW) (**Attachment 3c**) was also obtained in December 2017, and revised in October 2018, allowing the three encroachments for water diversions from the Honeydew Creek and unnamed tributaries to Honeydew Creek, for domestic and irrigation uses.

Biological Resources

A biological resources report was not prepared for this project. However, a review of the California Natural Diversity Data Base (CNDDDB) was conducted by Harris & Associates in January 2021 and identified one (1) plant species and one (1) animal species, neither of which are of special concern or sensitive status. The CNDDDB also showed that Northern Spot Owl critical habitat is near the site (approximately 175-meters), but no occurrences of Northern Spotted Owl are recorded. As shown below, the one (1) animal species, the foothill yellow-legged frog (*Rana boylei*), is recorded approximately 120 meters from the project boundary; And the one (1) plant species, white flowered orchid (*Piperia candida*), is recorded approximately 260-meters from the project boundary.

Cannabis cultivation activities have been occurring on the subject property since prior to 2012, which is well before the January 1, 2016, established CEQA baseline for CMMLUO. Therefore, it can be assumed that potential impacts to biological resources and required mitigation were identified in the environmental document prepared for CMMLUO 1.0. Furthermore, the project is conditioned to adhere to Dark Sky Standards for greenhouse lighting and security lighting, refrain from using synthetic netting, ensure refuse is contained in wildlife-proof storage, and refrain from using anticoagulant rodenticides to further protect wildlife. As proposed and conditioned, the project is consistent with CMMLUO

performance standards and CDFW guidance, and would not negatively impact the Northern Spotted Owl or other sensitive species.

Tribal Cultural Resource Coordination

The project is located within the traditional territory of the Mattole tribe. The project was referred to the Northwest Information Center (NWIC), Big Lagoon Rancheria, Blue Lake Rancheria, Hupa Valley Tribe, Karuk Tribe, Bear River Band of the Rohnerville Rancheria, Round Valley Indian Tribes of the Round Valley Reservation, Wiyot Tribe, and Yurok Tribe of the Yurok Reservation between February and May 2018. A Cultural Resources Investigation was prepared by Dimitra Zalarvis-Chase, MA, RPA and Thomas J. Ross, BA, of DZC Archaeology & Cultural Resource Management (DZC), Arcata, CA (May 2018).

The Bear River Tribal Historic Preservation Officer (THPO) recommended a survey given the sensitivity of the general area. No other tribe/representative responded to the referral.

The DZC report concludes that there will be "No Effect" to historic, archaeological, or Tribal Cultural Resources, as defined by CEQA. The record and literature searches indicated that there are no previously recorded resources within the Area of Potential Effect (APE) or Environmental Study Limits (ESL). A previous survey of the ESL, but not the APE, was conducted; and the survey report (S-043341), prepared for the California Department of Fish and Wildlife, concluded that no cultural resources during that investigation.

The DZC survey did identify one new archaeological resource (MAR-01), which was recorded on Department of Parks and Recreation Series 523 form (documented in Appendix F of the DZC report). However, the resource is a lone constituent, is not recommended eligible for the CRHR or NRHP, and is not located within 600 feet of any cannabis activity or related structures. Measures to protect unknown cultural resources, in accordance with the Inadvertent Discoveries Protocol, have been incorporated into the Conditions of Approval (**Informational Note 3**).

Access

Access to the site is via a private driveway off Wilder Ridge Road, approximately two miles south of the intersection of Mattole Road and Wilder Ridge Road, in the Honeydew area. Per the review referral from Humboldt County Department of Public Works (DPW), the entire road segment is developed to the equivalent of a road category 4 standard, and thus is adequate for the proposed use without further review. Nonetheless, DPW recommends standard conditions pertaining to fences and encroachments (**Condition 15**), driveways (**Condition 16**), and private road intersections (**Condition 17**).

CEQA

Environmental review for this project was conducted. Based on the results of that analysis, staff finds that all aspects of the project have been considered in the Mitigated Negative Declaration (MND) that was adopted for the CMMLUO, and thus has prepared an addendum to the MND for consideration by the Zoning Administrator (**Attachment 2**).

RECOMMENDATION:

Staff recommends that the Zoning Administrator describe the application as a part of the consent agenda; survey the audience to see if any person would like to discuss the application; if no one requests discussion, make all the required findings based on the evidence in the record; and approve the application subject to the recommended conditions.

Alternatives: Several alternatives may be considered: 1) The Zoning Administrator could elect not to hear this item and put the decision making in front of the Planning Commission. Any decision to place this matter before the Planning Commission must be done before opening the public hearing on this project; 2) The Zoning Administrator could elect to add or delete conditions of approval; 3) The Zoning Administrator could deny approval of the requested permits if you are unable to make all of the required findings. Planning Division staff is confident that the required findings can be made based on the submitted evidence and subject to the recommended conditions of approval. Consequently, planning staff does not recommend further consideration of these alternatives.

Resolution by the Zoning Administrator of the County of Humboldt certifying compliance with the California Environmental Quality Act and conditionally approving the Maromo, LLC, Special Permit (11432).

WHEREAS, Maromo, LLC, submitted an application and evidence in support of approving a Special Permit for an existing 10,000 square feet (SF) of outdoor cannabis cultivation operation, in three separate cultivation areas: Area A – 2,500 SF; Area B – 3,000 SF; and Area C – 4,500 SF). Ancillary propagation (Nursery) occurs in a 1,000-SF greenhouse onsite.

WHEREAS, the County Planning Division, the lead agency, prepared an Addendum to the Final Mitigated Negative Declaration (MND) prepared for the Commercial Medical Land Use Ordinance (CMMLUO) adopted by the Humboldt County Board of Supervisors on January 26, 2016. The proposed project does not present substantial changes that would require major revisions to the previous MND. No new information of substantial importance that was not known and could not be known at the time was presented, as described by §15162(c) of CEQA Guidelines; and

WHEREAS, the Humboldt County Zoning Administrator held a duly-noticed public hearing on **February 4, 2021**; reviewed, considered, and discussed the application for a Special Permit; and reviewed and considered all evidence and testimony presented at the hearing.

Now, THEREFORE BE IT RESOLVED, that the Zoning Administrator makes all the following findings:

- 1. FINDING:** **Project Description:** The application is a Special Permit for an existing 10,000 square foot (SF) of outdoor cannabis cultivation operation, in three separate cultivation areas: Area A – 2,500 SF; Area B – 3,000 SF; and Area C – 4,500 SF. Ancillary propagation (Nursery) occurs in a 1,000 SF-greenhouse onsite.

EVIDENCE: a) Project File: PLN-11432-SP
- 2. FINDING:** **CEQA.** The requirements of the California Environmental Quality Act have been met. The Humboldt County Zoning Administrator has considered the Addendum (**Attachment 2**) to and the Mitigated Negative Declaration (MND) prepared for the Commercial Medical Marijuana Land Use Ordinance (CMMLUO), adopted by the Humboldt County Board of Supervisors on January 26, 2016.

EVIDENCE: a) Addendum Prepared for the proposed project.
b) The proposed project does not present substantial changes that would require major revisions to the previous MND. No new information of substantial importance that was not known and could not be known at the time was presented as described by §15162(c) of CEQA Guidelines.

- c) A biological resources report was not prepared for this project. However, a review of the California Natural Diversity Data Base (CNDDDB) (**Attachment 3**) was conducted by Harris & Associates in January 2021 and identified one (1) plant species and one (1) animal species, neither of which are of special concern or sensitive status. - Discoveries Protocol to protect cultural resources, have been incorporated into the Conditions of Approval (**Informational Note 3**).
- f) Per the review referral from Humboldt County Department of Public Works (DPW), the entire road segment is developed to the equivalent of a road category 4 standard, and thus is adequate for the proposed use without further review. Nonetheless DPW recommends standard conditions pertaining to fences and encroachments (**Condition 15**), driveways (**Condition 16**) and private road intersections (**Condition 17**).

FINDINGS FOR SPECIAL PERMIT

- 3. FINDING** The proposed development is in conformance with the County General Plan, Open Space Plan, and the Open Space Action Program.
- EVIDENCE** a) General agriculture is a use type permitted in the Residential Agriculture (RA) land use designation. The proposed cannabis cultivation, an agricultural product, is within land planned and zoned for agricultural purposes, consistent with the use of Open Space land for managed production of resources. The use of an agricultural parcel for commercial agriculture is consistent with the Open Space Plan and Open Space Action Program. Therefore, the project is consistent with and complimentary to the Open Space Plan and its Open Space Action Program.
- 4. FINDING** The proposed development is consistent with the purposes of the existing Agricultural Exclusive (AE) in which the site is located.
- EVIDENCE** a) Agricultural Exclusive (AE) is intended to be applied to areas of the County where general agriculture residential uses are the desirable predominant uses.
- b) All general agricultural uses are principally permitted in the Agricultural Exclusive (AE).
- c) Humboldt County Code section 314-55.4.8.2.2 allows cultivation of up to 10,000 square feet of existing outdoor cannabis and up to 10,000 square feet of existing mixed-light cannabis on a parcel over 1 acre, subject to approval of a Special Permit and a determination that the cultivation was in existence prior to January 1, 2016. The application for 10,000 square foot (SF) of outdoor cannabis cultivation operation, in three separate cultivation areas (A – 2,500 SF; B – 3,000 SF; and C – 4,500 SF) and a nursery (1,000 SF-greenhouse), on 86-acre parcel is consistent with this and with the cultivation area verification prepared by the County.
- 5. FINDING** The proposed development is consistent with the requirements of the CMMLUO Provisions of the Zoning Ordinance.
- EVIDENCE** a) The CMMLUO allows existing cannabis cultivation to be permitted in areas zoned AE (HCC 314-55.4.8.2.2).
- b) The parcel was created in compliance with all applicable state and local subdivision regulations, as it was created in its current configuration by deed recorded September 2, 1950, before the establishment of county and state subdivision regulations that would

- have applied to the creation of the parcel.
- c) The primary water source for irrigation consists of rain-harvesting from the barn rooftop. Domestic and non-commercial agricultural water is provided by two points of diversion (POD), located on APN 107-144-020, from a spring (Certificate H100330) (**Attachment 3d**). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500-gallon plastic tanks and two (2) 20,000-gallon water bladders. The applicant proposes to install twenty (20) additional 5,000-gallon hard tanks to add 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF), with peak demand occurring in July at approximately 25,000 gallons per month. The Appropriate Right allows up 0.38 acre-feet to be diverted and no more than 0.39 acre-feet of water stored.
 - d) Humboldt County Department of Public Works (DPW) reviewed and inspected the access roadways in October of 2019, and concluded that the entire road segment is developed to the equivalent of a road category 4 standard, and thus is adequate for the proposed use without further review.
 - e) The slope of the land where cannabis will be cultivated is less than 15%.
 - f) A Timberland Conversion Report dated August 2018 was prepared by Mad River Properties, LLC. It details previously unauthorized timber conversion, consistent with the Forest Practices Act, and how the project can be implemented with no net loss of timberland, after the environmental baseline of January 1, 2016. In this particular case, the 0.14 acre of unauthorized timber conversion was done prior to 2012. All conversion occurred prior to the established CEQA baseline for CMMLUO. Therefore, the potential environmental impacts of all conversion was considered, and mitigated was identified in the environmental document prepared for CMMLUO.
 - g) The location of the cultivation complies with all setbacks required in Section 314-55.4.11.d. It is more than 30 feet from any property line, more than 300 feet from any off-site residence, and more than 600 feet from any school, church, public park or Tribal Cultural Resource.

6. FINDING

EVIDENCE

- The cultivation of 10,000 square feet of cannabis cultivation and the conditions under which it may be operated or maintained will not be detrimental to the public health, safety, or welfare or materially injurious to properties or improvements in the vicinity.
- a) The site is located on road that has been certified by a licensed engineer to safely accommodate the amount of traffic generated by the proposed cannabis cultivation.
 - b) The site is in a rural part of the County where the typical parcel size is over 40 acres, and many of the land holdings are very large. The proposed cannabis will not be in a location where there is an established neighborhood or other sensitive receptor such as a school, church, park or other use which may be sensitive to cannabis cultivation. Approving cultivation on this site, as well as the other sites

which have been approved or are in the application process, will not change the character of the area due to the large parcel sizes in the area.

- c) The location of the proposed cannabis cultivation is more than 300 feet from the nearest off-site residence.
- d) The primary water source for irrigation consists of rain-harvesting from the barn rooftop. Domestic and non-commercial agricultural water is provided by two points of diversion (POD), located on APN 107-144-020, from a spring (Certificate H100330) (**Attachment 3d**). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500-gallon plastic tanks and two (2) 20,000-gallon water bladders. The applicant proposes to install twenty (20) additional 5,000gallon hard tanks to add an additional 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF).
- e) Provisions have been made in the applicant's proposal to protect water quality and thus runoff to adjacent property, and infiltration of water to groundwater resources will not be affected.

7. FINDING

The proposed development does not reduce the residential density for any parcel below that utilized by the Department of Housing and Community Development in determining compliance with housing element law.

EVIDENCE

- a) The parcel was not included in the housing inventory of Humboldt County's 2019 Housing Element, but does have the potential to support one housing unit. The approval of cannabis cultivation on this parcel will not conflict with the ability for a residence to be constructed on this parcel.

DECISION

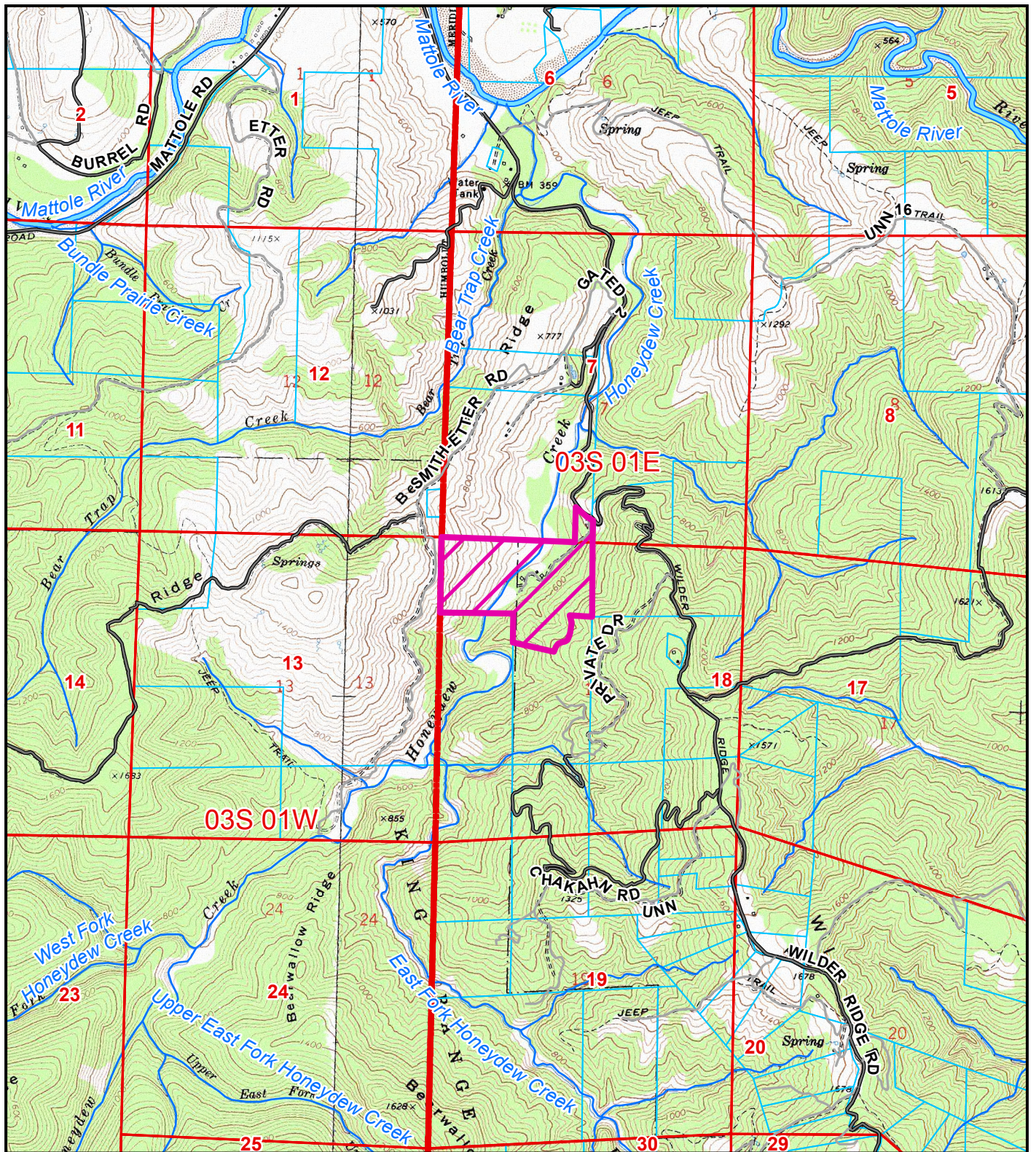

RECOMMENDED CONDITIONS OF APPROVAL

APPROVAL OF THE SPECIAL PERMIT IS CONDITIONED ON THE FOLLOWING TERMS AND REQUIREMENTS WHICH MUST BE SATISFIED BEFORE THE PROVISIONAL CANNABIS CULTIVATION PERMIT CAN BE FINALIZED.

A. General Conditions:

1. The Applicant is responsible for obtaining all necessary County and State permits and licenses, and for meeting all requirements set forth by other regulatory agencies.
2. The Applicant is required to pay for permit processing on a time and material basis as set forth in the schedule of fees and charges, as adopted by ordinance of the Humboldt County Board of Supervisors. The Planning and Building Department will provide a bill to the applicant after the decision. Any and all outstanding planning fees to cover the processing of the application to decision by the Hearing Officer shall be paid to the Humboldt County Planning Division, 3015 "H" Street, Eureka.
3. The Applicant is responsible for costs for post-approval review for determining project conformance with conditions. A deposit is collected to cover this staff review. Permit conformance with conditions must be demonstrated, prior to release of building permit or initiation of use and at the time of annual inspection. A conformance review deposit, as set forth in the schedule of fees and charges as adopted by ordinance of the Humboldt County Board of Supervisors (currently \$750), shall be paid within sixty (60) days of the effective date of the permit or upon filing of the Compliance Agreement (where applicable), whichever occurs first. Payment shall be made to the Humboldt County Planning Division, 3015 "H" Street, Eureka.
4. A Notice of Determination (NOD) will be prepared and filed with the County Clerk for this project in accordance with the State CEQA Guidelines. **Within three days of the effective date of permit approval** the Department will file the NOD and will charge this cost to the project.
5. Within 60 days of the effective date of permit approval, the applicant shall execute a Compliance Agreement with the Humboldt County Planning and Building Department, detailing all necessary permits and infrastructure improvements described under Conditions of Approval #6 through #17. The agreement shall provide a timeline for completing all outstanding items. All activities detailed under the agreement must be completed to the satisfaction of the Planning and Building Department before the permit may be finalized and no longer considered provisional.
6. The Applicant shall secure permits for all structures related to the cannabis cultivation and other commercial cannabis activity, including but not limited to, existing and proposed greenhouses, water tanks over 5,000 gallons, existing and proposed structures associated with drying and storage or any activity with a nexus to cannabis, and any noise containment structures as necessary. The plans submitted for building permit approval shall be consistent with the project description and the approved project site plan. A letter or similar communication from the Building Division verifying that all structures related to the cannabis cultivation are permitted will satisfy this condition.
7. The approved building plans shall meet all applicable fire codes, including fire suppression infrastructure requirements deemed necessary for the project by the Building Inspection Division. Sign-off on the Occupancy Permit by the Building Division shall satisfy this requirement.
8. The Applicant shall obtain a permit to operate the proposed generators from the North Coast Unified Air Quality Management District (NCUAQMD) and obtain an electric permit from the County's Building Department.

9. The Applicant shall prepare and submit a revised site plan, showing the required relocation of proposed greenhouses and cultivation area, including associated grading for the relocation of cultivation areas. Revised Site plan(s) shall be presented to the Director of Planning & Building.
10. The Applicant shall submit a grading, erosion and sediment control plan prepared by a qualified engineer. The plan shall identify the cubic yards of all grading that has been completed and any proposed. A letter or similar communication from the Building Division, verifying that all grading related to the cannabis cultivation operation are permitted or not needed, will satisfy this condition.
11. The Applicant shall implement recommendations in the Timberland Conversion Report, dated August 2018 and prepared by Mad River Properties, Inc. A monitoring report prepared by a licensed professional forester shall be submitted annually to the Planning and Building Department.
12. The Applicant shall contact the local fire service provider (Honeydew Volunteer Fire Department) and furnish written documentation from that agency of the available emergency response, fire suppression services, and any recommended project mitigation measures. Mitigation measures shall be incorporated into the project, if applicable. If emergency response and fire suppression services are not provided, the applicant shall cause to be recorded an "ACKNOWLEDGMENT OF NO AVAILABLE EMERGENCY RESPONSE AND FIRE SUPPRESSION SERVICES" for the parcel(s) on a form provided by the Humboldt County Planning Division. Document review fees, as set forth in the schedule of fees and charges as adopted by ordinance of the Humboldt County Board of Supervisors, will be required.
13. The Applicant shall be compliant with the County of Humboldt's Certified Unified Program Agency (CUPA) requirements regarding hazardous materials. A written verification of compliance shall be required before any provisional permits may be finalized. Ongoing proof of compliance with this condition shall be required at each annual inspection in order to keep the permit valid.
14. The Applicant shall execute and file with the Planning Division the statement titled, "Notice and Acknowledgment regarding Agricultural Activities in Humboldt County," ("Right to Farm" ordinance) as required by the HCC and available at the Planning Division.
15. COUNTY ROAD – FENCES & ENCROACHMENTS: All fences and gates shall be relocated out of the County right of way. All gates shall be setback sufficiently from the County road so that vehicles will not block traffic when staging to open/close the gate. In addition, no materials shall be stored or placed in the County right of way. This condition shall be completed to the satisfaction of the Department of Public Works prior to commencing operations,
16. COUNTY ROADS – DRIVEWAY (PART2): Any existing roads or proposed driveways, that will serve as access for the proposed project and connect to a county maintained road, shall be improved to current standards for a commercial driveway. An encroachment permit shall be issued by the Department of Public Works, prior to commencement of any work in the County maintained right of way. If the County road is an unpaved surface at the location of the driveway, the driveway apron shall be paved for a minimum width of 18-feet and a length of 50-feet.
17. COUNTY ROADS – DRIVEWAY & PRIVATE ROAD INTERSECTION VISIBILITY: All driveways and private road intersections onto the County road shall be maintained in accordance with County Code Section 341-1 (Sight Visibility Ordinance). This condition shall be completed to the satisfaction of the Department of Public Works prior to commencing operations, final sign-off for a building permit, or Public Works approval for a business license.

B. Ongoing Requirements/Development Restrictions Which Must be Satisfied for the Life of the Project:

1. The combination of background, generator and greenhouse fan or other operational equipment created noise must not result in the harassment of Northern Spotted Owl species, as required to meet the performance standards for noise set by Department Policy Statement No. 16-005 clarifying CMMLUO Section 55.4.11 (o) requirements. The combined noise levels measured at 100 feet or the edge of habitat, whichever is closer, shall be at or below 50 decibels. Conformance will be evaluated using current auditory disturbance guidance prepared by the United State Fish and Wildlife Service, and further consultation where necessary. A building permit shall be obtained should any structures be necessary for noise attenuation.
2. Should the Humboldt County Planning Division receive complaints that the lighting or noise is not complying with the standards listed above in items B.1. and B.2., within ten (10) working days of receiving written notification that a complaint has been filed, the applicant shall submit written verification that the lights' shielding and alignment, and/or noise levels have been repaired, inspected, and corrected as necessary.
3. The applicant shall ensure all generators are located on stable surfaces, with a minimum 200-foot buffer from all waterways, measured horizontally from the outer edge of the riparian drip zone, per CDFW referral comments received January 4, 2018.
4. The use of synthetic netting is prohibited. To minimize the risk of wildlife entrapment, the applicant shall not use any erosion control and/or cultivation materials that contain synthetic (e.g., plastic or nylon) netting, including photo- or biodegradable plastic netting. Geotextiles, fiber rolls, and other erosion control measures shall be made of loose-weave mesh, such as jute, hemp, coconut (coir) fiber, or other products without welded weaves.
5. The applicant shall contain all refuse in wildlife-proof storage containers at all times, and ensure refuse is disposed at an authorized waste management facility.
6. Should any wildlife be encountered during work activities, the wildlife shall not be disturbed and be allowed to leave the work site unharmed.
7. The use of anticoagulant rodenticide is prohibited.
8. The operator shall provide information to all employees about the potential health impacts of cannabis use on children. Information shall be provided by posting the brochures from the Department of Health and Human Services, titled "Cannabis Palm Card" and "Cannabis Rack Card." This information shall also be provided to all employees as part of the employee orientation.
9. All components of the project shall be developed, operated, and maintained in conformance with the Project Description, the approved Site Plan, the Plan of Operations, and these conditions of approval. Changes shall require modification of this permit, except where consistent with Humboldt County Code Section 312-11.1, Minor Deviations to Approved Plot Plan. At any time if offsite processing is chosen to be the preferred method of processing, this permit shall be modified to identify the offsite licensed facility.
10. Cannabis cultivation and other commercial cannabis activity shall be conducted in compliance with all laws and regulations as set forth in the CMMLUO and MAUCRSA, as applicable to the permit type.
11. If operating pursuant to a written approved compliance agreement, permittee shall abate or cure violations at the earliest feasible date, but in no event no more than two (2) years from the date of issuance of a provisional clearance or permit. Permittee shall provide plans for curing such violations to the Planning and Building Department within one (1) year of issuance of the provisional clearance or permit. If good faith effort toward compliance can be shown within the two years following the issuance of the provisional clearance or permit, the Department may, at the discretion of the

Director, provide for extensions of the provisional permit to allow additional time to meet the outstanding requirements.

12. The applicant shall possess a current, valid required license⁷ or licenses⁸ issued by any agency of the State of California in accordance with the MAUCRSA, and regulations promulgated thereunder, as soon as such licenses become available.
13. The applicant shall comply with all statutes, regulations, and requirements of the California State Water Resources Control Board and the Division of Water Rights, at a minimum to include a statement of diversion of surface water from a stream, river, underground stream, or other watercourse required by Water Code Section 5101, or other applicable permit, license, or registration, as applicable.
14. The applicant shall confine the area of cannabis cultivation, processing, manufacture, or distribution to the locations depicted on the approved site plan. The commercial cannabis activity shall be set back at least 30 feet from any property line, and 600 feet from any school, school bus stop, church or other place of religious worship, or tribal cultural resources, except where a reduction to this setback has been approved pursuant to Section 55.4.11(d).
15. The applicant shall maintain enrollment in Tier 1, 2, or 3, certification with North Coast Regional Water Quality Control Board (RWQCB) Order No. R1-2015-0023, if applicable, or any substantially equivalent rule that may be subsequently adopted by the County of Humboldt or other responsible agency.
16. The applicant shall comply with the terms of any applicable Lake and Stream Alteration (1600 or 1602) Permit obtained from the California Department of Fish and Wildlife (CDFW).
17. The applicant shall comply with the terms of a less-than-3-acre conversion exemption or timberland conversion permit, approved by the California Department of Forestry and Fire Protection (Cal Fire), if applicable.
18. The applicant shall consent to an annual on-site compliance inspection, with at least 24 hours prior notice, to be conducted by appropriate County officials during regular business hours (Monday through Friday, 9:00 a.m. to 5:00 p.m., excluding holidays).
19. The applicant shall refrain from the improper storage or use of any fuels, fertilizer, pesticide, fungicide, rodenticide, or herbicide.
20. The applicant shall pay all applicable application, review for conformance with conditions, and annual inspection fees.
21. Fuel shall be stored and handled in compliance with applicable state and local laws and regulations, including the County of Humboldt's Certified Unified Program Agency (CUPA) program, and in such a way that no spillage occurs.
22. The master log books maintained by the applicant to track production and sales shall be maintained for inspection by the County.
23. Pay all applicable taxes as required by the Humboldt County Commercial Marijuana Cultivation Tax Ordinance (Humboldt County Code Section 719-1 et seq.).

Performance Standards for Cultivation and Processing Operations

24. Pursuant to the MCRSA, Health and Safety Code Section 19322(a)(9), an applicant seeking a cultivation license shall "provide a statement declaring the applicant is an 'agricultural employer,' as defined in the Alatorre-Zenovich-Dunlap-Berman Agricultural Labor Relations Act of 1975 (Part 3.5

commencing with Section 1140) of Division 2 of the Labor Code), to the extent not prohibited by law."

25. Cultivators shall comply with all applicable federal, state, and local laws and regulations governing California Agricultural Employers, which may include federal and state wage and hour laws, Cal/OSHA, OSHA, the California Agricultural Labor Relations Act, and the Humboldt County Code (including the Building Code).
26. Cultivators engaged in processing shall comply with the following Processing Practices:
 - a. Processing operations must be maintained in a clean and sanitary condition including all work surfaces and equipment.
 - b. Processing operations must implement protocols which prevent processing contamination and mold and mildew growth on cannabis.
 - c. Employees handling cannabis in processing operations must have access to facemasks and gloves in good operable condition, as applicable to their job function.
 - d. Employees must wash hands sufficiently when handling cannabis or use gloves.
27. All persons hiring employees to engage in commercial cannabis cultivation and processing shall comply with the following Employee Safety Practices:
 - a. Cultivation operations and processing operations must implement safety protocols and provide all employees with adequate safety training relevant to their specific job functions, which may include:
 - (1) Emergency action response planning as necessary;
 - (2) Employee accident reporting and investigation policies;
 - (3) Fire prevention;
 - (4) Hazard communication policies, including maintenance of material safety data sheets (MSDS);
 - (5) Materials handling policies;
 - (6) Job hazard analyses; and
 - (7) Personal protective equipment policies, including respiratory protection.
 - b. Cultivation operations and processing operations must visibly post and maintain an emergency contact list, which includes at a minimum:
 - (1) Operation manager contacts,
 - (2) Emergency responder contacts, and
 - (3) Poison control contacts.
 - c. At all times, employees shall have access to safe drinking water and toilets and handwashing facilities that comply with applicable federal, state, and local laws and regulations. Plumbing facilities and water source must be capable of handling increased usage without adverse consequences to neighboring properties or the environment.
 - d. On site-housing provided to employees shall comply with all applicable federal, state, and local laws and regulations.
28. All cultivators shall comply with the approved processing plan, as to the following:
 - a. Processing practices,
 - b. Location where processing will occur,
 - c. Number of employees, if any,
 - d. Employee Safety Practices,
 - e. Toilet and handwashing facilities,
 - f. Plumbing and/or septic system and whether or not the system is capable of handling increased usage,
 - g. Drinking water for employees,
 - h. Plan to minimize impact from increased road use resulting from processing, and
 - i. On-site housing, if any.

29. Term of Commercial Cannabis Activity Special Permit. Any Commercial Cannabis Cultivation SP issued pursuant to the CMMLUO shall expire one (1) year after date of issuance, and on the anniversary date of such issuance each year thereafter, unless an annual compliance inspection has been conducted, and the permittees and the permitted site have been found to comply with all conditions of approval.
30. If the inspector or other County official determines that the permittees or site do not comply with the conditions of approval, the inspector shall serve the permit holder with a written statement identifying the items not in compliance, and the action that the permit holder may take to cure the noncompliance, or file an appeal within ten (10) days of the date that the written statement is delivered to the permit holder. Personal delivery or mailing of the written statement to the mailing address listed on the application by regular mail, plus three (3) days after date of mailing, shall constitute delivery. The permit holder may request a re-inspection to determine whether or not the permit holder has cured all issues of noncompliance. Failure to request re-inspection or to cure any items of noncompliance shall terminate the Special Permit, immediately upon the expiration of any appeal period or final determination of the appeal, if an appeal has been timely filed pursuant to Section 55.4.13.
31. Permit Renewals to Comply with Updated Laws and Regulations. Permit renewal is subject to the laws and regulations effective at the time of renewal, which may be substantially different than the regulations currently in place, and may require the submittal of additional information to ensure that new standards are met.
32. Acknowledgements to Remain in Full Force and Effect. Permittee acknowledges that the County reserves the right to reduce the size of the area allowed for cultivation, under any clearance or permit issued, in accordance with this section in the event that environmental conditions, such as a sustained drought or low flows in the watershed in which the cultivation area is located, will not support diversions for irrigation.
33. Transfers. Transfer of any leases or permits approved by this project is subject to the review and approval of the Planning Director for conformance with CMMLUO eligibility requirements and agreement to permit terms and acknowledgments. The fee for required permit transfer review shall accompany the request. The request shall include:
- Identifying information for the new owner(s) and management as required in an initial permit application;
 - A written acknowledgment by the new owner in accordance as required for the initial permit application;
 - The specific date on which the transfer is to occur;
 - Acknowledgement of full responsibility for complying with the existing permit; and
 - Execution of an Affidavit of Non-diversion of Medical Cannabis.
34. Inspections. The permit holder and subject property owner are to permit the County or representative(s) or designee(s) to make inspections at any reasonable time deemed necessary to assure that the activities being performed under the authority of this permit are in accordance with the terms and conditions prescribed herein.

Informational Notes:

- Pursuant to Section 314-55.4.11(a) of the CMMLUO, if upon inspection for the initial application, violations of any building or other health, safety, or other state or county statute, ordinance, or regulation are discovered, the Planning and Building Department may issue a provisional clearance or permit with a written approved Compliance Agreement. By signing the agreement, the permittee agrees to abate or cure the violations at the earliest opportunity, but in no event more than two (2) years after the date of issuance of the provisional clearance or permit. Plans for curing the violations

shall be submitted to the Planning and Building Department by the permittee within one (1) year of the issuance of the provisional certificate or permit. The terms of the compliance agreement may be appealed pursuant to Section 314-55.4.13 of the CMMLUO.

2. This provisional permit approval shall expire and become null and void at the expiration of one (1) year after all appeal periods have lapsed (see "Effective Date"), except where the Compliance Agreement per Condition of Approval #6 has been executed, and the corrective actions pursuant to the agreement are being undertaken. Once building permits have been secured and/or the use initiated pursuant to the terms of the agreement, the use is subject to the Permit Duration and Renewal provisions set forth in Conditions of Approval #26 and 27 of the Ongoing Requirements/Development Restrictions, above.
3. If cultural resources are encountered during construction activities, the contractor on-site shall cease all work in the immediate area and within a 50-foot buffer of the discovery location. A qualified archaeologist and the appropriate Tribal Historic Preservation Officer(s) shall be contacted to evaluate the discovery and, in consultation with the applicant and the lead agency, develop a treatment plan in any instance where significant impacts cannot be avoided.

Prehistoric materials may include obsidian or chert flakes, tools, locally darkened midden soils, groundstone artifacts, shellfish or faunal remains, and human burials. If human remains are found, California Health and Safety Code 7050.5 requires that the County Coroner be contacted immediately at 707-445-7242. If the Coroner determines the remains to be Native American, the Native American Heritage Commission will then be contacted by the Coroner to determine appropriate treatment of the remains pursuant to Public Resources Code (PRC) Section 5097.98. Violators shall be prosecuted in accordance with PRC Section 5097.99.

4. The applicant shall be aware that the Federal Government considers the cultivation of cannabis to be an illegal activity. This project is accessed by using roads that pass-through lands owned by the Federal Government. The Federal Government may not allow the applicant to use these roads to transport cannabis. In such case, Humboldt County will not provide relief to the applicant. Approval of this permit does not authorize transportation of cannabis across Federal lands.

BACKGROUND

Purpose of Addendum

Section 15164 of the California Environmental Quality Act (CEQA) provides that the lead agency shall prepare an addendum to a previously certified Mitigated Negative Declaration (MND), if some changes or additions are necessary, but none of the conditions described in Section 15162 calling for a subsequent EIR or Negative Declaration have occurred. Section 15162 states that when an EIR has been certified for a project, no subsequent EIR shall be prepared for that project unless the lead agency determines, on the basis of substantial evidence in the light of the whole record, one or more of the following:

1. Substantial changes are proposed in the project which require major revisions of the previous MND due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects;
2. Substantial changes occur with respect to the circumstances under which the project is undertaken which will require major revisions of the previous MND, due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects; or
3. New information of substantial importance, which was not known and could not have been known with the exercise of reasonable diligence at the time the previous MND was certified as complete, shows any of the following: A) the project will have one or more significant effects not discussed in the previous MND; B) a significant effect previously examined will be substantially more severe than shown in the previous MND; C) mitigation measures or alternatives previously found not to be feasible would in fact be feasible and would substantially reduce one or more significant effects of the project, but the project proponents decline to adopt the mitigation measure or alternative; or D) mitigation measures or alternatives, which are considerably different from those analyzed in the previous MND, would substantially reduce one or more significant effects on the environment, but the project proponents decline to adopt the mitigation measure or alternative.

Project History

The Commercial Medical Marijuana Land Use Ordinance (CMMLUO) established specific regulations for commercial cannabis operations in Humboldt County. These regulations were developed in concert with the MND that was adopted for the CMMLUO, in order to implement the mitigation measures of the MND. The MND addressed the broad environmental impacts that could be expected to occur from the adoption and implementation of the ordinance. The MND specified that the regulations established in the CMMLUO would mitigate the impacts of existing cannabis operations by establishing regulations for an existing unregulated land use to help prevent and reduce environmental impacts that are known to result from unpermitted baseline cultivation operations. Commercial cannabis cultivation in existence as of December 31, 2015, was included in the environmental baseline for the MND. The MND states that "Bringing existing operations into compliance will help to attenuate potential environmental effects from existing cultivation activities, including aesthetic impacts resulting from improper operation or poor siting." The current project was contemplated by the MND, and compliance with the provisions of the CMMLUO will fully mitigate all environmental impacts of the project to a less than significant level.

Modified Project Description

The modified project involves a Special Permit for an existing 10,000-square foot (SF) outdoor cannabis cultivation operation, in three separate cultivation areas (A – 2,500 SF; B – 3,000 SF; and C – 4,500 SF). Ancillary propagation (Nursery) occurs in a 1,000 SF greenhouse onsite. Drying and bucking occur onsite, and all other processing occurs offsite at a licensed processing or manufacturing facility. Up to five (5) employees may be utilized during peak operations. Power is provided by PG&E, with plans to

convert to a solar energy system in the future. The use of one (1) Honda generator (6500 watts each) may be utilized for supplemental power when needed.

The primary water source for irrigation consists of rain-harvesting from the barn rooftop. Domestic and non-commercial agricultural water is provided by two points of diversion (POD) located on APN 107-144-020 from a spring (Certificate H100330). The applicant has obtained a Small Irrigation Use Registration (SIUR) for irrigation purposes. Existing water storage is approximately 41,000 gallons in two (2) 500-gallon plastic tanks and two (2) 20,000-gallon water bladders. The applicant proposes to install twenty (20) additional 5,000-gallon hard tanks to add 100,000 gallons of water storage. Existing and proposed water storage will result in 141,000 gallons of total storage. Estimated annual water usage is 108,700 gallons (10.87 gal/SF).

A Cultural Resources Investigation was prepared by Dimitra Zalarvis-Chase, MA, RPA and Thomas J. Ross, BA, of DZC Archaeology & Cultural Resource Management (DZC), Arcata, CA (May 2018). The DZC report concludes that there will be "No Effect" to historic, archaeological, or Tribal Cultural Resources. Measures regarding the Inadvertent Discoveries Protocol to protect unknown cultural resources have been incorporated into the Conditions of Approval.

The modified project is consistent with the adopted MND for the CMMLUO, because it complies with all standards of the CMMLUO which were intended to mitigate impacts of existing cultivation. These include ensuring supplemental lighting and security lighting adheres to Dark Sky Association standards, and ensuring project related noise does not harass nearby wildlife, which will limit impacts to biological resources as a result of light and noise.

Summary of Significant Project Effects and Required Mitigation

No changes are proposed for mitigation measures identified in the original MND. The proposal to authorize the continued operation of an existing cannabis cultivation site, comprised of 10,000 square feet (SF) of outdoor cannabis cultivation operation, in three separate cultivation areas (A – 2,500 SF; B – 3,000 SF; and C – 4,500 SF), ancillary propagation (nursery) in a 1,000 SF greenhouse onsite, and associated drying/bucking activities is fully consistent with the potential environmental impacts identified and adequately mitigated in the original MND. The project, as conditioned to implement responsible agency recommendations, results in no significant adverse environmental effects beyond those identified in the MND. Compliance with the CMMLUO ensures consistency with the adopted MND and provides for mitigation of all project related impacts to a less than significant level.

In reviewing the application for consistency with the adopted MND, the County considered the following information and studies, among other documents:

- Plot Plans prepared by Northpoint Consulting Group, dated 03/13/2020
- Cultivation and Operations Plan prepared by Northpoint Consulting Group, revised March 2020
- Right to Divert and Use Water, Certificate H100330 with the State Water Resources Control Board, Division of Water Rights, dated October 19, 2017
- Timberland Conversion Report, prepared by Mad River Properties, Inc., dated August 2018
- Phase 1 Cultural Resource Inventory Report for Maromo, LLC, APNs 107-144-020 and 107-144-021, Humboldt County, California, prepared by DZC Archaeology & Cultural Resource Management, Arcata, California, prepared May 2018

Other CEQA Considerations

Staff suggests no changes to the revised project.

EXPLANATION OF DECISION NOT TO PREPARE A SUPPLEMENTAL MITIGATED NEGATIVE DECLARATION OR ENVIRONMENTAL IMPACT REPORT

See **Purpose** statement above.

In every impact category analyzed in this review, the potential environmental impacts of the current project proposal would be the same or similar. There would be no new significant environmental impacts, or a substantial increase in the severity of previously identified significant impact, than identified in the initial CMMLUO project for which the MND was adopted. Based upon this review, the following findings are supported:

FINDINGS

1. The proposed project will permit an existing cannabis operation and bring the operation into compliance with county and state requirements intended to adequately mitigate environmental impacts.
2. The circumstances under which the project was approved have not changed substantially. There are no new significant environmental effects and no substantial increases in the severity of previously identified effects.
3. For the current proposed project, there has been no new information of substantial importance, which was not known and could not have been known with the exercise of reasonable diligence at the time the previous MND was adopted as complete.

CONCLUSION

Based on these findings, it is concluded that an Addendum to the certified MND is appropriate to address the requirements under CEQA for the current project proposal. All of the findings, mitigation requirements, and mitigation and monitoring program of the MND, remain in full force and effect on the original project.

(Notification No. 1600-2017-0877-R1 executed 12/21/2017 and revised on 10/01/2018 – Attached)
9. If the source of water is a well, a copy of the County well permit, if available. (Not applicable)
10. If the parcel is zoned FR, U or TPZ, or involves the conversion of timberland as defined under Section 4526 of the Public Resources Code, a copy of a less-than-3-acre conversion exemption or

timberland conversion permit, approved by the California Department of Forestry and Fire Protection (Cal Fire). Alternately, for existing operations occupying sites created through prior unauthorized conversion of timberland, evidence may be provided by showing that the landowner has completed a civil or criminal process and/or entered into a negotiated settlement with Cal Fire. 11. Consent for onsite inspection of the parcel by County officials at prearranged date and time, in consultation with the applicant prior to issuance of any clearance or permit, and once annually thereafter. (On file)
12. For indoor cultivation facilities, identify the source of electrical power, how it will meet with the energy requirements in Section 55.4.8.2.3, and plan for compliance with applicable building codes. (Not applicable)
13. Acknowledge that the County reserves the right to reduce the size of the area allowed for cultivation, under any clearance or permit issued in accordance with this Section, in the event that environmental conditions, such as a sustained drought or low flows in the watershed, will not support diversions for irrigation. (On file)
14. Acknowledge that the County reserves the right to engage with local tribes before consenting to the issuance of any clearance or permit, if cultivation operations occur within an Area of Traditional Tribal Cultural Affiliation, as defined herein. This process will follow current departmental referral protocol, including engagement with the tribe(s) through coordination with their Tribal Historic Preservation Officer (THPO) or other tribal representatives. This procedure shall be conducted similar to the protocols outlined under SB 18 (Burton) and AB 52 (Gatto), which describe "government to government" consultation, through tribal and local government officials and their designees. During this process, the tribe may request that operations associated with the clearance or permit be designed to avoid, minimize, or mitigate impacts to tribal cultural resources, as defined herein. Examples include, but are not limited to, conducting a site visit with the THPO or their designee to the existing or proposed cultivation site, requiring that a professional cultural resources survey be performed, or requiring that a tribal cultural monitor be retained during project-related ground disturbance within areas of sensitivity or concern. The County shall request that a records search be performed through the California Historical Resources Information System (CHRIS). (On file)
15. Phase 1 Cultural Resource Inventory Report for Maromo, LLC, APNs 107-144-020 and 107-144-021, Humboldt County, California, prepared by DZC Archaeology & Cultural Resource Management, Arcata, California, prepared May 2018. (On-file and confidential)

1. PROJECT SUMMARY

1.1. PROJECT OBJECTIVE

Maromo, LLC is proposing to permit existing medical cannabis cultivation activities in accordance with the County of Humboldt's (County) *Commercial Medical Marijuana Land Use Ordinance* (CMMLUO). The project requires a Special Permit for approximately 10,000 square feet (sf) of outdoor cultivation. The project includes the permitting of existing and proposed facilities appurtenant to the cultivation, including greenhouses and a cultivation facility for drying and curing of medical cannabis. The applicant aims to become fully compliant with State and Local cultivation regulations.

1.1.1. CULTIVATION RELOCATION

The project location has two pre-existing cultivation areas: 1,000 sf of outdoor cultivation (Area "A") located on a south-facing flat terrace on the opposite side of Honeydew Creek from the residence and 12,463 sf of outdoor cultivation (Area "B") near the residence. The applicant proposes to reduce the size of Cultivation Area B to 3,000 sf and relocate 7,000 sf to the other cultivation areas: Cultivation Area A will receive an additional 1,500 sf, for a combined total area of 2,500 sf, and Cultivation Area C will receive 4,500 sf. The total proposed cultivation area for the parcel is 10,000 sf. The purpose of the reorganization is to relocate the cannabis cultivation outside of the Class III stream setback adjacent to Cultivation Area B, as shown on the site plan (Appendix A). The proposed relocation and reorganization will better protect water quality and riparian habitat.

1.2. SITE DESCRIPTION

The project is located at APN 107-144-020 approximately 27 miles north-west of the community of Redway, CA at latitude of 40.2138 and longitude of -124.1154. The subject parcel is approximately 86 acres in size per the County of Humboldt's WebGIS. The site is at an elevation of approximately 500 ft with a Class I watercourse, Honeydew Creek, flowing through the center of the property. Existing development of the site includes a barn (partially used for drying cannabis), and non-cannabis facilities such as a garage and two residences. There is a one-bedroom residence and one three-bedroom residence occupied year-round by the property owner and family.

1.3. LAND USE

The subject property has a General Plan Designation Timber Production and Public Lands as identified by the Humboldt County General Plan and is zoned Agricultural Exclusive. The surrounding parcels are zoned Timber Production Zone, Agricultural Exclusive and Unclassified.

1.4. STATE AND LOCAL COMPLIANCE

1.4.1. STATE OF CALIFORNIA COMMERCIAL CANNABIS ACTIVITY LICENSE

Maromo, LLC has obtained an annual Cannabis Cultivation License for a Small Outdoor commercial operation (License # CCL18-0003405) from the California Department of Food and Agriculture (CDFA).

1.4.2. STATE WATER RESOURCES CONTROL BOARD

Effective June 24, 2019, Maromo, LLC enrolled with the State Water Resources Control Board (SWRCB) for cannabis cultivation activities classified as Tier 1, Low Risk under Order No. WQ 2019-0001-DWQ *General Waste Discharge Requirements and Waiver of Waste Discharge Requirements for Discharges of Waste Associated with Cannabis Cultivation Activities* ("General Order"). A waste discharge identification (WDID) number has yet to be issued. A Site Management Plan (SMP) has been developed and submitted to the SWRCB to satisfy the conditions of the Tier 1, Low Risk enrollment requirements in the General Order.



Water is diverted, stored, and used for domestic and cultivation purposes entirely within APN 107-144-020. The primary water source for domestic purposes is a point of diversion (POD) located on a spring at latitude 40.2144, longitude -124.1197. An additional POD is in Honeydew Creek at latitude 40.2148, longitude -124.1147 and is be used for both domestic and non-commercial agricultural purposes. Both PODs are located on parcel number 107-144-020. An Initial Statement of Diversion and Use (ISDU) has been filed with the SWRCB for the spring POD (Statement # S027231). The applicant holds an appropriative right license (License # 8878) to withdraw from Honeydew Creek. Irrigation of commercial cannabis is supplied by the barn rooftop rain-catchment system (Appendix A). See the e-WRIMS Public Summary page in Appendix D for a list of water rights for the applicant.

1.4.3. NORTH COAST REGIONAL WATER QUALITY CONTROL BOARD

Effective January 5th, 2017 Maromo, LLC enrolled with the North Coast Regional Water Quality Control Board (NCRWQCB) for coverage under Tier 2 of Order No. 2015-0023 *Waiver of Waste Discharge Requirements and General Water Quality Certification for Discharges of Waste Resulting from Cannabis Cultivation and Associated Activities or Operations with Similar Environmental Effects in the North Coast Region* (WDID Number **1B170015CHUM**).

1.4.4. HUMBOLDT COUNTY BUILDING DEPARTMENT AND THE DEPARTMENT OF PUBLIC WORKS

All necessary building permits will be obtained from the Humboldt County Building Department for all existing and proposed structures and supporting infrastructure upon approval of the Special Permit. In addition, a road evaluation has been completed for the subject parcel and the adjoining parcel (APN 107-144-021). The private access drive meets Category 4 standards (Appendix H).

1.4.5. CAL FIRE

The subject property is located within a State Responsibility Area (SRA) for fire protection. Several improvements are proposed to meet SRA requirements, including designating a fire turn-around and pull-out area for emergency vehicles, and management of trees and vegetation around existing structures to maintain the required 100-foot defensible space. All structures on the property meet the 30-foot SRA setback requirement from property lines. There is a hydrant located near the place of residence that meets SRA specifications and is connected to two 2,500-gallon water tanks uphill from the main residence (Appendix A).

In addition, a Less Than 3-Acre Conversion Mitigation Plan has been prepared by Mad River Properties, Inc. for the subject parcel and the adjoining parcel (both parcels are owned by the applicant) to assess the prior conversion of timberland (Appendix G).

1.4.6. CALIFORNIA DEPARTMENT OF FISH AND WILDLIFE

Pursuant to Fish and Game Code section 1600, the applicant has entered into a Streambed Alteration Agreement (Agreement) with the California Department of Fish and Wildlife (CDFW) for the PODs and stream crossings (Notification No. 1600-2017-0877-R1, Appendix E). The applicant will complete the project in accordance with the Agreement, which includes project timing and reporting measures, to protect fish and wildlife resources.

1.4.7. CULTURAL RESOURCES

The applicant has had a cultural resources study completed for the subject parcel and the adjoining parcel (APN 107-144-021). A Phase I Cultural Resource Inventory Report, completed by DZC Archaeology & Cultural Resource Management, was submitted to the Humboldt County Planning & Building Department in May 2018 (Appendix F). The Cultural resources onsite are at least 600 feet



away from cannabis cultivation and associated activities. A nearby footpath will continue to incur low-impact disturbance, but no ground disturbance or cultivation operations will occur within the archaeological site boundary.

If buried archaeological or historical resources are encountered during construction or cultivation activities, the applicant or contractor shall call all work in the immediate area to halt temporarily, and a qualified archaeologist is to be contacted to evaluate the materials. Prehistoric materials may include obsidian or chert flakes, tools, locally darkened midden soils, groundstone artifacts, dietary bone, and human burials. If human burial is found during construction, state law requires that the County Coroner be contacted immediately. If the remains are found to be those of a Native American, the California Native American Heritage Commission will then be contacted by the Coroner to determine appropriate treatment of the remains. The applicant is ultimately responsible for ensuring compliance with this condition.

2. CULTIVATION AND PROCESSING

2.1. PROPAGATION AND INITIAL TRANSPLANT

Juvenile plants are grown from seed and/or propagated on site from 'mother plants' that demonstrate the desired genetics for the specific cannabis strain. Mother plants remain in the vegetative stage solely for propagation and are housed in the garden shed. Cuttings are sampled from the mother plants and are rooted into a growing medium, typically oasis cubes, to produce 'clones.' Once fully rooted, juvenile plants are transplanted directly into 4" pots after 3 weeks into the 500-sf nursery near Cultivation Area B (Appendix A). They are irrigated using hand watering methods. After 4 weeks the clones are then transplanted into 25-gallon pots with a soil/perlite medium and moved to an outdoor cultivation site where they continue their 'vegetative' cycle.

2.2. PRE-CULTIVATION ACTIVITIES

At the start of the growing season, organic potting soil will be amended with horse manure, straw, coconut fibers, bone blood, fish meal, feather meal, bone meal, kelp and bat guano. Amendments may also be added as needed throughout the growing season.

2.3. MIXED LIGHT AND OUTDOOR CULTIVATION PLAN AND SCHEDULE

There is no mixed light cultivation a part of the special permit.

2.4. IRRIGATION PLAN AND SCHEDULE

Juvenile plants are hand-watered until they are transplanted into larger pots. Then, they are watered by drip irrigation 3-4 times per week until the harvest season. Polytube runs the length of the rows and drip emitters are placed at the base of each plant. Each emitter delivers the right amount of water directly to the base of the plants so over watering is not occurring. The monthly Cultivation Activities Schedule in Appendix B details the irrigation activities associated with all cultivation. Maromo, LLC ensures that irrigation is efficiently managed, allowing for daily inspection of each plant by the cultivator.

2.5 HARVESTING, DRYING, AND TRIMMING

Plants that are ready for harvest have their flowering branches removed and suspended in the drying/storage shed near the main residence. All cannabis grown and harvested on the subject parcel is exclusively dried and temporarily stored onsite. The drying process takes approximately one to two weeks, at which time the flowers are bucked into manageable buds, placed in storage bins located in



the drying/storage shed and garage, then transported to an off-site processing facility for trimming and packaging.

2.6 EMPLOYEE PLAN

Maromo, LLC is an “agricultural employer” as defined in the Alatorre-Zenovich-Dunlap-Berman Agricultural Labor Relations Act of 1975 (Part 3.5 [commencing with Section 1140] of Division 2 of the Labor Code), and complies with all applicable federal, state and local laws and regulations governing California Agricultural Employers.

2.6.1 JOB DESCRIPTIONS AND EMPLOYEE SUMMARY

- *Agent in Charge* (1) Full-time: Responsible for business oversight and management of the Maromo, LLC. Responsibilities include, but are not limited to: inventory and tracking, personnel management, record keeping, budget, and liaison with State and County inspectors as needed. This is a part-time to full-time, seasonal position.
- *Lead Cultivator* (1) Full-time: Oversight and management of the day to day cultivation of medical cannabis. Responsibilities include, but are not limited to, plant propagation and transplant, soil management, irrigation, fertilization, pesticide management, and harvest activities. This is a full-time, year-round position.
- *Assistant Cultivator / Processing Manager* (1) Part-time: Provides support to the *Lead Cultivator* in their day to day duties and takes the lead role during times when the *Lead Cultivator* may be off site. Once processing activities commence, the *Assistant Cultivator* duties switch to oversight and management of processing the dried medical cannabis. This is a full-time, seasonal position.
- *Trimmer Laborer* (2) Seasonal: Provides cultivation, harvesting, and processing support including trim machine operation and hand-finish trimming. This is a part-time to full-time, seasonal position.

2.6.2 STAFFING REQUIREMENTS

In addition to the *Agent, Lead Cultivator, and Assistant Cultivator positions*, two (2) seasonal trimmers are employed. The number of seasonal laborers varies based on the needs of the farm during the cultivation, harvest and processing seasons. At the peak of harvest season, there are approximately five (5) employees on site.

2.6.3 EMPLOYEE TRAINING AND SAFETY

On site cultivation, harvesting, and drying is performed by employees trained on each aspect of the procedure, including cultivation and harvesting techniques, use of pruning tools, and proper application and storage of pesticides and fertilizers. All cultivation and processing staff are provided with proper hand, eye, body and respiratory Personal Protective Equipment (PPE). Access to the onsite cultivation and storage and drying facilities are limited to authorized and trained staff.

All employees are trained on proper safety procedure including fire safety; use of rubber gloves and respirators; proper hand washing guidelines; and protocol in the event of an emergency. Contact information for the local fire department, CAL FIRE, Humboldt County Sheriff and Poison Control as well as the Agent in Charge will be posted at the employee restroom. Each employee is provided with a written copy of emergency procedures and contact information. The material safety data sheets (MSDS) are kept on site and accessible to employees.



2.6.4 TOILET, HANDWASHING AND SEPTIC FACILITIES

There is a finished bathroom with an unpermitted septic system at the one-bedroom residence and a permitted septic system at the main 3-bedroom residence. The unpermitted system is proposed to be permitted by the Humboldt County Department of Environmental Health. A portable toilet will be onsite and serviced by the provider during the working season. Portable restrooms will be provided for sites that are more than 100' from existing restroom facilities.

2.6.5 ON SITE HOUSING

Existing development of the site includes a garage, two residences, each of which are occupied year-round by property owner and family. There is a one-bedroom residence and a three-bedroom residence. The residences are separated from cultivation operations. All other full-time and seasonal employees live off site and commute daily to the cultivation site. No new residential structures are proposed as a part of this project.

2.6.6 PARKING

There will be designated parking near the residences and barn.

2.7 SECURITY PLAN AND HOURS OF OPERATION

2.7.1 FACILITY SECURITY

The site is secured by a locked gate on the main access road with a security system. Gates will remain locked at all times. Access to the facilities are limited exclusively to employees, and restricted access signs are posted conspicuously at the entry gates. During the working season the agent in charge will be living in the residence on the property.

2.7.2 HOURS OF OPERATION

Activities associated with cultivation (watering, transplanting, and harvesting) generally occur 5 days per week during daylight hours during the months of operation of April - November. All other activities such as harvesting and drying typically occur no earlier than 8am and extend no later than 10pm during the peak season, which occurs in October.

3 ENVIRONMENT

3.1 WATER SOURCE AND PROJECTED WATER USE

The spring at latitude 40.2144, longitude -124.1197 supplies water for domestic purposes on parcel 107-144-020 exclusively. The other POD located at latitude 40.2148, longitude -124.1147 in Honeydew Creek is used for domestic and non-commercial agricultural purposes. Rain-harvesting off the barn rooftop supplies the irrigation water for cannabis cultivation. The applicant has a final Stream Alteration Agreement (SAA) with the CDFW for the subject parcel and the adjoining parcel (APN 107-144-021). Refer to section 2.4 for a summary of irrigation practices.

The water used for cultivation during a typical year was estimated based on the existing cultivation area, prior use, and the peak seasonal demand (Table 3.1). Variables such as weather conditions and specific cannabis strains will also have a slight effect on water use.

3.2 WATER STORAGE

The table below outlines the existing and proposed water storage onsite. For domestic use, (2) 3,500-gallon tanks are located on a trail near the spring POD and (1) 500-gallon tank near the main residence. In addition, (2) 3,500-gallon watertanks are located uphill from the residence and are used solely for emergency fire storage. To meet the forbearance period for cannabis cultivation, 141,000-gallons of water storage is proposed and being installed outside riparian setbacks on the subject parcel (Table 3.2). Approximately (20) 5,000-gallon watertanks and (2) 20,000-gallon bladders will be plumbed to the barn; 18 of the tanks will be located on the hillside and skid road near the main residence, 2 watertanks will be adjacent to Cultivation Area A (Appendix A). Two (2) 500-gallon watertanks have been connected to the barn rain gutters and water will be pumped from them to the existing waterbladders and proposed watertanks. The applicant has installed the waterbladders outside riparian setbacks near the horse paddock and will utilize them during the 2020 growing season. They may be used as temporary storage while the applicant is in the process of increasing storage capacity.

3.3 SITE DRAINAGE, RUNOFF, AND EROSION CONTROL

Maromo, LLC is enrolled with the SWRCB for Tier 1, Low Risk coverage, and a Site Management Plan (SMP) was developed in 2019, utilizing best practicable treatment or control (BPTC) measures in accordance with the cannabis General Order.

3.3.1 SITE DRAINAGE AND RUNOFF

NorthPoint Consulting Group, Inc. has performed site investigations as part of the development of the SMP to identify, evaluate, and prescribe corrective actions to any outstanding issues with site drainage and runoff.

3.3.2 EROSION CONTROL

The SMP includes erosion and sediment control BPTCs designed to prevent, contain, and reduce sources of sediment. It also includes corrective actions to reduce sediment delivery. Additionally, the SMP requires mulch piles and spoils from any grading to be stored in a designated location away from watercourse. Maromo, LLC has a contract with a construction company to evaluate and remediate roads either yearly or on an as-needed basis to prevent erosion. Garden pots will be covered with living mulch or straw in the winter. Road and stream crossing work will be performed during the dry season and in accordance with the conditions in the SAA.

3.4 WATERSHED AND HABITAT PROTECTION

Adherence to the SMP and SAA ensures that the watershed and surrounding habitat are protected. The cultivation activities and associated structures will be outside of all riparian zones, providing a suitable buffer between the cultivation operation and habitat. Additionally, site development and maintenance activities utilize BPTCs in accordance with the SWRCB's recommendations. Any grading



and earthwork activities will be conducted by a licensed contractor in accordance with approved grading permits and the SMP.

3.5 MONITORING AND REPORTING

Monitoring will be conducted to confirm the effectiveness of corrective measures listed in the SMP to determine if the site meets all Standard Conditions. Inspections will include photographic and hand-written documentation of any controllable sediment discharge sites, including stream crossings, as identified on the site map. Visual inspection will occur at those locations on the site where pollutants or wastes, if uncontained, could be transported into receiving waters, and those locations where runoff from roads or developed areas drains into or towards surface water. The inspection will also document the progress of any plan element subject to a time schedule, or in the process of being implemented. A monitoring plan is included in the SMP.

Onsite monitoring shall occur:

- Before and after any significant alteration or upgrade to a given stream crossing, road segment, or other controllable sediment discharge site. Inspection should include photographic documentation, with photo records to be kept on site.
- Prior to October 15 and December 15 to evaluate site preparedness for storm events and stormwater runoff.
- Following any rainfall event with an intensity of 3 inches precipitation in 24 hours. Precipitation data can be obtained from the National Weather Service by entering the site zip code at <http://www.srh.noaa.gov/forecast>.

An annual report (Order WQ 2019-0001-DWQ) is submitted annually by March 1 to the Regional Water Board. The report includes information from the monitoring documentation.

3.6 ENERGY AND GENERATOR USE

Electricity is currently supplied by PG&E. There are plans to convert to a solar energy system. Maromo, LLC does employ the use of portable generator for backup power. The generator is kept in the garden/storage shed (Appendix A). Cultivation is all outdoor full-sun except for the minimal lighting used for the mother plants, and the generator is not used for cultivation. Maromo, LLC will limit the use of the backup 6500 Honda generator to an as-needed basis, following all guidelines set up by Humboldt County and the State of California. The generator is stored with a drip pan and 5-gallon gasoline containers that have secondary containment for spill prevention.

3.7 USE AND STORAGE OF REGULATED PRODUCTS

3.7.1 FUEL STORAGE

Fuel for the generator and other machinery is stored in secondary containment within the garden/storage shed. All equipment is inspected prior to each use. Maintenance varies based on manufacturers requirements and oil changes for all equipment as well as all other maintenance is done at a certified maintenance facility.

3.7.2 BEST MANAGEMENT PRACTICES

Best Management Practices (BMPs), also known as BPTCs in the Cannabis General Order, are employed when storing, handling, mixing, application and disposal of all fertilizers, pesticides and fungicides. All nutrients, pesticides and fungicides are in a locked storage room, and contained within water-tight, locked and labeled containers in accordance with manufactures instruction. Application rates will be tracked and reported with the end of the year monitoring report required in the SWRCB Cannabis General Order. Employees responsible for application are trained to handle, mix, apply or



dispose of pesticides/fungicides with proper hand, eye body and respiratory protection in accordance with the manufacturer's recommendations. Maromo, LLC uses rubbing alcohol for sanitizing and cleaning.

3.7.3 FERTILIZERS

Fertilizers and amendments used for the cultivation of cannabis include:

- Blood meal
- Bone meal
- Fish meal
- Feather meal
- Horse manure
- Compost
- Granulated kelp
- Bat guano
- Chicken manure

Application amounts and total Nitrogen and Phosphorous are tracked and recorded as part of the annual reporting to the NCRWQCB.

3.7.4 PESTICIDES AND FUNGICIDES

Pesticides and fungicides used for cultivation include:

- Neem

Material Safety Data Sheets (MSDS) have been supplied to the Humboldt County Planning Department along with the initial project application in 2017.

3.8 WASTE MANAGEMENT PLAN

3.8.1 SOLID WASTE MANAGEMENT

Trash and recycling will be kept and stored at the storage area at the residence. The containers will be placed to prevent storm water contamination and leachate from entering or percolating to receiving waters. Solid waste and recycling are self-hauled off-site via trailer about 1-2 times per month to the Fortuna transfer station.

Vegetation matter such as branches and leaves are composted near Cultivation Area B (see the site plan in Appendix A). Soil will be left in the garden pots and planted with cover crop or mulched prior to the rainy season.

3.8.2 IRRIGATION RUNOFF MANAGEMENT

The water management plan aims to irrigate at agronomic rates, using drip emitters. Refer to section 2.4 for a summary of irrigation practices. No evidence of water movement and erosion in the cultivation area was observed during the site assessment. Maromo, LLC will apply amendments and fertilizers per label specifications.

3.8.3 CULTIVATION WASTE AND SOIL MANAGEMENT

Cultivation vegetative matter such as root balls, branches, and leaves are composted along with spent potting soil in a designated area (Appendix A). The compost pile is in a stable location and covered with straw to prevent migration. The spent soil is periodically analyzed by a third party, a local consulting firm providing soil testing, analysis, and management services. After consultation, the soils



may be amended and reused. All packaging from soil amendments and fertilizers will be collected and disposed at an appropriate facility.

3.8.4 WASTEWATER MANAGEMENT

The water management plan aims to achieve an entirely closed-cycle irrigation and nutrient system. Hand watering and drip-irrigation methods minimize the over-irrigation of plants and subsequent runoff.

There is a finished bathroom with an unpermitted septic system at the one-bedroom residence and a permitted septic system at the main 3-bedroom residence. The unpermitted system is proposed to be permitted by the Humboldt County Department of Environmental Health. A portable toilet will be onsite and serviced by the provider during the working season. Portable restrooms will be provided for sites that are more than 100' from existing restroom facilities.

4 PRODUCT MANAGEMENT

4.1 PRODUCT TESTING AND LABELING

Samples are selected from individual harvested cannabis strains and are tested by a licensed third-party lab in accordance with State and local standards.

4.2 PRODUCT INVENTORY AND TRACKING

The applicant has enrolled in the California Cannabis Track & Trace (CCTT) METRC program and is in compliance with all METRC regulations. The Agent in Charge and Lead Cultivator will ensure all cannabis from seed/clone to packaged product is tracked, accounted for, and inventoried. Records are kept at each phase of the harvest and processing operation for reporting and compliance with State and Local regulations.

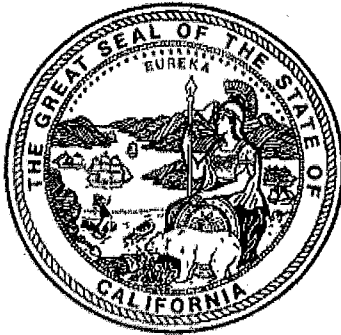
4.3 TRANSPORTATION AND DISTRIBUTION

Transportation will be handled by a third-party, contracted, licensed transporter/distributor in accordance with State and Local regulations. All merchantable product will be distributed through licensed commercial cannabis dispensaries. Prior to moving packages from the on-site holding facility to another physical location, a transport manifest will be created by the distributor/transporter and will include:

- Product ID numbers and product weight
- Route to be travelled
- Origin and destination addresses
- Time of departure
- Time of arrival

The *Agent in Charge* and the *Processing Manager* are responsible for performing a physical inventory of all packages being transported and ensuring that the physical inventory coincides with the transport manifest.

Pursuant to Water Code sections 100 and 275 and the common law public trust doctrine, all rights and privileges under this right, including method of diversion, method of use, and quantity of water diverted, are subject to the continuing authority of the State Water Board in accordance with law and in the interest of the public welfare to protect public trust uses and to prevent waste, unreasonable use, unreasonable method of use, or unreasonable method of diversion of said water.
12. The State Water Board reserves jurisdiction over this registration to change the season of diversion and rate of diversion based on later findings of the State Water Board concerning availability of water and the protection of beneficial uses. Any action to change the authorized season of diversion and rate of diversion will be taken only after notice to interested parties and opportunity for hearing.
13. Right holder shall grant, or secure authorization through right holder's right of access to property owned by another party, the staff of the State Water Board, and any other authorized representatives of the State Water Board the following:
 - a. Entry upon property where water is being diverted, stored, or used under a right issued by the State Water Board or where monitoring, samples and/or records must be collected under the conditions of this right;
 - b. Access to copy any records at reasonable times that are kept under the terms and conditions of a right or other order issued by the State Water Board;
 - c. Access to inspect at reasonable times any project covered by a right issued by the State Water Board, equipment (including monitoring and control equipment), practices, or operations regulated by or required under this right; and,
 - d. Access to photograph, sample, measure, and monitor at reasonable times for the purpose of ensuring compliance with a right or other order issued by the State Water Board, or as otherwise authorized by the Water Code.
14. Diversion of water under this right is subject to prior rights. Right holder may be required to curtail diversion or release water stored during the most recent collection season should diversion under this right result in injury to holders of legal downstream senior rights. If a reservoir is involved, right holder may be required to bypass or release water through, over, or around the dam. If release of stored water would not effectively satisfy downstream prior storage rights, right holder may be required to otherwise compensate the holders of such rights for injury caused.

16. All rights are issued subject to available flows. Inasmuch as the source contains treated wastewater, imported water from another stream system, or return flow from other projects, there is no guarantee that such supply will continue.
17. If storage or diversion of water under this right is by means of a dam, right holder shall allow sufficient water at all times to pass through a fishway or, in the absence of a fishway, allow sufficient water to pass over, around, or through the dam to keep in good condition any fish that may be planted or exist below the dam; provided that, during a period of low flow in the stream, upon approval of the California Department of Fish and Wildlife, this requirement will be satisfied if sufficient water is passed through a culvert, waste gate, or over or around the dam to keep in good condition any fish that may be planted or exist below the dam if it is impracticable or detrimental to pass the water through a fishway. In the case of a reservoir, this provision shall not require the passage or release of water at a greater rate than the unimpaired natural inflow into the reservoir. (Fish & G. Code, § 5937.)
18. The facilities for diversion under this right shall include satisfactory means of measuring and bypassing sufficient water to satisfy downstream prior rights and any requirements of the California Department of Fish and Wildlife and the State Water Board's Cannabis Policy.
19. This right does not authorize any act which results in the taking of a threatened, endangered, or candidate species or any act which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish and Game Code section 2050 et seq.) or the federal Endangered Species Act (16 U.S.C.A. section 1531 et seq.). If a "take" will result from any act authorized under this water right, the right holder shall obtain authorization for an incidental take prior to construction or operation of the project. Right holder shall be responsible for meeting all requirements of the state and Federal Endangered Species Acts for the project authorized under this right.
20. This right is subject to the submittal of an annual report of water use and satisfactory renewal, on forms to be furnished by the State Water Board, including payment of the then-current annual renewal fees. (Wat. Code, § 1228.5.)
21. This right shall be totally or partially forfeited for nonuse if the diversion is abandoned or if all or any part of the diversion is not beneficially used for a continuous period of five years.
22. This right is subject to enforcement, including but not limited to revocation, by the State Water Board if 1) the State Water Board finds that the right holder knowingly made any false statement, or knowingly concealed any material fact, in the right; 2) the right is not renewed as required by the conditions of this certificate; or 3) the State Water Board finds that the right holder is in violation of the conditions of this right. (Wat. Code, § 1228.4 et seq.)
23. The State Water Board intends to develop and implement a basin-wide program for real-time electronic monitoring and reporting of diversions, withdrawals, releases, and streamflow in a standardized format if and when resources become available. Such real-time reporting will be required upon a showing by the State Water Board that the program and the infrastructure are in place to accept real-time electronic reports. Implementation of the reporting requirements shall not necessitate amendment to this right.

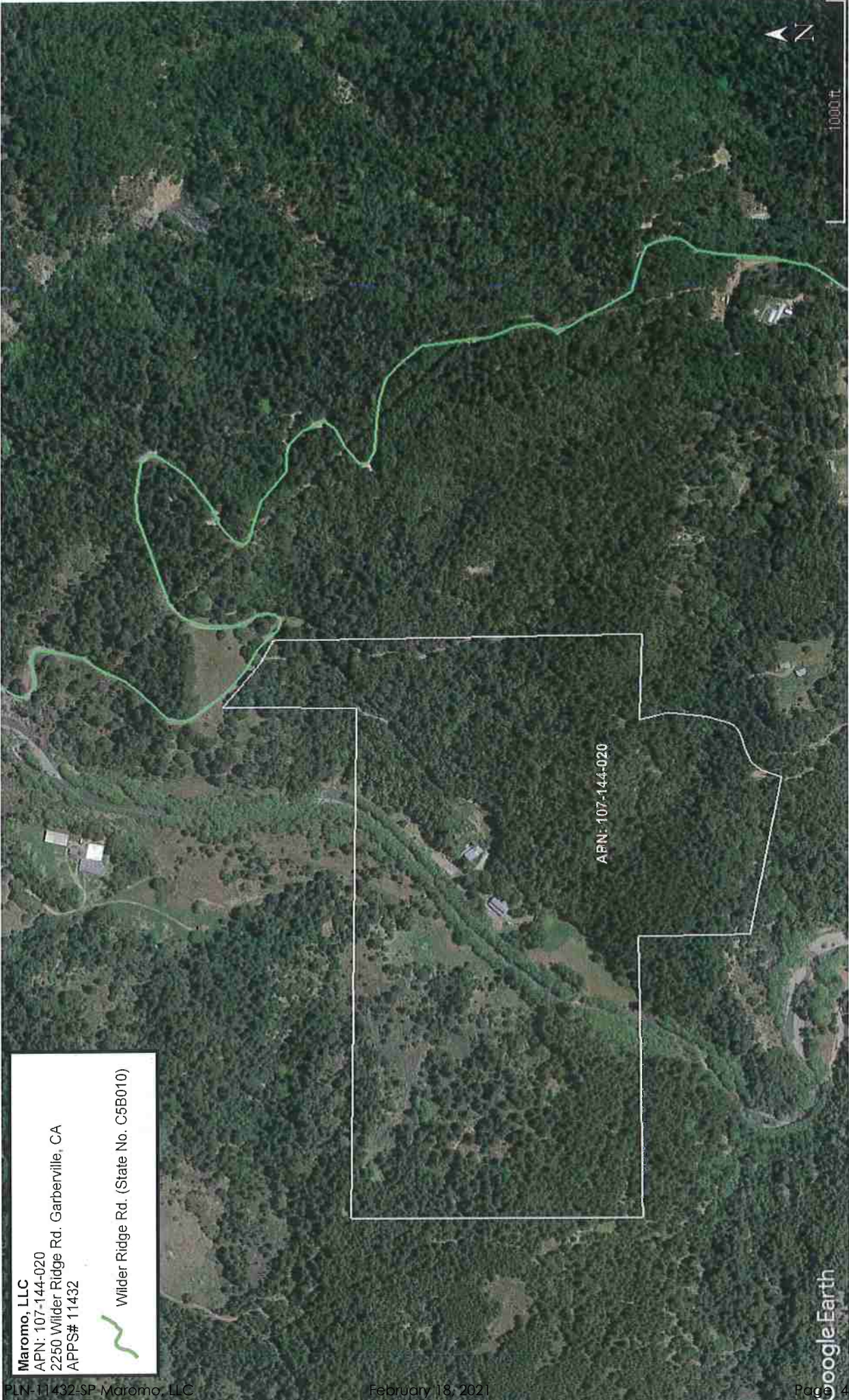

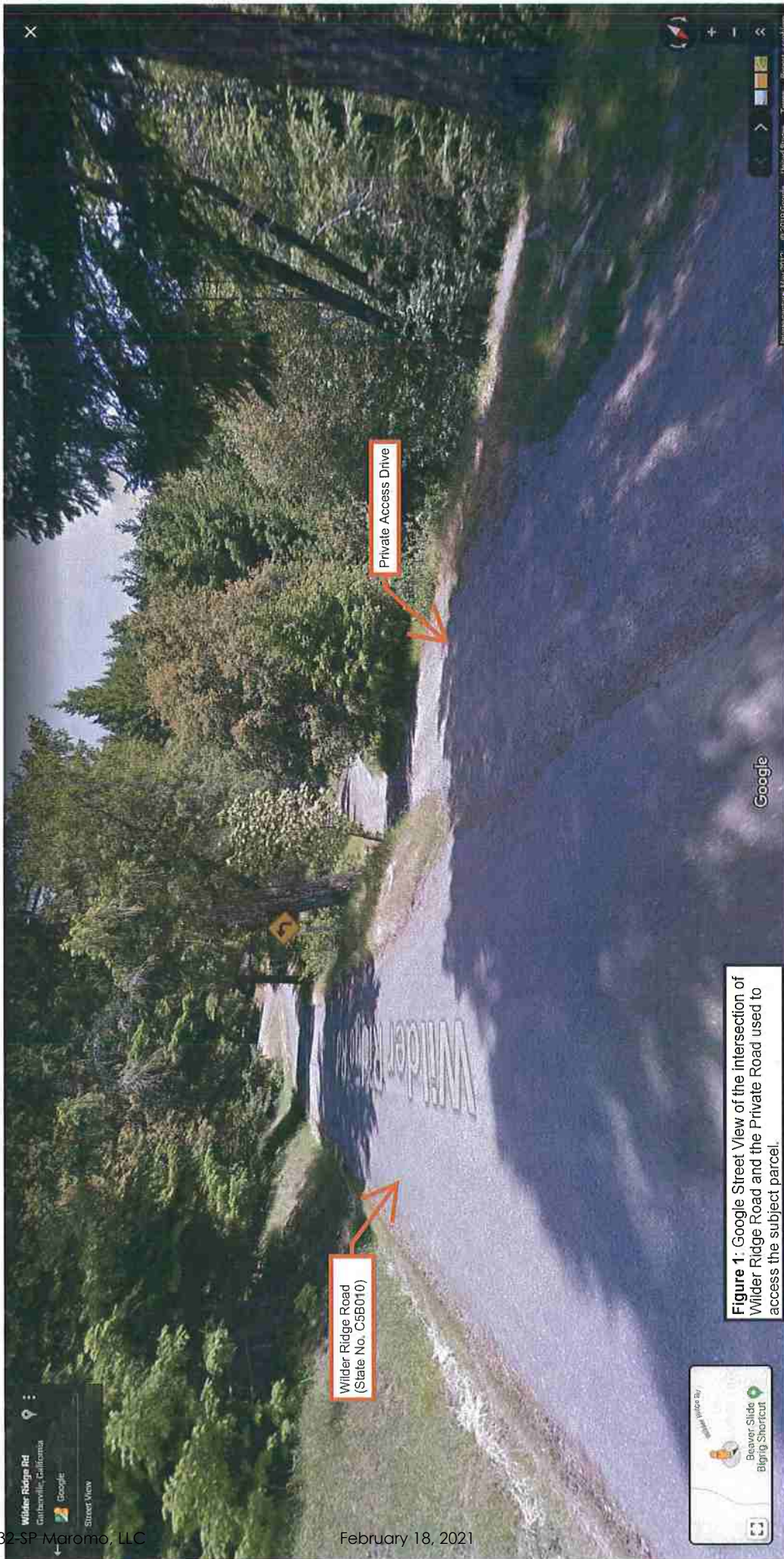


Figure 1: Google Street View of the intersection of Wilder Ridge Road and the Private Road used to access the subject parcel.

FIRE SAFE

General:

CALFIRE has responsibility for enforcement of Fire Safe Standards as required by Public Resources Code (PRC) 4290 and 4291. However CALFIRE is not the lead agency in planning development and project permitting. CALFIRE provides input as a contributing agency, generally limited to plan review, and is not the approving agency for these projects.

Local Responsibility Areas:

Should this project include Local Responsibility Area (LRA) lands, CALFIRE has no direct fire safe input on those parcels. However, in those areas with LRA parcels adjacent to State Responsibility Area (SRA) land, CALFIRE recommends that local standards be applied that are consistent with those CALFIRE makes for SRA lands.

State Responsibility Areas:

Should this project include State Responsibility Area (SRA) lands, the following are CALFIRE's Fire Safe minimum input and recommendation for any and all development.

1. In Humboldt County, developments must meet minimum fire safe standards by constructing the project in conformance with County Fire Safe Ordinance 1952, which the California Board of Forestry and Fire Protection has accepted as functionally equivalent to PRC 4290. The County Fire Safe Ordinance provides specific standards for roads providing ingress and egress, signing of streets and buildings, minimum water supply requirements, and setback distances for maintaining defensible space.
2. New buildings located in any Fire Hazard Severity Zone within State Responsibility Areas shall comply with the 2007 California Building Code (CBC) Section 701A.3.2. This requires roofing assemblies, attic and eave ventilation, exterior siding, decking and deck enclosure, windows and exterior doors, and exposed under floor areas that are approved "ignition resistive" in design.
3. All development, especially commercial or industrial development, should be designed to comply with the most current versions of the following standards:
 - a) California Fire Code (CFC) — for overall design standards
 - b) Public Utilities Commission (PUC) General Order 103 — for design of water systems
 - c) National Fire Protection Association Standards (NFPA) for fire flow minimums and other design questions not specifically covered by CFC and PUC
 - d) Housing and Community Development Codes and Standards —for mobile home parks and recreational camps
4. For Department of Real Estate reporting purposes, fire protection coverage in SRA is generally described as follows:

During the declared fire season (usually June through October) CALFIRE responds to all types of fires and emergencies in SRA.

During the remainder of the year (winter period), CALFIRE responds to emergency requests with the closest available fire engine, if a response can reasonably be expected to arrive in time to be effective. A fire engine is usually available somewhere in the Unit, but may have an extended response time.

There are many hazards confronting fire protection agencies in most subdivisions on SRA lands. Steep terrain and heavy wildland fuels contribute to fire intensity and spread. The distances from fire stations and road grades encountered usually create an excessive response time for effective structure fire suppression purposes.

Subdivisions increase fire risks from additional people and increase probable dollar losses in the event of fire due to added structures and improvements.
5. If the project expects to produce densities consistent with a major subdivision, the impacts on all infrastructures should be mitigated. Local government more appropriately provides the responsibility for high-density area protection and services. Annexation or inclusion into Local Responsibility Area should be studied as well.

6. CALFIRE does not support development in areas where there is no local agency fire service for structure fires and emergency medical response. Fire services should be extended into service gap areas as a condition of development. New development can adversely impact existing fire services. Careful consideration must be given where development may overload the local fire service's ability to respond.

RESOURCE MANAGEMENT

CALFIRE has enforcement responsibility for requirements of the Z'berg—Nejedly Forest Practice Act of 1973. CALFIRE is also the lead agency for those parts of projects involving the scope of the Forest Practice Act. The following basic input will cover the majority of projects. Each project will be reviewed with additional input sent at a later date, if needed.

The following comments reflect the basic Resource Management policies of the Board of Forestry and Fire Protection and CALFIRE on CEQA review requests. These policies apply to both Local and State Responsibility Areas.

1. If this project reduces the amount of timberland, by policy, the Board of Forestry and CALFIRE cannot support any project that will reduce the timberland base of California. "Timberland" means land which is available for, and capable of, growing a crop of trees of any commercial species used to produce lumber and other forest products, including Christmas trees regardless of current zoning (PRC 4526). However, if the zoning and intended use are consistent with the county's general plan; and if no land other than timberland can be identified to site the project; then CALFIRE may choose not to oppose the project.
2. If any commercial timber operations are involved with a project, the timber operations cannot be conducted without a CAL FIRE permit. Commercial timber operations include the cutting or removal of trees offered for sale, barter, exchange, or trade or the conversion of timberlands to land uses other than the growing of timber (PRC 4527). Contact your nearest CAL FIRE Resource Management office for guidance on obtaining the necessary permits.
3. If any timberlands are being converted to a non-timber growing use by this project, the conversion operations cannot be conducted without a CAL FIRE permit (PRC 4621). Conversion of timberland takes place when trees are removed and the land use changes, even without the sale, barter, exchange, or trade of the trees. Contact your nearest CAL FIRE Resource Management office for guidance on obtaining the necessary permits.
4. If timberland is in the viewshed of a project, the current and future owners should be overtly notified that changes will occur to their views due to timber management activities. Further, no project should be allowed to negatively affect access to timberland for timber management purposes; neither on the project parcel(s) nor any other timberland parcels.
5. If timber harvesting has occurred and post-harvest restocking and prescribed erosion control maintenance obligations have not been met on a parcel, future owners should be overtly notified (14 CCR 1042). The current owner of a parcel is responsible for restocking requirements and maintenance of roads whether or not they were involved in the actual harvest plan.
6. If the project involves the development of parcels zoned as Timber Production Zone (TPZ), CALFIRE cannot support the project. Dividing TPZ land into parcels of less than 160 acres requires a Joint Timber Management plan prepared by a Registered Professional Forester (RPF), recorded as a deed restriction for a minimum of 10-years on all affected parcels, and approved by a four – fifths vote of the full board (Govt. Code 51119.5). TPZ may be rezoned using a "Ten Year Phase Out," which precludes the need for a Timberland Conversion Permit. CALFIRE opposes immediate rezoning of TPZ land.

CANNABIS PROJECTS

Local Responsibility Areas:

CAL FIRE is the primary command and control dispatch center for many local agency fire districts and departments. Potential life hazard threats associated with a project must be identified and documented for the protection of the public and first responders. Projects which include timber harvesting or conversion of timberland are subject to the Forest Practices Act and Rules, regardless of wildland fire responsibility area.

State Responsibility Areas:

Should this project include State Responsibility Area (SRA) lands, the following are CAL FIRE's minimum input.

Conversion of timberland to a non-timber producing use is subject to permit from CAL FIRE. Commercial timber harvesting operations to facilitate cannabis cultivation and processing are subject to permitting and regulation under the Forest Practice Act and Rules. Please refer to the RESOURCE MANAGEMENT comments.

General Recommendations:

The following recommendations are made by CAL FIRE with the understanding that most areas of Humboldt County do not have a paid fire department providing fire prevention services.

1. Cannabis growing operations shall have easily accessible safety data sheets (SDS) for all chemicals and hazardous materials on site. Commercial operations must have a current Hazardous Materials Business Plan on file with Humboldt County Environmental Health, where applicable.
2. California Health and Safety Code (HSC 11362.769.) Requires that indoor and outdoor medical marijuana cultivation shall be conducted in accordance with state and local laws related to land conversion, grading, electricity usage, water usage, water quality, woodland and riparian habitat protection, agricultural discharges, and similar matters.
3. Cannabis growing and extraction shall be in accordance with Chapter N101.1 of the International Fire Code, the International Building Code, and the International Mechanical Code. Hazardous materials shall comply with Chapter 50. Compressed gases shall comply with Chapter 53. Cryogenic fluids shall comply with Chapter 55. Flammable and combustible liquids shall comply with Chapter 57. LP-gas shall comply with Chapter 61 and the International Fuel Gas Code. All applicable California State Fire Marshal standards and regulations for the designated occupancy must be met.
4. Growing and processing of cannabis is generally an agricultural operation. However, manufacture of marijuana extracts and concentrates are commercial or industrial activities, and may be subject to the county's SRA Fire Safe Ordinance. Any new residential units associated with cannabis cultivation and processing may also be subject to the SRA Fire Safe Ordinance. All materials hazardous and non-hazardous associated with the extraction process shall be utilized in conformance of the law and fire safe codes.
