Dear Richard McLennan:

On 09/04/2018 the California Department of Fish and Wildlife (CDFW) received your Notification of Lake or Streambed Alteration (Notification). On 10/09/2018, your Notification was deemed complete due to the passage of 30 days with no action taken place by CDFW to incomplete your Notification.

The Department is required to submit a draft Lake or Streambed Alteration Agreement (Agreement) to you within 60 calendar days from the date the Notification is complete. Therefore, the Department had until 12/08/2018 to issue you a draft Agreement or inform you that an Agreement is not required. Due to current staffing limitations, the Department did not meet that date. As a result, by law, you may now complete the **project described in your notification** without an Agreement.

Please note that pursuant to Fish and Game Code (FGC) section 1602, subdivision (a)(4)(D), if you proceed with this project, **it must be the same as described and conducted in the same manner as specified in the notification and any modifications to that Notification received by CDFW in writing prior to the date of this letter.** This includes completing the project within the proposed term and seasonal work period and implementing all avoidance and mitigation measures to protect fish and wildlife resources specified in the notification. If the term proposed in your notification has expired, you will need to re-notify CDFW before you may begin your project. Beginning or completing a project that differs in any way from the one described in the notification may constitute a violation of FGC section 1602.

Your notification includes, but is not limited to, the following information: Water well used for commercial and domestic irrigation located at (lat./long): 40.265791, -124.043799. Season of diversion for cannabis irrigation starting, April 1st and ending, September 31st at a diversion rate of 2 gpm and domestic use, year round at a diversion rate of 2 gpm. CDFW did not evaluate hydraulic connection of the well to surface water, nor was a hydrogeologic evaluation prepared by a licensed geologist provided for CDFW review.

This letter does not retroactively permit any stream crossings, water diversions or other encroachments not described above. No other projects that may be subject to FGC1602 were disclosed.

Also note that while you are entitled to complete the project without an Agreement, you are still responsible for complying with other applicable local, state, and federal laws. These include FGC sections 5650 and 5652 which make it unlawful to pollute waters of the state. FGC section 5650 makes it unlawful to deposit in, permit to pass into, or place where it can pass into waters of the state any substance or material deleterious to fish, plant life, mammals, or bird life, including, but not limited to gasoline and oil, as well as sediment. FGC section 5652 makes it unlawful to deposit in, permit to pass into, or place where it can pass into waters of the state, or to abandon, dispose of, or throw away, within 150 feet of the high water mark of the waters of the state, any garbage, refuse, or waste, among other materials. A person who violates FGC sections 1602, 5650, and 5652 in conjunction with the cultivation or production of cannabis is subject to significant penalties or fines. Specifically, CDFW may impose civil penalties administratively against any person found by CDFW to have violated these FGC sections in connection with the production or cultivation of cannabis following a complaint and, if requested, a hearing.

Other statutes in the FGC that might apply to your activity, include, but not limited to the following sections: 2080 et seq. (species listed as threatened or endangered, or a candidate for listing under the California Endangered Species Act); 1908 (rare native plants); 3511, 4700, 5050, and 5515 (fully protected species); 3503 (bird nests and eggs); 3503.5 (birds of prey); 5901 (fish passage); 5937 (sufficient water for fish); and 5948 (obstruction of stream), and the requirements set forth in the Forest Practice Act (Pub. Resources Code, § 4511 et seq.) for projects on private timberlands.

Finally, if you decide to proceed with your project without an Agreement, you must have a copy of this letter and your notification with all attachments available at all times at the work site. As indicated in your Notification, the Applicant agrees to allow CDFW employees access to any property it owns and/or manages for the purpose of inspecting and/or monitoring the activities covered by this Notification, provided CDFW: a) provides advance notice; and b) allows the Applicant or representatives to participate in the inspection and/or monitoring. This condition does not apply to CDFW enforcement personnel. Please note this letter is only valid until **12/08/2023**, which is 5 years from the date the Department was required to provide a Draft Agreement.

Briefly describe the entire project:

Rabbit Ridge Ranch will be cultivating commercial cannabis with a Small Mixed-Light Tier 2 license utilizing 7,185 sq ft of canopy space and a Specialty Outdoor utilizing 2,815 square feet of canopy space, for a total of 10,000 sq ft of canopy space. The water source for the project is the well identified on the site plan and referred to in the Division of Environmental Health Attachment as being well permit number 16/17-0710. Water will be stored in the water tanks identified on the site plan. The project will use 800 to 900 gallons of water per day.

Drainage from the site will be minimal owing to the use of drip irrigation. Berms and fabric barriers will be used if necessary. Owing to the topography of the property there is little chance of irrigation drainage reaching a water course.

All fertilizers, pesticides, or other regulated products are kept in enclosed plastic containers and locked in a steel storage unit.

Outdoor cultivation is minimal. Soil preparation will take place from January to March. The plants are moved outdoors through October. Weeding and soil cultivation will take place through August with harvesting beginning at the end of August. Drying and trimming will be conducted in October thru November.

Deprivation cycle 1 starts with a March planting. Weeding and soil cultivation continues through end of May, beginning of June. Harvest is at the end of June, with drying and trimming conducted from the end of June through the beginning of July.

Deprivation Cycle 2 starts June. Planting in the greenhouse starts the beginning of July. Weeding and soil cultivation proceeds through the end of August or the beginning of September. Harvest is in the beginning of September. Trimming and drying is conducted through the end of September.

Processing will be limited to drying and flower trimming.

There will be one outdoor harvest cultivation cycle per year and two light deprivation indoor cycles per year.

Security will be provided by fencing and observations from the residence on the property.
