WHEREAS, On January 29, 2021 the California Department of Housing and Community Development (HCD) issued a Notice of Funding Availability (NOFA) for 2020-2021 Community Development Block Grant (CDBG) program; and

WHEREAS, The County of Humboldt ("County" or "Applicant") is eligible to apply for up to \$1,500,000 from the CDBG 2020-2021 NOFA; and

WHEREAS, The CDBG funding is made available to assist Low and Moderate income persons with specific eligible activities; and

WHEREAS, On March 5, 2021, staff with the Humboldt County Planning and Building Department held a properly noticed public meeting to describe the funding available and eligible uses; and

WHEREAS, after receiving proposals for funding from members of the public and service providers, staff has prepared a proposal to utilize the CDBG 2020- 2021 funding; and

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the County Board of Supervisors of the County of Humboldt as follows:

#### **SECTION 1:**

The County Board of Supervisors has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$895,050 for the following CDBG activities, pursuant to the January 2021 CDBG NOFA not to exceed:

Public Service- Humboldt Senior Resource Center- Behavioral Health	\$ 145,050
Housing – Homebuyer Assistance Loans	\$ 500,000
Planning and Technical Assistance	\$ 250,000

# **SECTION 2:**

The County hereby approves the use of Program Income in an amount not to exceed \$8,000 for the CDBG activities described in Section 1.

#### **SECTION 3**:

The County acknowledges compliance with all state and federal public participation requirements in the development of its applications.

If an application is approved, the Planning and Building Director, or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.
