3. Describe how the scope of your proposal fits the intent of Measure Z. Specifically, how will it maintain and improve public safety and essential services, as described on the previous page? (750 character limit)

Homelessness, mental illness and addiction have a profound effect on our community and addressing these issues has been the highest priority for the City of Eureka, Eureka Police Department, and UPLIFT Eureka. EPD's Community Safety Engagement Team (CSET) along with the UPLIFT Eureka program have never wavered in our commitment to addressing these issues. Everything about our current, ongoing proposal echoes the purpose behind the Measure Z vision of maintaining and improving public safety. Vulnerable members of our community are getting the help they need through mental health services, addiction care and treatment. The positive effects of these efforts are being felt throughout the city by our businesses, residents, and visitors.

4. Please provide a brief description of the proposal for which you are seeking funding. (1500 character limit)

The Eureka Police Department seeks Measure Z funding to:

Continue to fund a full-time police officer dedicated to the Mobile Intervention and Services Team (MIST)

Continue to fund a full-time Parks & Waterfront Ranger position.

Continue to fund a Homeless Services Coordinator to work with UPLIFT Eureka. This civilian position oversees the daily operations of UPLIFT Eureka, the Co-Pilot program and other fundamental aspects of the program.

Continue to fund our full-time and part-time Homeless Outreach Worker (HOW) positions. These two civilian positions work to provide resources and assistance to our homeless population through UPLIFT Eureka.

Continue to fund a part-time Law Enforcement Assisted Diversion (LEAD) Program Coordinator. This diversion program is the first of its kind in Humboldt County and another valuable piece of the partnership between EPD, UPLIFT Eureka, and the County.

Continue to fund Emergency Homeless Support Services. These funds have been used to support CSET/MIST/UPLIFT Eureka efforts in areas including but not limited to detox, emergency shelter/housing, transportation, and other services essential to successfully serving and housing Eureka's high needs homeless population.

Continue to fund essential training for CSET/MIST, but primarily UPLIFT Eureka staff to enhance their skills, understanding, and expertise in implementing and sustaining successful homeless outreach.

5. How have you developed a plan for sustainability, including diversification of funding sources, for your proposal to carry on without reliance on future Measure Z funds? (750 character limit)

In the event Measure Z funds were no longer available, the City of Eureka would have to eliminate the positions all together or make further personnel cuts or changes within the department to absorb those positions.

UPLIFT Eureka has limited existing funding to run at a less-scalable level outside of the funding requested from Measure Z. This program would have to rely on their established grant monies and would require re-organizations and likely cuts to those positions funded by Measure Z.

6. If this request is for the continuation or expansion of an existing program/service, what is the current source of funding for that program/service? (500 character limit)

Our 2021/2022 Measure Z funding request is a continuation of our current programs and services with no changes. Currently, Measure Z provides the funding for personnel costs for the programs. The EPD MIST Officer and Parks & Waterfront Ranger positions are primarily funded by Measure Z. However, EPD funds portions of their positions not covered by the funds received from Measure Z. These expenditures include uniforms, training, equipment and overtime.

7. If you are awarded Measure Z funds, how do you plan to leverage these funds to secure additional grants, contributions or community support? (500 character limit)

The Eureka Police Department and the city's Economic Development Department, which oversees UPLIFT Eureka, have a good track record for finding and securing funding sources through grants, and would continue to showcase our successes to leverage future grant applications. UPLIFT Eureka and its community partners continue to receive positive media and press. The reputation and success of our Measure Z funded positions and programs continues to grow throughout the community and abroad.



Measure Z Application for Funding - Prior Year Results

Measure Z allowed the Eureka Police Department to conduct enhanced patrol, enforcement, outreach, engagement, and community clean-ups utilizing our Community Safety Engagement Team (CSET), which includes our Measure Z funded MIST Officer and Parks & Waterfront Ranger. EPD created the CSET team around these Measure Z positions to further support the mission and to expand their capabilities. The following are statistics for CSET in calendar year 2020:

Officer Activity:

Self-Initiated activity: 4,320 - team (Measure Z positions - 2,206), Calls for Service (Dispatched) – 1014. 81% of CSET's on-duty activity is proactive (self-initiated). This more frequent outreach and intervention/support has resulted in severely mentally ill and chronically homeless individuals in Eureka receiving more timely and intensive support.

CSET Enforcement Stats: Arrest/Cites – 599, Weapons Seized – 76, Methamphetamine Seized - 6 ounces, Heroin Seized - 1 ounce.

CSET Miscellaneous Stats: Camps/Property Tagged – 181, Abandoned Camps Dismantled – 133, Vehicles Tagged – 59, Garbage Collected - 56,245 lbs. (over 28 tons)

CSET Specialized Statistics: 5150 (Mental Health) Holds – 91, Substance Abuse Treatment (Warm handoffs) – 57, MIST Referrals - 4. CSET handled 30% (170 of 576) of EPD's Mental Health Related Calls for Service (CFS) as the primary officers assigned to the call. CSET placed 30% (91 of 302) of EPD's WI 5150 holds. These holds are usually more difficult cases which are time consuming as they require additional efforts and follow-up with St. Joseph Hospital and Behavioral Health personnel.

On a daily basis, CSET, which includes the MIST Officer and Waterfront Ranger, coordinate services with Humboldt County Department of Health and Human Resources. This includes long and short-term individualized planning, daily engagement with their clients, assisting in locating their clients, and direct requests from DHHS personnel to assist with clients in need of immediate support and/or in crisis. CSET assists DHHS move through the red-tape of bureaucracy, and problem-solve issues from a different perspective, which allows for streamlining solutions. On average, CSET spends approximately one to six hours per day collaborating with DHHS. At times, CSET has spent their entire days assisting DHHS.

Besides daily collaboration with DHHS, CSET also assists and coordinates services with St. Joseph Hospital, both with ER staff and hospital social workers. This includes coordinating services while patients at within their facility and/or after discharge. As Covid-19 has caused all mental health holds to enter their ER prior to placement at a mental health facility, CSET also assists hospital staff with de-escalating individuals and providing tools to assist staff defuse future events. On average, CSET spends approximately one to three hours per day at St. Joseph Hospital.

COVID 19 has affected both CSET and UPLIFT Eureka as modifications have had to be made to keep certain partnerships afloat, and to deal with the ever-changing environmental requirements (masks, social distancing, hand washing) to keep our most vulnerable population healthy. County and State lockdown requirements forced UPLIFT Eureka to temporarily suspend many programmatic components due to safety concerns. The efforts exerted by both CSET and UPLIFT Eureka during this pandemic are not fully exhibited in tangible statistics. However, the following are statistics for UPLIFT Eureka in calendar year 2020:

UPLIFT Eureka is currently serving more than 100 participants. The Job Skills Training Program served 69 individuals this year with 18 of them gaining employment. The program also received more than 125 applications.

Pathway to Payday, a component of the UPLIFT program, has placed over 120 individuals in jobs since November 2018. Participants in Pathway to Payday take part in an employment workshop which focuses on the enhancement of application, resume & interview skills, and offers the opportunity to interview with real employers for real jobs, receiving tangible feedback that they can apply to future interviews. This calendar year approximately individuals took part in Pathway to Payday were more than 215 interviews were conducted and more than 60 job offers received by the participants 15 participants. Of those 13 were offered jobs.

Following the housing first principles, Uplift Eureka operates a rapid rehousing program that in the 2020 calendar year housed 23 individuals in 17 households. It was challenging prior to the COVID outbreak to secure permanent housing in our area and was even more difficult during the pandemic. Even with the added challenges of fire refugees and folks moving to our area to work remotely from higher populated areas, Uplift Eureka staff was able to secure permanent housing and provide supportive services to those housed to ensure that they could stabilize and position themselves for future success.

As the COVID pandemic continues and local case counts increase, CSET and Uplift Eureka continue to answer the call to provide essential public safety services to our most vulnerable community members. CSET and Uplift Eureka provide assistance to community partners and conduct outreach services seven days per week. The level of supportive services needed has increased dramatically during the COVID outbreak, and the Uplift Outreach Team and has stepped forward to meet these needs. Additional services that have been provided include assistance in accessing numerous resources such as Economic Impact Payments, Unemployment Insurance Benefits and Free COVID-19 testing. The Uplift Outreach Team is also ensuring that community members have updated and accurate information regarding access to continued medical care, eviction protections, changing Cal Fresh rules and the latest health and safety guidance. The Uplift Outreach Team has been working closely with the Uplift's Housing Assistance Program to refer participants, secure permanent housing and provide supportive services to ensure those who have been housed are able to stabilize and maintain housing.

Dear Citizen's Advisory Committee Members,

This letter is in support of continuing funding for the City of Eureka's Measure Z funded positions. Since the 2014 passing of Measure Z, the City of Eureka has expanded its ability to proactively engage members of Eureka's homeless community, many of whom suffer from mental illness, addiction, and trauma.

The Eureka Police Department's (EPD) Community Safety and Engagement Team (CSET) and the City of Eureka's Uplift Eureka program, much of which is funded by Measure Z, works daily towards long-term solutions to improve the lives of individuals and the overall health of the community. In 2020 alone, CSET and Uplift helped connect 57 individuals directly to substance abuse treatment facilities. CSET and Uplift recognize that a dual approach of compassion and accountably must be used to improve lives while maintaining order in the community.

The MIST Officer (Mobil Intervention and Service Team) is responsible for proactive engagement and coordination of various services for those within Eureka's homeless community specifically those suffering from mental illness, addiction, and trauma. Besides proactive activity, the MIST Officer has expanded services to include responding to calls-for-service with individuals having a mental health crisis to help stabilize individuals and connect them with resources. Moreover, the MIST Officer is requested daily by DHHS Behavior Health and other partnered government and non-profit organizations to assist in providing services to their clients.

While some might be tempted to curtail this funding given the City was able to pass a recent tax measure, that would be unwise at this time, in my opinion, for several reasons. The tax measure specifically states "maintain" not increase level of services. Additionally, the tax measure does not go into effect until July 1 of this year so the actual amount of taxes that might be received is very unknown at this time. Lastly, and perhaps this one is even more important to the partnership between the County of Humboldt and the City of Eureka, without our continued investment in the CSET, MIST and Uplift programs, the county could possibly be left in the position of having to bring on more staff of our own to take over the workload.

This program has proven to be vital for the City of Eureka and Humboldt County as a whole. I strongly recommend continuing the City of Eureka's Measure Z funded positions.

In my work engaged with people experiencing homelessness, both EPD programs, and the personnel associated with them, have been great partners in the work of supporting members of our community as they strive to increase the health and safety in their lives.

CSET embodies the principles that make the program effective in the community. They are true community partners, regularly engaging with other programs and organizations to ensure that CSET is a meaningful part of a community-wide effort to protect and promote the safety of all citizens. Their focus on addressing the social issues that lead to criminal behavior is unique in law enforcement and is evidence-based, leading to positive outcomes community wide.

Law enforcement agencies have always provided social services. Research shows that effective prevention, intervention and stabilization cannot be implemented by a single agency alone but relies on collaborative relationships between many agencies within a community. In their Guide to Critical Issues in Policing, the Department of Justice lists *Police Encounters with Persons with Mental Illness/Behavioral Health Challenges* as third on its list of critical issue topic areas and *Community Policing* as number five. The Eureka Police Department is responding to community-based needs through the creation of CSET and the implementation of the Uplift Program.

Specifically, EPD's law enforcement officers have experience and training related to community members experiencing mental health (behavioral health) crises. They offer compassionate service to the individual and the community-at-large. The officers are essential partners with behavioral health providers, particularly during a crisis, and are the first responders who facilitate the person in crisis getting connected to the resources they need. Addressing behavioral health and social needs reduces criminal/anti-social activity associated with survival on the streets. Addressing social and behavioral needs has the potential to disrupt the cyclical nature of incarceration and release that hasn't worked at creating safer, more livable communities.

The Uplift Program's staff focuses on, and engages with, people experiencing homelessness. Staff create and maintain meaningful relationships, an essential part of supporting people as they work toward change. Relationship-based practice increases the likelihood of change that is maintained over time because it takes into consideration contextual factors such as poverty, trauma, social exclusion, and stigma. It seeks to understand and connect rather than dismiss and exclude (or incarcerate). Uplift staff offer concrete solutions to the barriers that people experiencing homelessness encounter and walk with the person experiencing the challenges. They provide connections to housing, to social services, to food, clothing, employment, medical care and to behavioral health services. In addition to connecting

people to services and resources, Uplift staff model behaviors and skills that empower individuals to identify goals, create plans to implement those goals and then achieve those goals.

On November 1, 1977 former vice president Hubert Humphrey, at the dedication of a building in Washington DC named after him said: "The moral test of government is how that government treats those who are in the dawn of life, the children; those who are in the twilight of life, the elderly; those who are in the shadows of life, the sick, the needy and the handicapped". With Measure Z funding, EPD is able to maintain its commitment to the members of our community who find themselves in the shadows of life. Supporting people as they transition toward health and out of poverty and the experience of homelessness benefits the entire community. Please approve the application submitted from the Eureka Police Department and support law enforcement's efforts to improve individual and community health and welfare.

Eureka Police Department's CSET Unit and the Uplift Community Outreach have continued to work closely with our St. Vincent de Paul (SVDP) Dining Facility in 2020 and prior. Their ongoing presence has dramatically improved the relationships with many of our daily luncheon clientele, which are largely individuals living a "homeless" existence that suffer from various issues of "mental health, substance abuse, and / or a dysfunctional family history". The atmosphere during our daily luncheon service and in our surrounding neighborhood has become more harmonious through the efforts of Sargent Leonard LaFrance, MIST Officer Ryan Swanson, Ranger Dennis Gagnon, Homeless Outreach Worker Larry Alexander, Homeless Outreach Worker Robert Williams, Homeless Outreach Worker Sarah Cooper, Case Manager Belen Gutierrez-Flores, and Homeless Services Coordinator Brandey Wheeler!

In March 2020, the City of Eureka provided our Dining facility a "street blocking permit", so luncheon guests could sit on folding chairs placed "socially distanced apart" on the street in front of our building. City administrators also secured a "handicap-access outdoor toilet" and two "handwash stations" for luncheon guests sanitary needs while on our Dining Facility property.

With the COVID-19 health emergency controlling how businesses operated and restricting social interactions across global society, the SVDP Dining facility was challenged to keep their daily free luncheon service available to the locally displaced community! The CSET Unit quickly helped our kitchen staff design an outdoor lunch service model, which included social distancing markings on the sidewalk in front of our building. CSET also put together an information board, which they updated daily with various COVID-related information. And before each outdoor lunch service, they would announce by megaphone the daily COVID news and instruct luncheon guests about sanitary compliance (*handwashing, wearing face masks, and maintaining 6-foot separation in the serving line*).

When the "*shelter-in-place*" directives were issued in March 2020, 80% of SVDP's regular Volunteers opted to stay home, as many were retirees with existing health concerns. With only two full time staff, our Dining Facility was faced with closing operations due to lack of manpower. Fortuitously, *Uplift Outreach* quickly offered their staff to help with the morning luncheon prep! Each day, 2-3 Uplift staff would arrive at our Dining Facility by 8:30 AM and assist with various kitchen prep duties until the lunch service began at 11:00 AM. During lunch service, Uplift staff would hand out *Face Masks* to lunch clientele, direct *Social Distancing* in the serving line as needed, and also conduct some of their outreach services with the luncheon guests seeking assistance. From early March to September 2020, our Dining Facility had served lunch for 195-consecutive days! This could not have happened without help from *Uplift Outreach* and some dedicated SVDP *Volunteers* that offered even more service duty than before the health emergency! The SVDP Dining Facility has been blessed by generous community support throughout these challenging times!

Our SVDP kitchen staff, volunteers, business neighbors, and citizens walking through our neighborhood need to feel safe. The *CSET Unit* and *Uplift Outreach* have maintained a secure environment around our facility! SVDP's kitchen staff and volunteers care greatly about the clientele that are provided a daily nutritious meal. Our facility also offers additional services from various collaborative agencies – *Betty Chinn* (showers), *SJH Community Resource Center* (community outreach), *Open Door Mobile Medical* (primary healthcare), *Councilperson Leslie Castellano* (art class), and others. The ongoing efforts to ensure a safe and harmonious environment is of paramount concern to many individuals affiliated with the daily on goings at the SVDP Dining Facility! Everyone involved appreciates the presence of the *CSET Unit* and *Uplift Outreach* staff!

Speaking for all that have been mentioned above, we hope the necessary funding will be made available to continue the ongoing support from the *CSET Unit* and *Uplift Outreach*! If you require further information in this matter, please contact me.

Papa & Barkley operates 3 facilities, collectively employing several dozen people, in Old Town/downtown Eureka. We rely heavily on the Eureka Police Department, including officers and staff associated with CSET, to keep our people and property safe. We run multiple shifts and therefore have employees who arrive in the dark, or leave work in the dark.

Our Facility Intelligence Coordinators (security staff) contact EPD to deal with situations like people in mental health crises, dealers selling scary hard drugs on the street, and the like. We contact EPD with 3-5 non-emergency calls per month, and 1-2 that are legitimate emergencies. Our interactions with the Department on these calls is consistently professional and positive. David Salas, one of our senior Facility Intelligence Coordinators wrote this to me: "The CSET Team is great with their coverage in our area--it's been a big improvement."

The enhanced EPD presence and associated services such as homeless services enabled by Measure Z funds clearly makes a difference to the quality of life in these areas.

I'll add that, if this is true of our company, with our own security and cameras covering every door, it has to be doubly true of smaller businesses that don't have this level of security infrastructure.

For these reasons, we strongly support the ongoing allocation of Measure Z funds to the Eureka Police Department.

I am writing to express my support for the Eureka Police Department's 2021 Measure Z Application to assist in funding positions in their Community Safety Engagement Team (CSET) and Uplift Eureka unit. Together CSET and Uplift Eureka provide a critical service to our community, our citizens, businesses, visitors and particularly to those individuals and families that are struggling with addiction, trauma, mental illness, homelessness and poverty.

CSET and Uplift Eureka have been successful in past budget cycles in improving public safety and addressing crime and disorder problems in Old Town, along the waterfront and in city parks. By proactively engaging members of Eureka's homeless community, CSET and Uplift Eureka work collaboratively to connect all members of this community to needed resources to address the underlying causes of crime and disorder.

In the year 2020, CSET conducted 4,320 self-initiated contacts and responded to 1,014 callsfor-service, 170 of which were mental health related. These contacts resulted in connecting 57 individuals directly into substance abuse treatment facilities, and placed 91 individuals experiencing a mental health crisis on a 5150 W&I Code hold. CSET also connects individuals with medical and mental health services, housing, employment, clothing, food and is coordinating and implementing the COVID-19 response within the homeless community.

These are critical services serving a critical population that if not addressed proactively by the specially trained and highly skilled CSET and Uplift Eureka team, would lead to escalated situations of crisis, increased crime and unacceptable anti-social behavior that would have negative impacts on our community.

In my experience as a former law enforcement/corrections professional (33 years), and former Eureka City Council Member (2011-2016), I am very much aware of the issues and underlying causes that can lead to incarceration and homelessness, as well as the challenges facing our community to effect change, improve the lives of others while increasing public safety. I strongly support the continued Measure Z funding for the CSET and Uplift Eureka team.

- CSET conducted 4,320 self-initiated contacts and responded to 1,014 calls-for-service.
- CSET seized 6 ounces of meth, almost an ounces of heroin, and collected over 56,000 lbs of trash.
- CSET connected 57 individuals directly to substance abuse treatment facilities 131 since 2019.
- CSET placed 91 individuals in crisis on WI 5150/mental health holds. This was 30% of all Eureka Police Department mental health holds.
- CSET responded to 170 Mental Health Related calls-for-service. This was 30% of all Eureka Police Department Mental Health Related calls-for-service.
- CSET connected individuals with medical and mental health services, housing, employment, clothing, food, and other needs.
- For CSET, these are the foundational principles I feel make us effective in the community:
- Community Partners We all need each other. This is a community approach. We are just a piece of the puzzle.
- Connection We want to connect with all members of the community to reduce negative impacts and create positive, long-term outcomes.
- Accountability, Compassion & Outreach We need to help improve the lives of others while maintaining order in the community.
- Underlying Causes To truly address and prevent crime, we must address the underlying causes of crime and disorder mental illness, addiction, & trauma.
