The Humboldt County Citizens' Advisory Committee on Measure Z Expenditures is now accepting applications for funding. Measure Z, Humboldt County's Public Safety/Essential Services Measure, is a half-cent sales tax, passed by the voters of Humboldt County during the November 2014 general election.

The Advisory Committee meets on each Thursday in March to review applications and will make recommendations to the Humboldt County Board of Supervisors in April.

Applications for funding must be filed with the County Administrative Office BY 5:00 P.M. ON FEBRUARY 15, 2021. Postmarks are not acceptable for meeting this deadline.

As KWSW 980 is the LP-1 (lead station for the EAS in Humboldt County), this funding would allow for the purchase and installation of a propane tank to permit extended operation when commercial power is lost. All three of our radio stations (KEKA-FM, KINS-FM and KWSW-AM) provide coverage in ALL of Humboldt County and during times with the Emergency Alert System is activated (or there is a request from NOAA or Public Works), this would insure the ability to continue broadcasting for up to one week and provide equipment to automatically get the message(s) on air This would also permit our stations to communicate with all other local radio stations to insure total coverage in the County of the information provided by official sources.

4. Please provide a brief description of the proposal for which you are seeking funding. (1500 character limit)

In the most basic of terms, the funding would permit the purchase and installation of a series of propane tanks in daisy-chained to permit extended fuel if needed. In addition to this infra-structure, we would also use the funding to purchase and install a piece of broadcast equipment which would permit all of our stations to simulcast any programming of content deemed worthy by the EAS sources in which we have the partnership with legally (FCC) or optionally (HCSD, NOAA, etc.) ...
