Word Limit: 500	Cobb Road is our private community road just off highway 36 in Dinsmore. The Cobb Road Association comprises 12 cannabis cultivating compliant properties. As a criteria for compliance, Timberland Resource Consultants has facilitated a Lake and

Streambed Alteration Agreement with the CA Department of Fish & Wildlife for our Cobb Road Association. It has been determined that 10 culverts and one new road crossing culvert must be replaced over the duration of the Agreement. The first phase requires that 5 of the 11 culverts be replaced as soon as possible to prevent potential failures at key points along the road. Plans to improve road safety include also adding turnouts and turnarounds along the road, as well as, implementing hill stabilization measures to ensure the road will support fire and emergency equipment accessibility.

A second assessment has also determined recommendations to improve the water crossings under the road. Efforts to implement the best practice measures to protect water quality have already begun, including removing debris, clearing out culverts and improving rock armoring to inlets and outlets.

Grant funding would be used to augment the Association's current funds to allow the upgrades of the first six culverts to be completed quickly, including the five with immediate concerns for CDFW, within one year. The current estimate from the CA Department of Forestry Services's recommended heavy machine operator is \$98,357 to replace the first six culverts. The remaining repairs will be ongoing through scheduled annual contributions and yearly projects until all repairs are completed.

To date our association has collected \$45,000 in initiation fees to cover the environmental assessments, road evaluations, consulting fees, the LSA 1600 permit application fees, and the initial road repairs which have helped to stabilize the road in preparation for the culvert replacement projects. The current pledged funds for 2021 will result in total contributions of \$165,000.

Despite the size of these expected contributions, the full project costs will exceed these funds. As a result, without additional support, the total financial burden of road repairs will lie with the small farmers on Cobb Road. A micro-grant award by the Trellis program would directly impact the community of farmers on Cobb Road and allow the additional funding to help make the necessary road improvements in 2021.

Currently, our Cobb Road Association members consist of twelve permitted cannabis farms having (2) newly approved but not yet activated licenses and (9) licensed cultivation businesses, accounting for approximately \$141,000 in annual Humboldt County Cannabis Excise Tax revenue. Our close proximity to Highway 36 has the potential to allow our neighborhood businesses to be more attractive for vendors doing product pickups including distributors and manufactures. We believe the proposed road improvements will encourage third-parties to engage our Cobb Road businesses as a result of being more easily accessible, and the road improvements will ensure better safety and security for their vehicles and drivers. Job Creation or Retention:

Similar to third-party accessibility, we believe a safer and more secure road will also enable association members to more easily attract site staff who wish to commute to our farms for work. By improving safety, accessibility, and enabling the use of smaller commuter vehicles, this will allow our members to attract more qualified candidates with greater flexibility in supporting both onsite and off-site employees.

How project and/or grant request will add to the sustainability of Humboldt County's cannabis industry:

By enabling road improvements in 2021, the grant will allow our Cobb Road Association members to build strong relationships with new buyers, establishing our place in the industry prior to the 2023 introduction of large industrial grows. It is crucial that these networks are developed as soon as possible, if Humboldt is to be considered a reliable and competitive source for high-quality products in the future.

Solvency:

The micro-grant will enable this project to move forward quickly and support a collection of small farmers and their emerging brands. Without this funding, the improvements will need to be done over a longer period of time and will not provide the advantage of safety and ease of accessibility for several years.

Grant funding would be used to augment the Association's current funds to allow the upgrades of the first six culverts to be completed quickly, including the five with immediate concerns for CDFW, within one year.

The road repair will enable the area to better sustain waterflows to the capacity of a 100-year flood event. This will also ensure that all culverts have proper inflow and outflow mechanisms to prevent sediment and debris from entering the nearby Van Dusen river. The improvements will ensure stability of the roadway and reduce the potential for future erosion along the roadsides and waterways. This will provide additional stability and security for both residents and the local habitat.

Our Road Association has begun to make initial road improvements with minor re-grading, sculpting the road, installing drainage features and adding gravel. Plans to improve road safety include also adding turnouts and turn-arounds along the road, as well as, implementing hill stabilization measures to ensure the road will support fire and emergency equipment accessibility.

Efforts to implement the best practice measures to protect water quality have already begun, including removing debris, clearing out culverts, installing ditch relief culverts and french drain systems and improving rock armoring to culvert inlets and outlets. Word Limit: 500

- Plans will be supplemented to add final four (4) culvert replacements and additional culvert installation, with existing project plans.

- Road turnout engineering designs will be developed

- Continue implementing and monitoring water quality best practices

- The association will consult with a commercial fencing company to receive recommendations on a replacement of the Main gate with commercial grade locking mechanisms and proper installation

- The association will obtain up to three bids from security surveillance providers on the addition of two (2) 1080P commercial grade wireless security cameras, motion sensors, and a surveillance system for the main entrance, along with installation.

- Current association members with construction experience have volunteered to assist with project facilitation, monitoring and support as needed. All services will be quoted by multiple contractors prior to securing a contract for the work to be performed.

Preparedness

Currently, the road association has obtained an LSAA from CDFW, an initial road evaluation from DNJ engineering, and an environmental assessment from Timberland Resource Consultants. A site visit was performed with CA Departments of Fish & Wildlife and Forestry Services. Implementation of recommendations resulting from these activities have already begun.

	All members of the Road Association are still in the permitting process with the County and have not moved to staff reports and approvals because of an oversight in Planning dating back almost 50 years. We were told that when the development was subdivided and sold in the 1970s, an airspace variance should have be adopted by the Board of Supervisors. To date, we have been asked to file such a variance which we did in Oct 2017. We then were asked to register all building on the property directly with Federal Aviation Administration which we completed in 2019. To date we still do not have a clear understanding of either the status of our efforts nor next steps to pursue. But, we are hopeful that the County will advise us accordngly in order to secure final approval for all commercial cannabis sites on Cobb Road.
