#### Re: Old Goat Farms, LLC Conditional Use Permit

Attached for the Planning Commission's record and review is the following supplementary information items that have been submitted to the Department after the date of the staff report:

Hi John:

It seems we crossed paths on our calls today. I am sorry we missed each other, but it is very important that we speak.

The Tribe received the staff report today and we have concerns about the recommendation to approve a conditional use permit. The Tribe has commented on the permit application, has communicated with you, Sheriff, William Honsal, and with your staff about those concerns. The Tribe has also attempted to work with the owners, Mr. Dell and Mr. Sayas, and has had a lengthy, albeit frustrating, correspondence with Mr. Dell. Therefore it was concerning when Mr. Johnson, your senior planner, stated in an email on January 29<sup>th</sup>, 2020:

"I have combed through our records and can not find any comments from the Tribe stating any specific objections to this application."

I am concerned that the Tribe's objections have not been included in the staff analysis of the proposed project. I am concerned about the County's review process and how communication is managed.

The Yurok's THPO officers have reached out to Old Goat multiple times over the past two years through both the present THPO, Rosie Clayborn, and the previous TPHO, Vice Chair Myers, after reviewing and providing extensive corrections to a faulty cultural resources report. To date, there has been no response from either the archeologist, Mr. Arsenault, nor from Mr. Dell or Mr. Sayas. We are now concerned that the false and inaccurate report is be part of the basis of the Department's recommendation. This is for a permit within the ancestral lands of the Yurok Tribe.

As I discussed with you and Sheriff Honsal, the owners of Old Goat have deployed armed guards (Omni Security) with no communication or agreement with the Yurok and Hoopa communities, who frequent the area as cultural practitioners and for subsistence activities.

Mr. Dell and Mr. Sayas were notified at three meetings and in writing that a cultural resource permit and cultural monitors were needed for any ground disturbing activities, yet they proceeded with construction of the well and other projects without any notification, permitting or monitoring.

Finally, the Yurok Tribe Environmental Program has indicated multiple concerns with the impact of the well and water use on a Class II creek. In brief:

- The Depth to the first water of the well, (50 ft) means that it is likely to be hydrologically connected to the diverted class II creek, and should be included in the right to divert water calculation
- The Diversion can only be supported if it doesn't negatively affect downstream resources.
  - We believe that the diversion and the cultivation operation could negatively affect:
    - turbidity levels
    - cold water refugia
    - the designation of Pine Creek as a groundwater Recharge area
    - The preservation of Threatened and endangered Species
- Pine Creek is listed as the third most important tributary for salmon habitat within the Hoopa Valley
- Nutrient Inputs from the farm could lead to an increased potential for bacterial and cyanobacterial contamination
- A discharge of sediment or nutrients from this project could result in a violation of the Hoopa Tribe's Pollutant Discharge Ordinance

 Federal dollars have been spent on Erosion Control and Prevention on Pine Creek. Agricultural projects located on the headwaters of this creek could negatively affect the Federal dollars spent on restoration within this watershed.

It is critical that the County and Department understand the risk to Yurok peoples' lives, the potential risks to water resources and the willful violations of cultural resource protection that have been the practice of the owners, as well as the serious errors in the Cultural Resources Report.

I am in Redding in the morning, and am driving back to the coast after noon. The Tribe is asking that permitting for PLN-11033-CUP/ Assessor's Parcel Number: 531-011-005 be tabled until further review and consultation occurs. In the process, perhaps we can also come to some better understanding of how to address these issues in the future.

Please let me know when there is some time to discuss. The hearing is currently scheduled for February 6, 2020. Again, the Tribe is asking to have this matter tabled.

Hi Elly:

I agree we need to discuss this. I just attempted to call but your voicemail cannot accept more messages. I am in the Redway office today at (707) 383-4100. It is important that we discuss this because we have differing perspectives.

Perhaps most importantly is that County staff is hearing significant concerns expressed very late in the process. This is frustrating in light of the efforts made to obtain comments from the tribe throughout the project review process. The County received two written communications. The first was the November 13, 2018 email you sent me expressing concern about the use of armed security for this and several other sites. I did investigate this concern and determined that the use of a security agency did not violate County Code, and in light of the concern for security and the remoteness of the location, having a licensed security company on site was not a negative action. The planner on this project has made several attempts to elicit comments from the Yurok Tribe, the most recent being on December 9, 2019 when all relevant information was sent to the tribe with the notice that this would be scheduled for the January 9, 2020 Planning Commission.

The preparation of an archaeological report is a critical piece of the application process and we are sensitive to wanting this to be correct. The applicant's archaeologist has provided the County information outlining their attempts to coordinate with the Tribe with a lack of response.

We understand the concern with the well. The second communication was an email from Don who expressed concern with this site about lack of permits for the septic and well. I researched this and found that both had been permitted by the County. We understand that the Tribe wanted to consult with the people doing the work, and it is our understanding that the well driller attempted to coordinate with the Tribe, but there was no response.

The list of concerns with the project are all newly expressed concerns with an application that the county has been attempting to address with the Tribe for some time, with no response. We believe that these concerns have been addressed as part of the permit review and this is reflected in the staff report. The well is connected to groundwater, and there will be storage, and forbearance to address concerns associated with groundwater use. Water quality sampling has been conducted showing there is not runoff from the site. This information has been provided to the Tribe.

I look forward to discussing this with you to address this project and also to insure that we are effectively communicating on all applications.

Hi John:

It was nice to see you on Friday.

I wanted to make sure you were aware of the properties that we have seen people with guns and signage around. There are two properties with signs up: Old Goat APN 531-011-055-000 application #: 11033, and Sullivan LLC APN 531-011-009-000 and APN 531-011-010 application #s: 12858 and 12849.

It sounds as if code enforcement would be the appropriate responding unit, but to keep everyone on the same page, I am cc'ing Natalie Duke and Sheriff Honsal because they were a part of the initial conversation regarding the guns in ancestral lands.

I am not sure of the status of the permits, but the Tribe agrees that guns are not the appropriate response to the Humboldt County cannabis permitting process, and that the area would be much safer without hired armed security. In the event that this is the response by permitted grows, we may want to discuss how to give notice to the tribe so there can be better safety precautions all around.

Again thank you for touching base on this Friday, and please let me know how we can be of assistance. We look forward to hearing about the outcome.

During their consultation visit with us, the owners disclosed they had taken it upon themselves to have a septic system installed on their property and that they were in the process of having Watson Well install a well for water consumption needs related to their operation (in lieu of the surface water diversion that currently exists and the proposed 500,000 gallon pond). Mr. Dell explicitly told the task force the county permitting process was too cumbersome and would take too much time to wait for, so they were installing the infrastructure ahead of the necessary permits to help set up their grow site in preparation for the upcoming outdoor growing season.

As I explained to you during our side conversation, Old Goat Farms' disregard for county permitting requirements is very concerning to us on the task force. If Mr. Dell does not see the need to comply with your county processes, there is little confidence he will be forthcoming and honest when dealing with us. Our hope is that you will instruct your staff to investigate this matter further and, if unpermitted construction has been occurring, determine the appropriate course of action moving forward.

Thank you for your time and attention, and we look forward to hearing what you discover regarding this matter.

I also wanted to remind you that, prior to beginning work on your well or any other activity that disturbs soils or involves water, waste water or other building/construction projects, you must contact the cultural and environmental departments of the Tribe to secure the necessary permits and cultural monitors. For environmental permits, you should work with Louisa McCovey, copied here, and for cultural resource management permits and monitors you should contact Rosie Clayburn and Frankie Meyers, copied here. I cannot emphasis strongly enough how important these steps are. Failure to consult at this stage would prejudice your application significantly.

We look forward to receiving a copy of your archeologist's report and to hearing from you and your attorney so we can move the permit process forward.

#### January 19 2018 Letter from Yurok:

John Ford CC on letter

Letter from Yurok Tribe requesting \$2500.00, Tribal application Form, and Site Remediation Application, \$1500.00 (Signature Required to consent to Yurok Tribal Jurisdiction, Laws and Policies, request to sign and certify as requested on this Application. The Application had 4 individual terms that we could not sign on and are not supported or required by Humboldt County. We are under the regulations and laws from Humboldt County Planning.)

Submitted all other requested documents in the letter on March 28th 2018.

#### March 14 2018 Letter from Yurok:

John Ford CC on letter

Received letter from Yurok Tribe:

The Tribal Review Committee does not perceive problems with moving your application forward to the Yurok Tribal Council for final review.

#### March 28 Email from Brian to Kathleen

Forwarded documents that were requested in the January 19th Letter from Yurok.

Brian Requested Meeting with Yurok Tribe.

#### April 9th Email

Confirmed meeting at Yurok Tribal Office for May 2nd.

#### April 20th Email thread From Kathleen/Yurok

Received the Yurok Cannabis Application on April 20th 2018 with a request to pay:

\$2500.00 Application Fee

\$1240.00 Review Fee

\$260.00 Property Profile

675.00 Compliance Inspection

TOTAL \$4675.00

Was advised by Humboldt Planning that this not a requirement as I am bound by Humboldt County Planning. Articulated to Kathleen.

Also was told that documentation requested by Humboldt County as it pertains to our application will be submitted to Yurok for comments.

#### Meeting May 2nd at the Yurok Tribal Office,

Discussed a option to work on a contract that is in compliance with **Humboldt County Planning and would address Yurok Tribe Concerns.** 

Updated Fred Fletcher, our attorney on 5/14/18, to initiate dialog with Yurok Team.

During the May 2nd meeting we received from **Yurok a vendor list, on that list was Watson Well.** As we had urgency in completing the and had contracted with Watson Well we had understood that Yurok Tribe would contact Watson Well directly.

I notified Watson Well to expect a call from Yurok so they may be present during the drilling, emphasized with Yurok that it was best for Yurok to coordinate direct with Watson Well, which was agreed to as Drilling Timeline was fluid due to weather and work load. Watson Well also reached out to Yurok as noted in the letter from Don Watson, owner.

Well was installed June 1st 2018.

#### May 4th Email thread From Kathleen/Yurok follow up from May 2nd meeting.

Introduction to Elly Hoopes, Yurok attorney,

On 5/14 sent contact info to Fred Fletcher.

Fred Fletcher advised that Elly was not licensed in California.

Goal was to initiate the process of a formal agreement between us and Yurok that would be compliant with Humboldt County Planning.

Email also Informing us that before we complete any infrastructure, including the Well, we need to secure multiple permits from them, once again we were staying compliant with Humboldt County Planning and were told that additional permits were not a requirement. We were making efforts to have a formal Agreement.

#### As noted above:

We understood from the May 2nd meeting that Yurok Tribe would contact Watson Well and I also notified Watson Well to expect a call from Yurok so they may be present during the drilling. Emphasized that it was best for them to coordinate direct with Watson as Drilling Timeline was fluid due to weather and work load. (Note Letter From Watson Well) Priority was to terminate our Stream diversion and install a Well which was completed June 5th 2018.

Unfortunate Misunderstanding that I tried to clarify in emails.

#### May 8 2018 Email

Submitted Cultural Resource Report to Kathleen Fischer at Yurok.

Kathleen told me they were never contacted by Mark prior to Mark initiating the work. I advised Kathleen that Mark did send letters to Yurok pertaining to his planned work as noted in the report on pages 38 and 39. Mark had not received any response back from Yurok.

#### May 21st 2018

Mark Arsenault met with Rosie and Frankie from Yurok to discuss the CRI Report, he informed me he than followed up with phone calls and eventually a email on August 29th.

## August 29th Conference Call Brian Dell, Fred Fletcher, Elly Hoopes email follow up from Elly,

Elly mentioned that the cannabis group met but did not provide any details

Elly Reiterated/restated Kathleen May 4th email

I Mentioned that Mark, who prepared the CRI was trying to reach Frankie Meyers as additional information was being requested by Yurok. Mark was initiating efforts to coordinate.

Elly told us that even with a written agreement it would not be in conjunction with any approval, perplexing as why would Yurok want a signed agreement.

Told us the Frankie Meyers felt the best way to move forward is with a site visit on October 5th or the 9th.

#### September 11, 2018 Email from Brian to Kathleen

Long email to Kathleen updating her regarding the challenge of contacting Elly Hoopes but finally making progress.

Noting that since we still have no agreement in place and Emphasizing that we must be compliant with Humboldt County Planning first and foremost.

We would hold off on major infrastructure so we may complete a timely agreement.

Mark the Archaeologist who prepared CRI emailed Frankie Meyers on August 29th (as well as me mentioning it to Elly Hoopes on a August 29th conference call with Fred Fletcher and Elly) as it pertained to the request from the Yurok Tribe to coordinate access to additional information from Yurok and as appropriate incorporate that into the CRI Report. As of September 11th, the date of my email Mark had not received any communication from Frankie.

#### September 11, 2018 Email from Elly Hoopes and my response.

Elly Acknowledging that she is not Licensed in California as of yet.

Cannabis Task Force is meeting on some of our concerns.

Confirming my email that we will hold off on infrastructure projects.

My response offering to fly up to address any questions from the Cannabis Task Force since they were meeting.

#### September 17 2018 Email

Confirming site visit on October 5th 2018

Email to Elly showing why there may have been miscommunication as it pertained to Well with a copy of the Vendor list we received from Yurok during the May 2nd meeting.

We would like to move forward in a collaborative way, wanted to finalize a written agreement.

#### Yurok Site Visit October 5th.

Several people from Yurok Tribe showed up plus a individual who said he was consultant as he had his own cannabis cultivation farm.

Was informed that ours was the first legal Farm they have visited Also understood they would follow up with us.

#### 10/15/18 Email from Brian to Elly

My Follow up to October 5th site visit, no response

#### 10/18/18 Email from Brian to Elly

Second follow up to site visit, no response

As of February 2020 no response and moving forward to Planning Commission Hearing on February 6th.
