A RESOLUTION APPROVING AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2020 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM - CORONAVIRUS RESPONSE ROUND 2/3 (CDBG-CV 2/3) NOFA DATED DECEMBER 18, 2020

WHEREAS, On December 18, 2020 the California Department of Housing and Community Development (HCD) issued a Notice of Funding Availability (NOFA) for the Coronavirus Response Round 2/3 (CDBG-CV 2/3) funding; and

**WHEREAS,** The County of Humboldt ("County" or "Applicant") is eligible to apply for a \$1,104,688 allocation from the CDBG-CV NOFAs: and

WHEREAS, The CDBG-CV funding was made available to address the public health emergency caused by the Covid-19 virus; and

WHEREAS, On January 19, 2021, staff with the Humboldt County Planning and Building Department held a properly noticed public meeting to describe the funding available and eligible uses; and

WHEREAS, after receiving proposals for funding from members of the public and service providers, staff has prepared a proposal to utilize the CDBG-CV funding; and

**NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED** by the County Board of Supervisors of the County of Humboldt as follows:

#### **SECTION 1:**

The County Board of Supervisors has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$1,104,668 for the following CDBG-CV activities, pursuant to the December 2020 CDBG-CV 2/3 NOFA not to exceed:

Public Facility- Redwoods Rural Health Center Covid-19 Improvements	\$ 416,440
Public Facility- Humboldt Inn Elevators	\$ 613,910
Program Administration	\$ 74,318

## **SECTION 2:**

The County hereby approves the use of Program Income in an amount not to exceed \$8,000 for the CDBG-CV 2/3 activities described in Section 1.
