Consent to Assumption Agreement

This Assumption of the Granicus, Inc. Software Support Services Agreement (this "Assumption") is effective on the date this documentis signed and entered into by and between Granicus, LLC, a Minnesota Limited Liability Company, and Humboldt County CA (hereinafter referred to as "Client"), with reference to the following:

WHEREAS, the Client and Granicus, Inc. entered into a Software Support Services Agreement effective 06/05/2018

(the "Agreement"); and WHEREAS, in October 2016, GovDelivery, Inc. and Granicus, Inc. were acquired and merged;

and

WHEREAS, the operating entity moving forward for Granicus, Inc. is Granicus, LLC; and

WHEREAS, Granicus, LLC desires to accept and assume all of Granicus, Inc.'s rights, duties, benefits, and obligations under the Agreement; and

WHEREAS, the Client desires to consent to such assumption; and

WHEREAS, Granicus, LLC and Client mutually agree to amendment certain sections of the Agreement to comply with Confidential Information and Indemnification requirements for Granicus, LLC.;

NOW, THEREFORE, in consideration of the premises, the parties intend that the Agreement be amended as follows:

- Granicus, LLC accepts and assumes all rights, duties, benefits, and obligations of the Agreement, including all existing and future obligations to perform under the Agreement.
- 2. All references to Granicus, Inc., under the Agreement, shall hereinafter be referred to as Granicus, LLC.
- 3. The Client hereby consents to the foregoing assumption.
- 4. Section 10 of the Agreement labeled "Confidential Information" is hereby amended in its entirety to read as follows:

"In the performance of this Agreement, each party may receive information that is confidential under local, state or federal law. The parties hereby agree to protect all confidential information in conformance with any and all applicable local, state and federal laws, regulations, policies, procedures and standards, applicable to the confidential information received.

Continuing Compliance with Confidentiality Laws. The parties acknowledge that local, state and federal laws, regulations and standards pertaining to confidentiality, electronic data security and privacy are rapidly evolving and that amendment of this Agreement may be required to ensure compliance with such developments. Each party agrees to promptly enter into negotiations concerning an amendment to this Agreement embodying written assurances consistent with the standards and requirements of any other applicable local, state and federal laws, regulations or standards."

5. Section 14 of the Agreement, labeled "Indemnification" is hereby amended in its entirety to read as follows:

"A. Hold Harmless, Defense and Indemnification. CONTRACTOR shall hold harmless, defend and indemnify COUNTY and its agents, officers, officials, employees and volunteers from and against any and all claims, demands, losses, damages, and liabilities, including reasonable expenses and costs including, without limitation, reasonable attorney's fees and other costs of litigation arising out of, or in connection with: (i) claims by a third party of personal injury, injury to tangible property or



wrongful death arising from CONTRACTOR's negligent performance of, or failure to comply with, any of the duties and/or obligations contained herein, except to the extent such loss or damage was caused by the negligence or willful misconduct of COUNTY; or (ii) claims by a third party that the products or services provided by Granicus infringes or misappropriates the intellectual property rights of such third party. Contractor will have sole control and authority with respect to the defense or settlement of any such claim, and County will provide reasonable cooperation and assistance to Contractor in the defense and settlement thereof. Contractor is not obligated to indemnify County for any claim arising from any modification to the products or services by any party not Contractor, combination or use of the Contractor's products or services with products or services not provided by Contractor or use of Contractor's products or services in a manner not authorized by the license granted to County.

B. Effect of Insurance. Acceptance of the insurance required by this Agreement shall not relieve CONTRACTOR from liability under this provision. Subject to limitations of liability elsewhere in this Agreement, this provision shall apply to all claims for damages related to CONTRACTOR's performance hereunder regardless of whether any insurance is applicable or not. The insurance policy limits set forth herein shall not act as a limitation upon the amount of indemnification or defense to be provided hereunder."

- 6. Except as amended by this Assumption, all other terms and conditions of the Agreement shall remain in full force and effect.
- 7. In the event of any inconsistency between the provisions of this Assumption and the documents comprising the Agreement, the provisions of this Assumption shall prevail.
