Professional Services Agreement Dated [March 18, 20[21]

This Task Order issued pursuant to the terms and conditions of the Professional Services Agreement dated <u>January 13</u>, 20[21], by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and MCCULLOUGH CONSTRUCTION, INC., a California Corporation, hereinafter referred to as "CONTRACTOR," is intended to supplement the terms and conditions contained in the Professional Services Agreement:

WHEREAS, the definitions, terms and conditions set forth in the Professional Services Agreement dated <u>January 13</u>, 20[21], are incorporated herein by reference as if set forth in full and shall be fully binding upon the parties hereto; and

WHEREAS, notwithstanding anything contained herein, any and all definitions, terms and conditions contained in the Professional Services Agreement shall control to the exclusion of any different, contrary or conflicting definitions, terms or conditions set forth herein.

NOW THEREFORE, the parties hereto mutually agree as follows:

1. SCOPE OF SERVICES:

- A. <u>Abatement Services</u>. CONTRACTOR shall supply the necessary equipment, materials and personnel to demolish and remove all debris of the church structure in accordance with *California Building Code Section 3303 Demolition*. CONTRACTOR shall cap both water and sewer. CONTRACTOR must obtain proper demolition permit through the Humboldt County Planning and Building Department. CONTRACTOR shall leave all viable concrete foundation intact. CONTRACTOR shall remove and properly dispose of all solid waste located on the property.
- C. <u>Deliverables</u>. The property will be free and clear of the fire-damaged church building, solid waste, litter and debris.
- D. <u>Acceptance Criteria</u>. The property will be free and clear of the fire-damaged church building, solid waste, litter and debris. A final COUNTY inspection will be scheduled after completion of the abatement to verify the criteria have been met.

2. REPORTING REQUIREMENTS:

CONTRACTOR shall submit photographs of prior to and after completion of the abatement of the public nuisances.

Maximum Amount Payable is subject to actual debris volume (or weight) transported and the associated disposal fees incurred. McCullough Construction Inc. (MCI) estimates a total billable cost of \$67,000 in labor and equipment per the agreement rates provided based on resource loading for a 5 working day field work duration and intends to bill disposal fees at cost plus mark up. Two disposal options are being evaluated for cost and schedule efficiency and MCI will likely utilize both options. The options are the coordination and loading of commercial landfill supplied 40 cubic yard containers and/or MCI trucking (end dump type) to commercial landfill. Assuming the debris waste to be offhauled is nonregulated universal waste MCI estimates disposal volume not to exceed 2,000 cubic yards at commercial landfill disposal rate.

AMENDMENT

Maximum Amount Payable is subject to actual debris volume (or weight) transported and the associated disposal fees incurred. McCullough Construction Inc. (MCI) estimates a total billable cost of \$70,507.45 in labor and

equipment per the agreement rates provided based on resource loading for a 5 working day field work duration and intends to bill disposal fees at cost plus mark up. Two disposal options are being evaluated for cost and schedule efficiency and MCI will likely utilize both options. The options are the coordination and loading of commercial landfill supplied 40 cubic yard containers and/or MCI trucking (end dump type) to commercial landfill. Assuming the debris waste to be offhauled is nonregulated universal waste MCI estimates disposal volume not to exceed 2,000 cubic yards at commercial landfill disposal rate. The additional \$3,507.45 is due to unforeseen asbestos abatement costs.
