Regarding agenda item H2 of the Board of Supervisors meeting on 10/5/2021, I would like the public record to note that the Communication and Education Committee (CEC) of the Humboldt County Democratic Central Committee (HCDCC) opposes the proposed coal train and the use of Humboldt Bay as a port to ship coal to China or any other country. On 9/24/2021 the CEC passed the attached resolution opposing the coal train. The entire HCDCC will vote on this resolution at their 10/13/2021 meeting, and I'm confident the resolution will pass.

The CEC opposes the coal train for numerous reasons, including

- · the unstable geology of the Eel River Canyon,
- the history of train derailments in the area,
- · the possibility of contaminating the Eel and Russian Rivers and Humboldt Bay with coal dust, and
- the fact that we are in a global climate crisis caused in large part by the burning of coal.

According to <a href="https://www.sightline.org/2016/05/04/coal-trains-mean-coal-dust-period/">https://www.sightline.org/2016/05/04/coal-trains-mean-coal-dust-period/</a> as much as a ton of coal, including coal dust, can escape from a single loaded coal car. Other reports show that as much as three percent of a coal car's load, which is typically 100 tons or more, can blow (or bounce) away in transit. Contamination from coal dust will negatively impact aquafarming and other businesses reliant on Humboldt Bay.

For all the reasons listed above, the CEC encourages the Board of Supervisors to oppose the California coal train and the use of Humboldt Bay to transport coal to other countries.

For the reasons mentioned above, I respectfully request the Humboldt County Board of Supervisors adopt the RESOLUTION OF HUMBOLDT COUNTY, DECLARING THE COUNTY'S OPPOSITION TO POTENTIAL COAL EXPORT THROUGH HUMBOLDT COUNTY AND REAFFIRMING SUPPORT FOR THE GREAT REDWOOD TRAIL.

Humboldt County Board of Supervisors,

I am writing to let you know that I stand with the Redwood Chapter of the Sierra Club's position against the use of the NCRA tracks for coal transport. Their position states that the Sierra Club Redwood Chapter opposes:

- 1. Use of the North Coast Railroad Authority tracks from Schellville to Eureka to transport coal,
- 2. and, any attempt to restore the damaged NCRA tracks in the Eel River canyon.

Transporting heavy loads of coal through the Eel River Canyon is inadvisable. The NCRA tracks were abandoned due to the unstable nature of the Eel River Canyon with its eroding sandstone bluffs, substantial rainfall, and seismic activity. Historically the upkeep of the line was fraught with disastrous landslides which required continuous expensive maintenance. This contributed to the significant environmental degradation of the Eel River caused by the rail line.

Coal has no place in our delicate Humboldt Bay and Eel River canyon ecosystems or, for that matter, in the world. Coal is carcinogenic and contains multiple toxins including mercury, cadmium, and arsenic. Bulk coal can also create methane gas. I am a professional geologist who has worked in Humboldt County since 1978. I have conducted numerous studies on landslide occurrence and the effect of slides on river health. The Eel River basin, especially the Eel River Canyon, is very unstable geologically. Past landslides destroyed many parts of the old railway line. Remember the saying, attributed to Einstein, "Insanity is doing the same thing over and over and expecting different results." Rebuilding the old rail line across the same unstable slopes is an enormous waste of money and will just lead to more failures and more sediment entering our already-impaired rivers.

It is well documented that excess sediment is harmful to aquatic habitat, it impacts salmon spawning, rearing and migration, and the harmful effects last for decades. For example, in the Redwood Creek watershed, just a bit north of Humboldt Bay, a recent summary of research on just these topics includes 33 pages of references.

- 2. Pass the resolution to **oppose** coal trains running through the Eel River canyon and Old Town Eureka to Humboldt Bay for the following reasons:
  - Each car on a coal train can release between 500 and 2000 pounds of coal dust, which
    contains arsenic, lead, mercury and other toxic heavy metals. A typical 125-car coal train could
    release up to 250,000 pounds of coal dust per trip.
  - Coal dust is a public health hazard.
  - Coal dust contains <u>Particulate Matter 2.5</u>, which can contribute to asthma, prenatal complications, respiratory illness, and cardiac disease.
  - Exposure to PM 2.5 has been linked to increased mortality from Covid 19.
  - There is no safe level of exposure to PM 2.5. Communities of Black, Indigenous, and People of Color and lower-income communities bear a disportionate burden from air pollution which would be worsened by the addition of coal dust in our communities from any sites storing and handling coal.
  - Contamination from coal dust will negatively impact aquafarming and other businesses reliant on Humboldt Bay.
  - Train derailments were common through the Eel River canyon when the line was active over 20 years ago, running coal trains along the river presents a high potential for environmental disaster and could contaminate the drinking water source of towns along the line.
  - Reviving this train line will be prohibitively expensive due to the current state of the tracks and the geologic instability of the route.

Dear Clerk Cob and the Humboldt County Board of Supervisors,

I write to you as one who has worked on Eel River and Humboldt Bay issues for several decades. I believe that since the Eel River is designated a Wild & Scenic River, because it is so highly erodible while containing the largest amount of ancient coast redwoods of any watershed on Earth, and because the rail line had lots of historic problems tumbling into the Eel River below, the Great Redwood Trail is an excellent and healthy vision — while being a negatively-impacted funnel to export deadly coal to keep Asia dependent on such would be a nightmare for Humboldt County and along other parts of the rail route from Wyoming. Also, there would be negative impacts on listed species such as the Marbled Murrelet, the Northern Spotted Owl, and some anadramous fish species if some fossil fuel Big Boys try to force through the Coal Train.

I have also worked on Humboldt Bay issues for quite some time — it has enough problems with major PCB, dioxin, pentachlorophenol, herbicide and sediment from corporate clearcutting up the hill, as well as toxic threats to the Mad River from which the Humboldt Bay Municipal Water District gets its water. The air of the Humboldt Bay area has generally improved over the past several decades due to no spewing chlorine-bleached pulp mills anymore, though the so-called "biomass energy" mess of a facility near Blue Lake doesn't help. The cancer rate has always been pretty high in Humboldt County, and hauling huge amounts of coal through the area will be an ongoing hazard with guaranteed major disasters if carried out. A train chuggin' through our communities spreading toxic coal dust is the last thing either the Eel River or a recovering Eureka economy need. And even if some go through motions for awhile as if the giant coal train for export to Asia from Humboldt Bay is "on track" so to speak, there will be so many lawsuits, protests, climate disasters in the interim, construction and gravity problems, etc. that various powers-that-be will likely change their mind to stop the coal train before it gets anywhere near complete.

October 5, 2021 Public comment on Agenda item H2

I am commenting as a local physician and public health professional. Please pass a resolution supporting the Great Redwood trail and an ordinance prohibiting coal handling and transport in our county. Coal by rail and a coal export terminal would be health hazards now and for future generations.

Air quality Air quality monitors along coal by rail corridors show large spikes of fine particulates from coal dust and diesel as trains pass. These particulates cause heart, lung, and kidney disease, diabetes, cancer, premature birth, increased covid casees and covid deaths. Even short term exposure increases hospitalizations and premature deaeths. Studies in recent years show that these harms occur at levels below state and federal air quality standards. The World Health Organization just lowered its fine particulate standard to 5 micrograms per cubic meter, a level that Humboldt County already exceeds. The EPA will be revising its standard downward as well. As we've seen with wildfire smoke, fine particulates remain suspended for days and travel thousands of miles so coal transport would degrade air quality for all Humboldt Bay and Eel River Valley residents and beyond, not just those who live along the tracks.

Wildfire Powder River Basin coal is particularly prone to self combustion, and has been found smouldering in train cars arriving at their destination and at the site of a train derailment a month after the event. The unstable nature of the Eel River canyon increases the risk of track damage, which is the most common cause of derailments. Under current drought conditions the risk of wildfire is extreme.

Climate There is enough accessible coal in the Powder River Basin to emit 47 million tons of carbon dioxide. If this coal reaches power plants in Asia, its combustion will increase climate impacts like wildfires, ocean acidification, drought, and sea level rise here and around the world. Seven other West Coast ports have already rejected this plan and our harbor is the coal companies last resort. Economic analyses have shown that if coal cannot be exported from the West Coast, it will not simply be replaced by coal from other sources. If we stop it here, it will likely stay in the ground.

Lost Opportunity The Great Redwood Trail promises to bring much to our county in opportunities for outdoor recreation and as an engine of economic development. The proposed coal terminal would bring illness and death to county residents and harm our valuable natural resources. As a touring cyclist who has ridden on many bike trails across the country, I have seen how long distance trails revitalize small towns. This is the kind of economic development we need and I can't wait to ride it.

We are the eighth West Coast port that coal interests have tried to use to export coal to Asia. Each proposal has been rejected by environmental regulators and local jurisdictions. so there is solid precedent to justify coming to the same conclusion. I urge the Humboldt County Board of Supervisors, the Eureka City Council, and the Humboldt Bay Harbor District to safeguard the health of our community and pass ordinances to prohibit the transport, loading and unloading of coal and urge you to direct staff to support completion of the railbanking process.

There are many reasons to oppose the "coal train," but I can speak directly about one. In 2005 I was part of an archaeological and ethnographical survey team that examined the Island Mountain area for a client that wanted to reestablish the rail line that ran through the region. We observed massive destruction of the existing railroad right-ofway, including several landslides that had erased sections of the railbed, tracks that had sprung loose and curled into semicircles, and a general deterioration of the railline's infrastructure. In the subsequent sixteen years conditions have only gotten worse, as documented by photos taken by Friends of the Eel River

If you could have witnessed, as I did, the massive damage to the existing rail line and the extreme fragility of the physical environment, I am sure you would be convinced, as I am, that no rehabilitation of the railroad is feasible, nor is the damage to the river canyon that such attempt would inflict in any way justified.

I hope that you will do everything in your power to derail plans for the "coal train."
