## RESOLUTION FOR EXCEPTION TO THE 180-DAY WAIT PERIOD GC SECTIONS 7522.56 & 21224

WHEREAS, in compliance with Government Code section 7522.56 the Humboldt County Board of Supervisors must provide California Public Employees Retirement System (CalPERS) this certification resolution when hiring a retiree before 180 days has passed since her retirement date; and

**WHEREAS,** Pamala Johnson (Employee ID #F5416) is retiring from Humboldt County Probation Department in the position of Senior Legal Office Assistant, effective December 10, 2021; and

**WHEREAS,** section 7522.56 requires that post-retirement employment commence no earlier than 180 days after retirement date, which is June 10, 2022, without this certification resolution; and

**WHEREAS,** section 7522.56 provides that this exception to the 180 day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors, the Humboldt County Probation Department and Pamala Johnson certify that Pamala Johnson has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Humboldt County Board of Supervisors hereby appoints Pamala Johnson as an extra help retired annuitant to perform duties of the Senior Legal Office Assistant for the Humboldt County Probation Department effective December 26, 2021; and

**WHEREAS**, the entire employment agreement, contract or appointment document between Pamala Johnson and the Humboldt County Probation Department has been reviewed by this body and is attached herein; and

**WHEREAS**, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar, and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

**WHEREAS**, the maximum base monthly salary for this position is \$3903.47 and the hourly equivalent is \$22.52, and the minimum base salary for this position is \$3,042.00 and the hourly equivalent is \$17.55; and

WHEREAS, the hourly rate paid to Pamala Johnson will be \$22.52, and
