

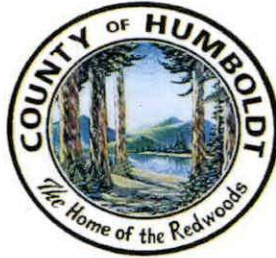


Tuesday, October 12, 2021
