DISCUSSION:

The Humboldt County Civil Grand Jury investigates and reports on the operations, accounts, and records of the officers, departments, or functions of the County of Humboldt and other local government agencies. The county thanks the grand jury for its hard work and efforts they have put forth in their 2022-23 Grand Jury reports.

To date, the Humboldt County Civil Grand Jury has submitted seven reports to the presiding judge of the Humboldt County Superior Court, of which were received, and responses for two reports were approved by your Board on July 18, 2023, and Aug. 15, 2023. Three of the remaining reports that require responses from your Board which will come before your Board today.

The reports to be discussed that require responses from your Board are as follows:

- "Custody and Corrections, and Other Humboldt County Facilities?" (Attachment 1)
- "Humboldt County Emergency Preparedness: Ready or Not?" (Attachment 4)
- "The Humboldt County Child Abuse Services Team" (Attachment 7)

It should be noted that the response for the "Custody and Corrections, and Other Humboldt County Facilities" was due to the presiding judge by Saturday, Sept. 9. Staff have contacted the Grand Jury to make them aware of this and the Grand Jury did not voice any concern with the timing of the response.

Responses to the reports "Custody and Corrections, and Other Humboldt County Facilities" and "Humboldt County Emergency Preparedness: Ready or Not?" have been provided by the Humboldt County Sheriff and are included in this agenda item for informational purposes. These responses have previously been submitted to the Presiding Judge and Grand Jury as your Board is not required to respond or approve the Sheriff's responses related to this report, per California Penal Code Section 933.05.

Additionally, responses to the report "The Humboldt County Child Abuse Services Team" have been provided by the Humboldt County District Attorney (DA) and included in this agenda item for informational purposes. These responses have previously been submitted to the Presiding Judge and Grand Jury as your Board is not required to respond or approve the DA's responses related to this report, per California Penal Code Section 933.05.
